**APC 10.1 : Confirmation of the Minutes of the Ninth Meeting held on 7.3.2002.**

APC 10.1.1: The Minutes of the last meeting held on 7.3.2001 were approved as no comments were received from the members.

**APC 10.2: Phase – IV Form – Certificate Programme on HIV and Family Education – School of Continuing Education.**

APC 10.2.1: Prof. G. Thomas gave an account of the current status of preparation for launch of the programme.

APC 10.2.2: The committee approved the Phase-IV form of the programme for launch from January 2002. The observations of the Committee are given in the following:

APC 10.2.3: "The Programme Co-ordinator Director of School will give the requisite information to the SR&ED in a few days as the CRC of the Student's Handbook for January 2002 is going to be ready. The information should also include the Study Centres to be activated".

APC 10.2.4: The publicity material should be developed to sensitize the learners.

APC 10.2.5: The programme has good potential in the N-E region, and activities related to its promotion in the N-E region can be funded from the N-E project grant.
