At the outset, the Chairman welcomed the members to the meeting. The Chairman then requested the Member-Secretary to present the items on the Agenda of the meeting.

The following items were taken up:

**ITEM NO. 1 TO CONFIRM THE MINUTES OF THE 13<sup>TH</sup> MEETING OF THE RESEARCH COUNCIL HELD ON 30<sup>TH</sup> MARCH, 2009 AND NOTE THE ACTION TAKEN THEREON.**

RC.14.1.1 It was presented that the Minutes of the Thirteenth Meeting of the Research Council held on 30<sup>th</sup> March, 2009 were circulated to the members. No comments have been received from the members. The Action Taken Report on the Minutes was also annexed to the agenda and circulated to members.

RC.14.1.2 The Research Council confirmed the Minutes of its 13<sup>th</sup> Meeting held on 30<sup>th</sup> March, 2009 (**Annexure-1 to item no. 1 as circulated with the agenda**) and noted the action taken thereon.

**ITEM NO.2 TO CONSIDER AND APPROVE THE LAUNCH OF PH.D PROGRAMME IN DAIRY TECHNOLOGY.**

RC.14.2.1 It was presented that The School of Agriculture has submitted the Phase-1 form for launch of Ph.D programme in Dairy Technology. The programme

aims to equip dairy professionals in the industry/institutes to undertake quality research in the area of dairy technology. It shall provide a platform for undertaking industrial research and testing of the technologies developed at the research institutes. The programme will have Course Work and research component as per the University norms. The proposed date of launch the programme is **July, 2010**.

The Phase-1 form has been duly approved by the School Board of School of Agriculture at its 11<sup>th</sup> meeting held on 15.4.2009. A copy of the Minutes was placed at **Annexure-1 to item no. 2 as circulated with the agenda**.

RC.14.2.2 Prof. M.K.Salooja, Programme Coordinator explained the various queries raised by the Members. The Chairman suggested that the title should be “Dairy Science and Technology” which covers broader areas.

**ITEM NO. 9 TO CONSIDER AND APPROVE THE RESEARCH PROPOSALS OF RTAs IN SCHOOL OF GENDER & DEVELOPMENT STUDIES.**

RC 14.9.1 It was presented that the Doctoral Committee of Women's Studies in its meeting held on 26.3.2009 examined the proposals of the following two RTAs:

1. Ms. Shaista Zafar, RTA: Topic for Ph.D - **“Empowerment of Women Through ICTs: Emerging Challenges: A Comparative Study of Working Women in Delhi and Bombay”**

The Doctoral Committee approved the revised proposal submitted by the candidate under the supervision of Prof. Debal S. Roy, SOSS.



The candidate agreed to incorporate the suggestions made by the committee members, while developing the thesis.

2. Ms. Monica Neeta Laloo, RTA: Topic for Ph.D - **“Local Self-Government in Socio-Political Context of North East India with special reference to the Khasi society: Women’s Perspectives”**

The committee members made several suggestions regarding the proposal. It was agreed that the candidate may be admitted to the Ph.D programme in Women’s Studies provisionally. The candidate would be required to undertake recommended Course Work (Diploma in Women’s Empowerment and Development to be followed by 32 credits of M.Phil level Course Work). She may simultaneously work on developing a fresh proposal to be resubmitted to the Doctoral Committee. The candidate was agreeable working under the direct supervision of Dr. Nilima Srivastava, Reader, SOGDS.

The Minutes of the Doctoral Committee dated 26.3.2009 have been approved by the School Board of SOGDS at its 4<sup>th</sup> meeting held on 6.4.2009 **(Annexure-1 to item no. 9 as circulated with the agenda).**

- RC 14.9.2 The Research Council considered and approved the research proposal of Ms. Shaista Zafar under the supervision of Prof. Debal S. Roy, SOSS and Ms. Monica Neeta Laloo under the supervision of Dr. Nilima Srivastava, Reader, SOGDS respectively alongwith the Course Work “Diploma in Women’s Empowerment and Development” worth 32 Credits.

**ITEM NO. 10 TO CONSIDER AND APPROVE THE INTEGRATED M.PHIL-PH.D PROGRAMME IN WOMEN’S STUDIES.**

- RC 14.10.1 It was presented that the M.Phil programme in Women’s Studies is currently under development and will comprise of four courses of 8 credits each, for a total of 32 credits of Course Work. For candidates exiting with an M.Phil degree, the Course Work is to be followed by an M.Phil dissertation, as per University norms. A face-to-face version of this programme will be on offer from July 2009 on limited basis for RTA’s and any other eligible candidates. The course structure of the M.Phil programme, including eligibility criteria, broad course outline, evaluation system, and teaching modalities are attached in summary form.

At a meeting of the sub-committee of the Joint Coordination Committee for the Ph.D programme in Women’s Studies (Academic Committee) was held on 21.4.2009. It was proposed by the committee members that, subject to the approval of the Doctoral Committee, eligible candidates may be allowed to register for an integrated M.Phil-Ph.D programme so that they could directly proceed to the Doctoral research after successfully completing the Course Work for the M.Phil programme **(Annexure-1 to item no. 10 as circulated with the agenda).**

**Based on the above, the following are being proposed:**

1. Candidates registering for the M.Phil programme in Women’s

Studies would earn the M.Phil degree after having successfully completed the required Course Work and M.Phil dissertation.

2. Those candidates who wish to pursue the integrated M.Phil-Ph.D programme would indicate the same at the commencement of the M.Phil programme. After the second semester of the M.Phil programme, the Doctoral Committee may decide whether or not the candidate may be exempted from the M.Phil dissertation, based on the academic performance of the candidate and her/his ability to pursue Doctoral research immediately after completion of Course Work. **If approved**, the candidate may continue with the integrated programme.

In case the Doctoral Committee does not approve exemption of M.Phil dissertation, the candidate would be required to complete the M.Phil dissertation, thereby earning a separate M.Phil degree (as in 1. above), before registering for the Ph.D programme.

RC 14.10.2 Dr. Savita Singh, SOGDS explained the various queries raised by the members regarding Integrated M.Phil-Ph.D programme in Women's Studies. However, Members felt that School should offer M.Phil and Ph.D programmes separately like other Schools/Centres/Institutes.

RC 14.10.3 The Research Council informed the School to submit the proposal to offer M.Phil and Ph.D Programmes separately.

RC 14.13.2 The Research Council has deliberated that there should be only one category of research supervisors i.e. Research Supervisor irrespective of Research Supervisor's institution/place. The Council felt the word 'Internal' and 'External' research supervisor is redundant and is no more relevant and hence decided drop nomenclatures internal and external words before research supervisor. Further, it was also deliberated that all eligible and approved supervisors placed in the Prospectus should be placed discipline-wise and School/Centre/Institute/Unit-wise. Hence, it was agreed to forward all approved name of supervisors to Schools/Centres/Institutes/Units to place them in the discipline concerned.

**ITEM NO. 23 TO CONSIDER AND APPROVE THE PROPOSAL FOR RENAMING THE ‘AREA COMMITTEE’ AS “RESEARCH COMMITTEE” – AN AMENDMENT TO THE ORDINANCE ON THE RESEARCH DEGREE PROGRAMMES.**

RC 14.23.1 It was presented that as per the Ordinance on Research Degree Programmes (M.Phil/Ph.D) School Board (Section 2.3 of 13) and Area Committee (Section 2.4 of 13) shall operationalize Research Degree Programmes as follows:

1. School shall operationalize the Research Degree Programmes in the disciplines assigned to the concerned Schools in accordance with the policies and guidelines laid down by the Academic Council and the Research Council (**Section 2.3**).
2. Area Committee shall administer of the Research Degree programmes falling in the (i) Developmental Studies – Inter-disciplinary (ii) System-Based Areas (iii) Any other area not covered by the Schools (**Section 2.4**).
3. School Boards shall be responsible for research topics covering the disciplines assigned to the Schools concerned. However, for topics of interdisciplinary nature, the decision shall be taken by the Area Commit

A meeting was held on 27<sup>th</sup> April, 2009 with the Directors of Schools/Heads of Divisions/Centres/Units/Institutions. It was discussed in detail about re-naming of the ‘Area Committee’ taking into consideration of new Schools of Studies namely Tourism, Foreign Languages, Gender and Development Studies, Women Studies, Vocational Education, Inter-disciplinary Studies (which have multiple disciplines within each school). Similarly, disciplines like Distance Education, Women Studies, Rural Development, Child

Development, IT, Knowledge Management, Extension Education Community Outreach etc. are independent/inter-disciplinary disciplines placed under Institutes/Centre/Others in the University. Each discipline needs specific attention (besides Doctoral Committee) in selecting Ph.D candidates instead of making it a general and placing such disciplines under a common committee namely 'Area Committee'. In fact, requirements of such disciplines are specific in nature and hence needs specific discipline expertise and attention. Whereas in Schools, each discipline has a Doctoral Committee, Standing Committee (representing School Board) and School Board.

It is in this context, detailed deliberations were held in the meeting with the Directors of Schools/ Heads of Divisions/Centres/Units/Institutes on 27.4.2009 and it was proposed to rename the 'Area Committee' as "**Research Committee**". It was also decided that each Institute/Centre/Unit who are offering research programmes should have a specific "Research Committee" beside a Doctoral Committee to look after their research programmes being offered by them.

In view of the above, it was agreed the following:-

1. Permit all Institutes/Centres/Units to have their "Research Committees" to place minutes of the Doctoral Committee pertaining to Ph.D candidates such as registration, progress of candidates etc. for consideration and approval.
2. The Clause Area Committee needs to be amended replacing with Research Committee for Institutes/Centres/Units of the University. The Research Committee and the Doctoral Committee transact Ph.D registration and related matters pertaining to Ph.D programmes.

**The Composition of the Research Committee shall be as follows:**

The Research Committee shall meet as and when necessary. Fifty percent of the membership shall form the quorum of the committee. The nominated members of the Research Committee shall hold the office for a period of 3 years from the date of appointment, or till he/she holds the respective position in the University, whichever is earlier. A member can also be re-nominated for another term with the approval of the Vice Chancellor. Research Committee shall be responsible for the research topic covering the disciplines assigned to the Institute/Centre/Unit.

RC 14.23.2 Detailed deliberations were held with regard to abolition of “Area Committee” and proposal to create “Research Committee” for Institutions/Centres/Units/Others. The purpose of Research Committee is to look into research related activities (such as synopsis, progress reports etc.) presented by M.Phil/Ph.D candidates in the Doctoral Committee

RC 14.23.3 The Research Council considered and approved the abolition of the “Area Committee”.

RC 14.23.4 The Research Council approved the creation of “Research Committee” to Institutes/Centres/Units and Others (other than the Schools of Studies). The composition of the Committee will be as follows:

RC 14.23.5 The Research Council approved the proposed amendment (i.e. “abolition of Area Committee” and Creation of Research Committee for Institutes/Centres/Units/Others) to the Ordinances and Regulations of the University of the Research Degree Programmes. The Research Council has also approved to forward the amendment to the MHRD for consent of the Visitor.

**ITEM NO. 24 TO RATIFY THE ACTION TAKEN BY THE VICE CHANCELLOR IN APPROVING THE CONDUCT OF TEE AND ENTRANCE EXAMINATION BY THE RESEARCH UNIT AND PROPOSAL FOR SEPARATE BUDGET TO THE RESEARCH UNIT FOR CONDUCT OF TEE FOR M.PHIL/PH.D COURSE WORK.**

RC 14.24.1 It was presented that a meeting was held on 27.4.2009 with the Directors of Schools/Heads of Divisions/Centres/Units/Institutions in which the Hon’ble Vice Chancellor assigned the job of conducting the TEE for Ph.D as well as M.Phil candidates to the Research Unit taking into consideration the limitations and constraints expressed by the Registrar, SED in conducting Term-End Examinations by the SED, IGNOU.

In view of the above, as directed by the Vice Chancellor, the Research Unit would be conducting Entrance Examinations as well as TEE w.e.f June, 2009. Modalities for conduct of TEE for Course Work and Entrance Examination are being worked-out by a committee approved by the Vice Chancellor. In order to conduct the above examinations, the Research Unit needs a separate budget for setting question papers, moderation of question papers and evaluation of answer scripts of Entrance and TEE and conduct of examinations.

Expenses to be incurred by disciplines/schools with regard to above will be disbursed by the Research Unit hereafter. The proposed expenditure specified above is tentative and exact requirements will be submitted in the Revised Budget of 2009-2010 and 2010-2011.

**ITEM NO. 25 TO CONSIDER AND APPROVE THE PH.D AND M.PHIL PROSPECTUS.**

RC 14.25.1 It was presented that the University has launched thirty eight Ph.D programmes in various disciplines and two M.Phil programmes i.e in Economics and Sri Aurobindo Studies. The Ph.D Prospectus, 2009 (revised) and M.Phil Prospectus have been printed and are being issued for research candidates based on the University Ordinances and Regulations on Research Degree Programmes and amendments made time to time. The

draft Ph.D and M.Phil prospectus were circulated among Schools/Cenres/Institutes for their feedback. The draft was finalized based on the feedback/suggestions given by the Schools/Centres/Institutes. The Hon'ble Vice Chancellor has approved the final Ph.D and M.Phil Prospectus. The Prospectus covers various operational details pertaining to Ph.D/M.Phil registration, eligibility criteria, supervisors (internal/external), evaluation procedures, guidelines for preparations of synopsis etc. A copy each of the Ph.D and M.Phil Prospectus were placed at **Annexure-1 to item no. 25 as circulated with the agenda.**

- RC 14.25.2 Dr. V.Venugopal Reddy, Member Secretary also informed that the University launched RTA Scheme in the year 2008 and admitted Ph.D candidates under the Scheme. A brochure with guidelines along with the application form has also been printed for inviting applications. An advertisement for this purpose is being released shortly in July, 2009. However, the RTA Scheme has been placed at the IGNOU's website.
- RC 14.25.3 The Member-Secretary circulated copies of the printed booklets of M.Phil Prospectus, Ph.D Prospectus and RTA Scheme to all Members of the Research Council.
- RC 14.25.4 The Members appreciated contents and booklets brought-out by the Research Unit for Ph.D and M.Phil Prospectus, 2009 and RTA Scheme. The Research Council considered and approved the Ph.D and M.Phil Prospectus and RTA Scheme with revised guidelines.

**ITEM NO. 26 TO CONSIDER AND APPROVE THE PROPOSAL FOR OFFERING OF PH.D PROGRAMMES THROUGH IIVET, NECRD AND ICRTA.**

- RC 14.26.1 It was presented that the University has established three national level institutes namely (i) IGNOU Institute of Vocational Education and Training (IIVET) at Shillong, (ii) North East Centre for Research and Development (NECRD) at Guwahati and IGNOU Centre for Research and Training in Agriculture through ODL (ICRTA) at Agartala.

The mandate of these three institutes are to engage themselves/facilitate research and developmental activities in the North-East Region within the purview of its objectives and goals. These institutes are headed by OSDs and Deputy Directors in the rank of Professors and Readers which are academic positions in the University. These institutes are potential to identify and engage external research guides/supervisors from North-East higher learning institutes/ universities for different disciplines.

The EDNERU taking the strength of IGNOU and its newly established North-East Centres at Shillong, Guwahati and Agartala proposed to offer Ph.D programmes in the following areas for January/July 2010 cycle:

- IIVET : Vocational Education, English Literature, Medicinal Plants, Tribal Health, Culture and Folk Lore, Distance Education, Indigenous Knowledge and Technology**
- NECRD : Physical Sciences, Political Science, Sociology, Anthropology, Tribal Studies, Regional Studies, Rural Development, Distance Education, Interdisciplinary & Multi disciplinary Studies**
- ICRTA : Agricultural Extension and Distance Education, Agricultural Economics**

RC 14.26.2 Dr. A.Varadarajan, Deputy Director, EDNERU was invited to clarify the various quarries raised by the Members with regard to faculty availability, infrastructure and other facilities that are needed for research in the above three Institutes. Having heard to Dr. Varadarjan, it was felt that the Institutes are established recently and they need some time to establish themselves to offer Ph.D programmes. It was also felt that they need to have full-time faculty and required infrastructure for offering Ph.D programmes.

RC 14.26.3 The item was deferred till these three Institutes are established themselves in terms of faculty and infrastructure that are needed for offering research programmes in the North-East region.

**ITEM NO. 27 TO CONSIDER AND APPROVE THE PROVISIONAL REGISTRATION OF MS. SURBHI SAINI, RTA (EDNERU) LIB. & INFORMATION SCIENCE, SOSS.**

RC 14.27.1 It was presented that the Doctoral Committee dated 10.6.2009 considered the research proposal entitled **“Public Library Legislation in Mizoram: An Evaluative Study”** submitted by Ms. Surbhi Saini an RTA from EDNERU affiliated with Lib. & Information Science, SOSS. The Doctoral Committee approved the topic in principle and made some modifications/suggestions to be complied by the candidate. Dr. Lalramsiami, Asstt. Librarian, Mizoram University, Aizol, Mizoram will be her external supervisor. A copy of the Minutes of the Doctoral Committee dated 10.6.2009 was placed at **Annexure-1 to item no. 27 as circulated with the agenda.**

RC 14.27.2 The Research Council considered and approved the provisional registration of Ms. Surbhi Saini, RTA (EDNERU) Library & Information Sciences under the supervision of Dr. Lalramsiami, Asstt Librarian, Mizoram University.
