The meeting recorded its appreciation of the valuable contribution made by the outgoing members to the deliberations and proceedings of the Research Council.

- (iv) *Determination of the criteria for purview of the research areas/themes/topics relevant to the School Board and/or the Area Committee.*
- (v) *Advice on research priorities and allocation of resources for research.*
- (vi) *Delegation of any of these functions assigned to the Area Committee or the School Boards.*
- (vii) *Preparation of the consolidated reports on research efforts of the University.*
- (viii) *Any other work related to research development and co-ordination.*

<b>RC 19.1</b>	<b>To confirm the Minutes of the 18<sup>th</sup> Meeting of the Research Council held on 26<sup>th</sup> July, 2011 and to note the Action Taken thereon.</b>
RC 19.1.1	The Minutes of the 18 <sup>th</sup> Meeting of the Research Council along with the Action Taken Report were placed for consideration and approval of the 19 <sup>th</sup> Meeting of the Research Council. The members brought to the notice of the meeting an inadvertent spelling error in recording the word "international" as "internal" in RC 18.14.3 as a consequence of which the import of the item had changed completely. The error was noted and rectified.
RC 19.1.2	The Minutes of the 18 <sup>th</sup> Meeting of the Research Council with the above noted correction along with its Action Taken Report were approved.
<b>RC 19.2</b>	<b>To consider and approve the Minutes of the 10<sup>th</sup> Meeting of the Research Council Standing Committee held on 23<sup>rd</sup> December, 2011 and to note the Action Taken thereon.</b>
RC 19.2.1	The Minutes of 10 <sup>th</sup> Meeting of the Research Council Standing Committee along with its Action Taken Report were placed for consideration and approval of the Research Council. It was noted that comments from two members, Prof. B.S. Saraswat and Prof. J. Dorairaj, on the minutes were received. While Prof. Dorairaj's note was of general commendation, Prof. Saraswat had raised three issues in his note about the minutes: <ul style="list-style-type: none"> <li>a. Replacement of the expression "presented" with "tabled/placed/submitted" at several places;</li> <li>b. Deleting the word "DC" from RCSC 10.4.2; and</li> <li>c. Non-availability of any proof of relaxation in the period of thesis submission for the case under reference in RCSC 10.4.2.</li> </ul>
RC 19.2.2	The members noted that Prof. Saraswat's observation about replacing the word "presented" with "tabled/placed/submitted" was not a substantive issue. His observation about RCSC 10.4.2 was accepted by the members and the word "DC" was duly dropped. Regarding the third observation, Member-Convener testified to the relaxation being approved by the erstwhile Vice Chancellor. It was also pointed out by the Member-Convener that in the preamble of the minutes the Chairman had strongly reiterated and the members had unanimously resolved to conform to the Ordinance on Research Degree Programmes.

	<b>Research Degree Programmes.</b>
RC 19.7.1	<p>As per the decision of the 10<sup>th</sup> Meeting of the Research Council Standing Committee (vide RCSC 10.41.3), a Status Paper on the amendments in Ordinance on Research Degree Programmes was prepared and circulated to Research Council Standing Committee (RCSC) members for consideration and feedback. The finalized Status Paper was also circulated and discussed in the Research Programme Coordinators' Meeting held on 12<sup>th</sup> March 2012. It was suggested by the Research Programme Coordinators that in the wake of the Status Paper, several notifications about Research Degree Programme of the University needed reversal/annulment.</p> <p>Further, in view of the issues emanating from UGC Guidelines, 2009 and in the light of MHRD letter and subsequent reminder asking the University to resolve the conflict between UGC Notification of 2009 and the existing IGNOU Ordinance, some amendments in the Ordinance on Research Degree Programmes had become necessary. The UGC had decided in its 479<sup>th</sup> Meeting held on 08.07.2011 to permit an Open University "to conduct M.Phil./Ph.D. programmes through distance education mode subject to the condition that it does so strictly as per the provisions of the UGC Regulations, 2009".</p>
RC 19.7.2	The amendments, proposed, had been finalized in conformity with the above consideration and incorporation of UGC Regulations, 2009. The amendments were placed before the Research Council for consideration and approval.
RC 19.7.3	The matter was discussed at length. It was suggested by the members that all the essential conditions of UGC Guidelines, 2009 and the decisions of its 479 <sup>th</sup> Meeting dated 08-07-2010 may be accommodated in the Ordinance and Guidelines.
RC 19.7.4	The Research Council authorized the Chairman to finalize and place the amendments, as suggested above, for the consideration and approval of all the relevant statutory authorities of the University and the Visitor as was required in terms of Statute 26.
RC 19.7.5	The Research Council also directed that suitable re-notification/s (and annulments wherever necessary) should be issued on the matters not meeting necessary statutory requirements as brought out by the Status Paper on Ordinance on Research Degree Programmes.
<b>RC 19.8</b>	<b>To consider and approve amendments in the Comprehensive Guidelines for Ph.D.</b>
RC 19.8.1	It was submitted that a compilation of all the Guidelines issued so far for Ph.D. Programmes was prepared and placed before 10 <sup>th</sup> Research Council Standing Committee (RCSC) for its consideration and approval. The Convener was requested by the members to vet and

As per the suggestions received from this meeting, certain amendments had been carried out in the Guidelines again. The amended Guidelines were placed before the Research Council for consideration and approval.</p>
