It was also noted that Prof. Mohamed Miyan, Vice Chancellor, Maulana Azad National Urdu University, Hyderabad and a member of the Research Council had completed his term. The meeting recorded its appreciation of the valuable contribution made by the out-going member to the deliberations and proceedings of the Research Council.

Appreciating various initiatives taken by the Research Unit (RU) in the past few months Prof. A.K. Singh suggested that a peer-reviewed biannual Journal be published by the University to showcase researches by the students and the Faculty. The Research Council endorsed this suggestion and requested Director, Research Unit to prepare a comprehensive proposal to be placed before the Vice Chancellor for approval.

Prof. M.K. Salooja suggested that the University should encourage the Faculty to undertake research for which adequate funding should be made available. The Director, Research Unit informed the meeting that the matter was under active consideration and specific Guidelines in this regard were being formulated.

The members appreciated the efforts of the Research Unit, as a cohesive team, in carefully preparing the agenda papers and facilitating the conduct of the meeting.

RC 20.1.2	<p>The Director, Research Unit brought to the notice of the members the following observations made by Prof. Narayan Prasad, regarding Research Programmes of IGNOU: (1) IGNOU Ordinance on Research should comply with UGC Regulations, 2009, and (2) the proposal to shift the programme structure of the MPhil/PhD Programme from Ordinance to Guidelines be vehemently opposed. He contended that the above issues had not been documented properly in the Minutes of the 19<sup>th</sup> RC (<b>Annexure RC 20.1.3</b>).</p> <p>The members were assured that the Minutes had meticulously noted the necessity of IGNOU's Research Programmes to be in conformity with UGC Regulations, 2009 and that on the opinion about "shifting", in the wake of purported "vehement opposition", no formal decision was recorded.</p>

	<p>ensuing meeting of the RC/RCSC.</p> <p>It was further resolved to present the agenda in the meeting/s in the Power Point format and circulate the agenda to the members in the soft format through E-mails. The Minutes of the meeting/s would be made available to the members as hard copy. The resolution was unanimously welcomed by the Research Council.</p>
<b>RC 20.3</b>	<b>Consideration and Approval of the Amended Guidelines for Implementation of Government of India Reservation Policy in Research Degree Programmes.</b>
RC 20.3.1	<p>A Committee was constituted by the Director, Research Unit (RU) to devise the amended Guidelines for implementation of the GOI Reservation Policy in respect of Research Degree Programmes of the University. The Committee deliberated on the matter and evolved a set of Amended Guidelines to implement the Reservation Policy. The same was placed before the RC for consideration and approval (<b>Annexure RC 20.3.1</b>).</p>
RC 20.3.2	<p>The Research Council discussed the matter at length and approved the amended Guidelines for the implementation of the GOI Reservation Policy by noting that Quality Assurance in Research Programmes would be the priority concern; and it would be the responsibility of individual Schools of Studies to ensure that the amended Guidelines for implementation of the Reservation Policy were carefully adhered to at the time of selecting candidates for MPhil/PhD Programmes so that the Research Supervisors, as far as possible, had at least one reserved category candidate under their supervision. The Schools may take stock of the matter over a three year period and review the enrolment accordingly.</p>
<b>RC 20.4</b>	<b>Consideration and Approval of Enhancement of IGNOU-Research Fellowship Award.</b>
RC 20.4.1	<p>The Finance Committee (FC) in its 76<sup>th</sup> Meeting held on 12<sup>th</sup> July 2011 and Board of Management (BOM) in its 109<sup>th</sup> Meeting held on 27<sup>th</sup> August 2011 approved the IGNOU-Research Fellowship (IGNOU-RF) Award. Under the scheme a monthly Fellowship of the value of Rs. 5000/- is awarded to Research Scholars engaged in full-time research at the University (<b>Annexure RC 20.4.1</b>).</p> <p>The selection procedure of IGNOU-RF was as rigorous as that of the UGC-JRF, though the amount of Fellowship was not compatible with UGC-JRF. The Research Council was informed that there had been a persistent request by the Research Fellows and by the Faculty to enhance the amount of IGNOU-RF such that it came close to UGC-JRF.</p> <p>Accordingly, it was proposed to enhance the IGNOU-RF Award, from the present Rs.5000/- to Rs.10000/- per month and additionally provide</p>

RC 20.4.2	The Research Council considered and approved the suggestion and directed that the matter be pursued with the Finance Division for its implementation.
<b>RC 20.5.</b>	<b>Consideration and Ratification of Fellowship Awarded to Research Scholars under IGNOU-RF Scheme.</b>
RC 20.5.1	The Meeting for selection of IGNOU-RF Awards was held on 21 <sup>st</sup> September 2012. In all 22 candidates had applied for the award. Of these, 08 MPhil candidates and 11 PhD candidates appeared before the Selection Committee. The Selection Committee awarded IGNOU-RF to the candidates as per recommendations noted in the <b>Annexure RC.20.5.1</b> . The awards were subsequently approved by the Vice Chancellor.  The matter was placed before the Research Council for ratification of the Fellowships awarded to the Research Scholars under IGNOU-RF Scheme.

RC 20.6.1	The Research Unit had made a proposal for allocation of Rs. 6,00,000/- under the Head <b>Research Books and Periodicals</b> in the Revised Estimate for the Financial Year 2012-13. This provision was meant for creating a collection of books and periodicals relating to the specific area of Research Methodology. The amount had been sanctioned by Finance and Accounts Division (F&A) ( <b>Annexure RC.20.6.1</b> ). The books and periodicals would be purchased by the University Library and shall subsequently be given on loan to RU for use by the Research Scholars. The matter was placed before the Research Council for information.
RC 20.6.2	The Research Council took note of the matter and appreciated the efforts of the Research Unit in this regard.
<b>RC 20.7</b>	<b>Consideration and Approval of Payment Norms for Thesis Evaluation and Viva-Voce Examination for MPhil/PhD Programmes of IGNOU.</b>
RC 20.7.1	The matter pertaining to the enhancement in the payment norms for evaluation of thesis and for Viva-Voce Examination for MPhil/PhD Programmes was discussed in the 17 <sup>th</sup> Meeting of the Research Council held on 28 <sup>th</sup> December 2010 (vide Agenda Item 32).
