SB 30.1 Confirmation of the 29th School Board meeting held on February 18, 2002

Economics Discipline: The topic was approved in principle. However the faculty was asked to call the candidate and have a discussion as regards adding to the title ((its implication on Banking System)


Library & Information Science Discipline: The proposal was approved.
