- SB 33.2 **To consider and approve adoption of CLD-1 course as an elective course in BDP (Economics) and CLD-2 course under AOC of BDP programme (4credits)**

The faculty may deliberate the issue again and come with a concrete suggestion the light of credit adjustments with earlier courses and be placed in the next School Board.

- SB 33.3 **To consider and approve the course "Sustainable Development: issue and challenges" in M.A. (Pol.Sc.)**

&

- SB 33.4 **To consider and approve the course "Religions thought & belief in India" MHI-07**

The courses can be offered as optional. However every Discipline offering Post-graduate programme should place before the School Board, a total package of core courses, optional courses and other optional courses from other disciplines for its approval. This would be applicable to all disciplines.

The Board approved the proposal with the suggestion that before it goes to the Academic Programme Committee other modalities should be completed like project guide, etc.
