ITEM NO. 1	To discuss the inputs received from Schools of Studies on draft document on Curriculum and Credit Framework for Undergraduate Programmes prepared by the committee members.	
1.1.1	The members discussed the comments received from School of Sciences and School of Social Sciences. They also re-looked the draft document and incorporated the suggestions wherever required.	
1.1.2	Resolution: The committee decided that the policy document should be a generic document and not specific to any School of Studies. This broad framework should be used by respective disciplines and Schools subsequently to develop programme specific structures keeping in view the basic philosophy of NEP 2020. It was decided that after finalizing the draft document along with the minutes it should be sent to the committee members with a request to go through it again to check if any modification is needed. Once received from the members, their suggestions if any (by 5 th March), should be incorporated and the final document with signatures of all members should be handed over to the Vice-Chancellor for his kind consideration.
