Sub: Assignment of work related to Bank Reconciliation of IGNOU Fee Account

Sir/Madam,

Indira Gandhi National Open University (IGNOU), a Central University in Distance Education mode established by an Act of Parliament in 1985 invites bids under two bid system (technical & financial) from the Chartered Accountants for Bank Reconciliation work of its fees accounts maintained at Headquarters at New Delhi.

The fee for various programmes of the University are collected at its 56 Regional Centres spread all over the Country and deposited in their fee account in IDBI or in Indian Bank. The fee collected at Regional Centres is subsequently transferred through ECS in the Nodal Banks i.e. IDBI and Indian Bank at New Delhi. Fee is also collected online in the centralized Fee Account in Union Bank of India at New Delhi.

The approximate yearly receipts of IGNOU are Rs.400.00 crores and the number of approximate instruments processed/deposited is 80,000 at Hqrs level. The work involved for fee reconciliation of fee accounts of IDBI and Indian Bank is for the financial year 2015-16 & 2016-17 and of Union Bank of India is from Financial Year 2014-15. The technical and financial bids in the, proformas enclosed, should be sealed by the bidder in separate covers duly superscribed and both these sealed covers are to be put in a bigger cover which should also be sealed and duly superscribed. The technical bids will be opened at the first instance and evaluated and at the second stage. Financial bids of only the technically qualified bidders will be opened for further evaluation and ranking before awarding the work.

Payment for the work done will be made on successful completion of the work and providing the necessary certificates on bank reconciliation work.
