At the outset, Prof. Nageshwar Rao, Vice Chancellor, IGNOU and Chairperson of the Research Council Standing Committee, welcomed Prof Satyakam, Prof Sumitra Kukreti and Prof Neeti Agrawal as the special invitees of the 26th Meeting of the RCSC and all the members of the RCSC. Thereafter, the Chairperson requested the Director (I/c), Research Unit and Member Secretary of the Research Council to present the Agenda items. The Member Secretary presented the Agenda items as under:

RCSC 26.1.1	The Member Secretary informed the Committee that the Minutes of the 25th Meeting of the Research Council held on 8 th May 2023 were circulated amongst all the Members of the RCSC. Since no comments were received from the Members on the Minutes, the Minutes were circulated among the Schools of Studies for initiating action on the decisions. The Member Secretary placed the Action Taken Report on the Minutes of 25th Meeting of the RCSC before the Committee and informed

RCSC 26.1.2	The RCSC confirmed the Minutes of the 25 th RCSC held on 8 th May 2023 and Action Taken thereon.
RCSC 26.2	To Consider approval of Candidates selected for admission to PhD Programme invarious Disciplines for the July 2022 session.
RCSC 26.2.1	The Member Secretary presented the agenda in detail. She apprised the Committee that the University had advertised for admission to PhD Programme in twenty seven (27) disciplines; Economics, Sociology, History, Library and Information Science, Psychology, Journalism and Mass Communication, Theatre Arts, Fine Arts, Dance, Commerce, Management, Education Distance Education, Gender and Development Studies, Interdisciplinary and Trans-disciplinary Studies, Dairy Science and Technology, Development Studies, Tourism and Hospitality Service Management Studies, Computer Science, Nursing, French, Vocational Education and Training, Hindi, Child Development, Home Science, Rural Development, Social Work. The Entrance Test was conducted on 8th January 2023 and the result was declared on 26th May, 2023. A totalof 4390 candidates appeared in the Entrance Test, out of which only 1671 (38.06%) candidates qualified. No candidate qualified in the Discipline of Dairy Science and Technology.

RCSC 26.2.2

The RCSC went through the detailed lists of selected candidates as recommended by DRCs of 26 Disciplines and their respective School Boards/ School Board Standing Committees. The RCSC further observed that there were some Disciplines where the seats had not been filled despite large number of applications which was a serious issue. The RCSC directed that information be called from such Schools/ Disciplines.

The RCSC approved the lists of selected/ waitlisted candidates and directed Research Unit to declare the result of only selected candidates on the website of the University and send offer letters to selected candidates. The RCSC further resolved that all efforts be made to ensure the admission process to be completed including the waitlisted candidates, if any, latest by 31st August 2023.

RCSC 26.3.1

To Consider seeking vacancy of seats in various Disciplines and suggest modalities to be adopted for admission to Ph D Programme July 2023.

RCSC 26.3.2

Presenting the agenda in detail, the Member Secretary informed the RCSC that as per IGNOU Ph D Guidelines, admission to Ph D Programme takes place in July session every year depending on the position of vacant seats in various Disciplines. Accordingly, the vacancy of seats was to be ascertained by various disciplines/ Schools willing to advertise Ph D Programme for July 2023 session. Further, the member secretary informed that the Student Evaluation Division had sought the detailed information about Ph D admission 2023 for the purpose of conducting Entrance test for Ph D programme.



	Accordingly, decision needed to be taken about the modalities. Since the Ph D Admission involved various activities including inviting online applications/ conduct of Entrance test/ Interview and final selection of candidates, a timeline needed to be chalked out to complete the entire process in a time-bound manner so that the delay caused in the last three sessions due to COVID disruptions could be overcome and the admission process could again be streamlined.
RCSC 26.3.3	 The RCSC deliberated on the matter and the following were resolved: The Research Unit to seek the information about the willingness of Disciplines/ Schools to advertise for admission to PhD programme for 2023 along with number of vacant seats discipline wise. An admission monitoring committee be constituted to oversee the detailed admission related activities including the timeline to be followed.
RCSC 26.4.1	To Consider approval of the recommendations of the Institutional Ethics Committee (IEC) at its 2 nd Meeting held on 17 th May 2023.
RCSC 26.4.2	The member secretary presented the agenda in detail. She briefed the RCSC that the second meeting of the Institutional Ethics Committee was held on 17.05.2023 wherein the research proposals of six research students from Nursing and Social Work disciplines were placed for ethical clearance along with the revised Standard Operating Procedure as approved by the Research Council at its 31 st Meeting held on 15 th November 2022. She further informed that the Minutes of the 2 nd Meeting of IEC (Annexure RCSC 26.4.1) were submitted to the Vice Chancellor for approval and as per the direction of the hon'ble Vice Chancellor, the minutes the minutes were placed for consideration and approval of RCSC.
RCSC 26.4.3	Deliberating on the agenda, the RCSC observed that the Institutional Ethics Committee (IEC) was constituted for Research scholars exclusively as per UGC norms. The issue of ethical clearance of research proposals in case of IGNOU employees may be dealt separately.
RCSC 26.4.4	The RCSC resolved that the minutes be placed before the Vice Chancellor for approval after necessary corrections.
RCSC 26.5	To Consider approval of the Recommendations of the Grievance Committee w.r.t the Grievance of Ms. Monal, a Ph D scholar of Education, SOE.
RCSC 26. 5.1	Presenting the agenda in detail. the Member Secretary informed the RCSC that Ms Monal, a Ph D Student of School of Education (SOE) (bearing Enrollment no.202494221), had represented regarding the issues related to her request to exempt her from coursework, grant of maternity leave, allotment of Research Supervisor and Research topic, proceeding in Ph D work and availing UGC JRF. The Member Secretary further apprised the RCSC that Ms Monal had already completed her coursework during her M Phil in the University of Delhi but SOE had assigned her Coursework as she could not produce her M Phil Degree as per the UGC Regulations 2016, which states thatcandidates already holding M.Phil Degree and admitted to the PhD. programme, or those who have already completed the course work in M.Phil and have been permitted to proceed to the Ph.D. in the integrated course, may be exempted by the Discipline from the PhD coursework. All other candidates admitted to the Ph.D. programme shall be required to complete the Ph.D. coursework



prescribed by the Discipline.

Ms Monal, was asked by the School of Education to do the coursework or produce the M Phil Degree certificate in order to be exempted from coursework but she could not submit the M Phil Degree Certificate due to the delay in M Phil / PhD schedule caused by COVID. However, as per records it was found that Ms Monal had submitted her M.Phil dissertation on 16.12.2021 to the department of Education, Delhi University. But the Viva Voce could not be conducted due to closure of activities in the University during the Covid' 19 Pandemic. Meanwhile, the Head, Department of Education, Delhi University issued a bonafide certificate dated 21.01.2022 for completion of course work during M.Phil programme in respect of Ms. Monal. But, the School of Education did not consider her request for exemption of course work. In between, Ms. Monal qualified UGC-NET JRF in March, 2022 but could not avail fellowship as the School did not allow her to join. As per procedure, the JRF would start from the date of joining the Ph D programme. The SOE placed the matter in DRC and resolved for not exempting Ms Monal from doing coursework. The School Board of SOE upheld DRC resolution.

The Grievance Committee heard the submissions made by the student and the School in person. The Minutes of the Grievance Committee at Annexure RCSC 26.5.1 was submitted to hon"ble Vice Chancellor for approval. As directed by the Vice Chancellor, the minutes were placed before RCSC.

RCSC 26.5.2

The RCSC took note of the fact that disruptions of academic activities had impacted all educational institutions during COVID and UGC had given relaxation to all M Phil/ Ph D students till 31st December 2022 to facilitate submission of thesis. The committee also went through the thesis submission certificate along with the course work completion status i.r.o Ms. Monal issued by the Head of the Department of Education, University of Delhi dtd 21.01.2022. Ms. Monal had successfully completed her Viva Voce on 7.7.2022.

After detailed deliberations, the RCSC approved the recommendations of Grievance Committee.

26.6 To Consider allocation of Research Topics/Supervisors to the PhD Students in various Disciplines.

The Member Secretary presented the agenda in detail. She informed that on successful completion of the coursework, the Doctoral Research Committees of various Disciplines had recommended research topics/ supervisors for the Research scholars in their respective disciplines.
