Item No. 48.7 To identify PGDCA as an individual programme of SOCIS and to be made available in

the list of IGNOU Academic Programmes & to consider and approve Phase - I form of

PGDCA.

**Discussion:** Chairman informed the members of School Board that the broad objective of the MCA

programme is to prepare graduate students for productive careers in software industry and academia by providing an outstanding environment for teaching and research in the core and emerging areas of the discipline. The Programme's thrust is on giving the students a thorough and sound background in theoretical and application-oriented courses relevant to the latest computer software development. The programme emphasizes the application of software technology to solve mathematical, computing, communications/networking and

commercial problems.

This Master's Degree Programme has been designed with a semester- based modular approach in mind. The first year courses are aimed at skills development in computers using various technologies, the second year is more focused on core courses providing conceptual

frame work and the third year provides the specialization and the project work.

After the successful completion of first year of MCA programme a Post Graduate Diploma in Computer Applications (PGDCA) will be awarded to the student. However, this PGDCA is not listed as a separate standalone programme in our list of IGNOU academic

programmes. Moreover, in every Convocation, a gold medal is been awarded for the best performing student of PGDCA along with other programmes. This programme as standalone has a great potential of attracting many students after the completion of any under-graduate programme.

There won't be any deviation in the eligibility criteria for intake (as was set for admission to MCA programme), no. of courses in 1<sup>st</sup> and 2<sup>nd</sup> semesters, syllabus, evaluation scheme, programme delivery, compulsion of attendance (70%) for lab courses.

As it will be in the modular approach format, if the student wishes to move ahead with the MCA 2<sup>nd</sup> year, the provision of re-registration will be provided.

**Decision:** School Board approved the Phase-1 form of PGDCA (Annexure 48.7.1). School Board also noted that there will not be any deviation in the eligibility criteria for intake (as was set for admission to MCA programme), courses in 1<sup>st</sup> and 2<sup>nd</sup> semesters, syllabus, evaluation scheme, programme delivery, compulsion of attendance (70%) for lab courses. in all aspects, the two semesters of PGDCA proposed will be replica of first two semesters of MCA.

As it will be in the modular approach format, if the student wishes to move ahead with the MCA 2<sup>nd</sup> year, the provision of lateral entry/re-registration should be provided, as per University norms.

#### Item No. 48.8 To consider and approve Phase - I form of M. Phil programme.

#### **Discussion:**

Dr. Sudhansh Sharma presented the item and chronologically updated the status of proposal of launching M. Phi. Programme. Members are of the opinion that as it is an intermediate degree, however, does not have enough scope in career growth. In fact, the process of applying for M. Phil is more often same as for Ph.D. Moreover, without completion of M.Phil (CS), most of the universities offer admission to Ph.D (CS) after the completion of MCA/M.Tech, etc. on clearing a written test. As per the latest guidelines of UGC, Ph.D is made as compulsory qualification for the entry level teaching job in any University.

#### **Decision:**

Considering the above mentioned facts, School Board disapproved the Phase-I form of M.Phil. However, members suggested to plan for M.S (Master by Research) and MS (Master by Course Work) which may be appropriate to the present context, instead of M.Phil (CS).

Also members suggested to plan for some certificate programmes/MOOCs covering the latest areas like Cryptocurrency/Block chain, Cyber Security, Big Data, Data Science, Machine Learning, IoT, Big Data Analytics, etc.

#### Item No. 48.9 To consider and approve the offer of B.Sc (Computer Science) programme in CBCS mode.

#### **Discussion:**

A Bachelor of Science degree (or B.Sc for short) is a degree awarded at universities around the world for completion of an undergraduate-level study in a science- or technology-related field. Enrolling in B.Sc degree program translates to making a significant investment in one's professional career. In addition to the enhanced career prospects that can be gained by taking a

Bachelor of Science, students also develop valuable technical, programming, personal skills and fulfill a crucial prerequisite to Master studies.

Recently UGC has formulated various regulations and guidelines from time to time to improve the higher education system and maintain minimum standards and quality across the Higher Educational Institutions (HEIs) in India. One of the recent announcements is the Choice Base Credit System. The CBCS provides an opportunity for the students to choose courses from the prescribed courses comprising core, elective/minor or skill based courses. The courses can be evaluated following the grading system, which is considered to be better than the conventional marks system. Therefore, it is necessary to introduce uniform grading system in the entire higher education in India. This will benefit the students to move across institutions within India to begin with and across countries. The uniform grading system will also enable potential employers in assessing the performance of the candidates. In order to bring uniformity in evaluation system and computation of the Cumulative Grade Point Average (CGPA) based on student's performance in examinations, the UGC has formulated the guidelines to be followed.

There are several templates for B.Sc (Computer Science) available on the UGC's website.

Taking the queue from it School of Computer and Information Sciences wish to move in this direction to offer B.Sc (Computer Science) and requests School Board to consider and approve the formal proposal.

**Decision:** 

Members appreciated the idea of offering B.Sc (with Computer Science) in CBCS mode and approved. Members made following suggestions:

- (a) Should be simple (minimum credits) complying the template's of CBCS offer of B.Sc (with Computer Science).
- (b) Should work out the details along with the BDP committee and CBCS committee of IGNOU and finalize the modalities to offer B.Sc (with Computer Science) along with other BDP courses.

### Item No. 48.10 To consider and recommend the names of TEE Answer Script Evaluators, Paper Setters and Moderators for MCA, BCA and CIT Programmes.

**Decision:** 

The 48<sup>th</sup> meeting of School Board considered and recommended the names, proposed as answer script evaluators for TEE, Paper Setters and Moderators for MCA, BCA and CIT Programmes.
