AND

The Indira Gandhi National Open University (hereinafter referred as "IGNOU"), established by an Act of Parliament in 1985 by its authorized representative as second party.

That the IGNOU in association with South Zone SDMC will ask the Canteen and Shopkeepers in IGNOU Campus to adhere to non-selling of their merchandise in single use plastics/polythene bags.

The IGNOU in association with South Zone, SDMC shall promote use of jute/cloth bags in the University Campus.

That IGNOU shall ask the Canteen/Shops in the University Campus to refrain from using single use plastic in their packaging material while carrying their trade.

The IGNOU in association with South Zone, SDMC shall endeavour to make the University Campus plastic free.
