The University vide its advertisement No. 02/2022/ACD dated 31.12.2022 had invited online applications from the eligible candidates, in the prescribed Application Proforma for appointment to 01 (one) (OBC-01) position of Professor, in the Academic Pay Level 14 of 7th Central Pay Commission Pay Matrix (Rs. 1,44,200 – Rs. 2,18,200/-), in the Discipline of Commerce in School of Management Studies at the Indira Gandhi National Open University. **A. Applicant provisionally shortlisted:**
