The University vide Advertisement No. 03/2019/ACD dated 28th September 2019 (Employment News) had invited online applications from the eligible candidates, in the prescribed Application Proforma for appointment to 01 (One) (Un-reserved) position of Professor, in the Academic Pay Level 14 of 7th Central Pay Commission Pay Matrix (Rs. 1,44,200 – Rs. 2,18,200/-), in the Discipline of Psychology in the School of Social Science at the Indira Gandhi National Open University.
