- The University vide its advertisement No. 02/2021/ACD dated 30.11.2021 had invited online applications from the eligible candidates, in the prescribed Application Proforma for appointment to 01 (one) (ST – 01) position of Associate Professor, in the Academic Pay Level 13A of 7th Central Pay Commission Pay Matrix (Rs. 1,31,400 – Rs. 2,17,100/-), in the Discipline of Distance Education in the Staff Training and Research Institute of Distance Education (STRIDE) at the Indira Gandhi National Open University.
