**Result of Screening of Applications to shortlist the Applications for the Post of Professor in  
the Discipline of Management in School of Management Studies**

**[02 Post, OBC-01, EWS-01]**

- The University vide its advertisement No. 02/2021/ACD dated 30.11.2021 had invited online applications from the eligible candidates, in the prescribed Application Proforma for appointment to 02 (two) (OBC-01, EWS-01) positions of Professor, in the Academic Pay Level 14 of 7th Central Pay Commission Pay Matrix (Rs. 1,44,200 – Rs. 2,18,200/-), in the Discipline of Management in the School of Management Studies at the Indira Gandhi National Open University. The result of Screening of applications received by the University is given below.
- The candidates are requested to go through the results. The grievance/representation should be supported by authentic documentary evidence. Any grievance/representation received after due date or without any supporting document and any new claim or additional information, which was not provided in the application submitted against advertisement No. 02/2021/ACD dated 30.11.2021 shall **Not** be entertained.

**A. Eligible Candidates:**
