- 6. The authority competent to approve NIT for the combined cost and belonging to the major discipline will consolidate NIT's for calling the tenders. He will also nominate Division, which will deal with all matters relating to the invitation of tenders. For composite tenders, besides indicating the combined estimated cost put to tender, should clearly indicate the estimated cost of each component separately. The eligibility of tenderer will correspond to the combined estimated cost put to tender.
- 7. The tenders will be issued to eligible contractors provided they produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority of having satisfactorily completed similar works of magnitude as specified in the advertisement.
- 8. Agreement shall be drawn with the successful tenderer on prescribed Form No. CPWD-8, which is available as a Govt. of India publication. Tenderer shall quote his rates as per various terms and conditions of the said form, which will form part of the agreement.
- 9. The time allowed for carrying out the work will be one year from the date of start as defined in the Schedule 'F' or from the first date of handing over the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.

Tender documents consisting of plans, specifications, the schedule of quantities of various classes of work be done and the set of terms and conditions of contract to be complied with by the contractor whose tender may be accepted and other necessary documents can be seen in the office of the Executive Engineer between hours of 11.00 a.m. & 4.00 p.m. from _____ to _____ everyday except on Saturdays/Sundays and Public Holidays. Tender documents, excluding standard for, will be issued from his office, during the hours specified above, on payment of ₹ 1000/- in cash (non-refundable) as cost of tender.

- 12. Earnest Money of ₹ 2,19,808/- in shape of Pay Order/Demand Draft of a schedule Bank issued in favour of IGNOU, New Delhi should accompany the tender.
- 13. Tenders, which should always be placed in sealed envelope, with the name of work and due date written on the envelopes, will be received by the Executive Engineer (C) upto 3.00 p.m. on ------ and will be opened by him or his authorized representative in his office on the same day at 3.30 p.m.
- 14. The contractor, whose tender is accepted, will be required to furnish Performance Guarantee of 5% (Five percent) of the tendered amount within the period specified in Schedule 'F'. This guarantee shall be in the form of cash (in case guarantee amount is less than ₹ 10,000/-) or Deposit at call receipt of any scheduled bank/Banker's cheque of any scheduled bank/Demand draft of any scheduled bank/Pay order of any scheduled bank (in case guarantee amount is less than ₹ 1,00,000/-) or Government securities of Fixed deposit receipts or Guarantee bonds of any Scheduled bank or the State Bank of India in accordance with the prescribed form.
- 15. Description of work is given at Page No. 1 may be seen. Copies of other drawings and documents pertaining to the works will be open for inspection by the tenderers at the office of the above mentioned officer. Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools and plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. - 16. The competent authority on behalf of Vice Chancellor, Indira Gandhi National Open University does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all tenders received without assignment of any reasons. All tenders in which any of the prescribed condition is not fulfilled or any conditions including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
- 17. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractor who resorts to canvassing will be liable to rejection.
- 18. The competent authority on behalf of Vice Chancellor, Indira Gandhi National Open University reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 19. The contractor shall not be permitted to tender for work in IGNOU (responsible for award and execution of contracts) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grade of Suptd. Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relative to any gazetted officer in the University. Any breach of this condition by the contractor would render him liable to be removed from the approved list of the contractors of this department.

- 20. No Engineer of gazetted rank or other gazetted officer employed in Engineering or Administrative duties in an Engineering deptt. of the University is allowed to work as a contractor for a period of one year after his retirement from service, without the previous permission of the University authorities in writing. The contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such person who had not obtained the permission of the University as aforesaid before submission of the tender or engagement in the contractor's service.
- 21. The tender for the works shall remain open for acceptance for a period of ninety (90) days from the date of opening of tenders. If any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the deptt, then the University shall, without any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the tenderer shall not be allowed to participate in the re-tendering process of the work.
- 22. This Notice Inviting Tender shall form a part of the contract document. The successful tenderer/contractor, on acceptance of his tender by the Accepting authority, shall, within 15 days from the stipulated date of start of the work, sign the contract consisting of :

 - (iii) After the work is awarded, the contractor will have to enter into separate agreements for each component with the officer concerned.
 - (iv) Executive Engineer in charge of minor component shall make interim payments in respect of minor component of work. Executive Engineer In-charge of the major component shall make the payment against final bill of the composite work
 - (v) The Executive Engineer-In-charge of the major component will call tenders for the composite work. The cost of tender document and earnest money will be fixed with respect to the combined estimated cost put to tender for the composite tender. Security deposit will be worked out separately for each component corresponding to the estimated cost of the respective component of woks. The earnest money will become part of the security deposit of the major component of work.

SPEICAL TERMS & CONDITIONS:

- Before quoting the rates, the supplier shall acquaint himself regarding the site conditions for supplying and filling of water at different locations (water tanks and pump houses) at IGNOU Campus. Nothing extra towards accessibility and approaching etc. will be entertained on this account beyond to their quoted rates. The quantities mentioned in the Schedule are tentative subject to deviation in plus or minus and the payment shall be made as per actual quantity supplied by the agency.
- 2. The disinfected Water Tanker shall be accompanied with suitable length and size of flexible pipes etc. as per site requirement for filling of water at the Pump Houses & different tanks at IGNOU Campus, Maidan Garhi, and New Delhi. Nothing extra beyond to their quoted will be entertained.
- 3. The Agency shall provide its contact Nos., such as Mobile No., as Land Line No. and e-mail ID etc. for communication purpose.
- 4. The agency has to supply water on an average 15 tanker of water in a day for 365 days in a year. However, the quantity of supply of water tankers per day may increase or decrease depending up on the actual requirement at site and accordingly the contractor has to supply the water as per site requirement every day. For this purpose, the contractor or his representative has to keep close watch the requirement in the pump houses and water tanks at IGNOU Campus. In case, any crises of water arisen due to non-supply of required water tankers by the agency, the department will arrange the water tankers at the risk and cost of the agency and the amount thus incurred will be recovered from the bills/PBG of the agency as per actual.
- 5. The payment shall be made to the agency on Monthly basis after the receipt of bills along with challans & other records towards the supply made by them. The challans shall be of different colour for DJB supply and own source supply respectively. The challans shall be in triplicate form and the agency has to be submitted 01 challan for individual trip in main gate, Security department, IGNOU and the 2nd one shall be deposited at respective user end. The detail of water supply made by the agency in everyday shall be maintained which shall be submitted to the department along with challans fortnightly. Nothing beyond to their quoted rates will be entertained on this account.
- 6. The Engineer-in-charge reserves the right of accepting/rejecting any or all tender without assigning any reason. The decision of the Engineer- in-charge shall be final.
- 7. All precautionary measures shall be adopted to carry out the work. During the contract in case of any accident/misshaping/Traffic Challans etc. occurs i/c damage to buildings/IGNOU Property then the agency shall be fully responsible for the same.
- 8. The Engineer-in-charge reserves the right for stopping the supply of water from the supplier without assigning any reason, Usually this happens unsatisfactory Performance by the Contractor. If any change in filling point by DJB other than C.W.G, point then the actual lead will be calculated on proportionate basis i.e increase or decrease during the contract period & payment will be done accordingly for trips of tanker. IGNOU will accord necessary permission/ approval from DJB for filling of water time to time. Contractor has to lift the water as permited by DJB. The charges for filling of water @80/-P/KL as per DJB has to borne by the contractor. However, if any increase/decrease of filling rate made by DJB then Department will pay the filling charges on actual basis as prevailing during the contract period.

- 10. The agency shall intimate the sources from where he will collect the water of item 1(b) with detail locations, test report from the Govt. Laboratory regarding fitness of domestic usages before its delivery. The suppliers also intimate if any change in the sources during the contract period to the department along with test report of the changed sources. The cost required for such tests shall be borne by the agency within their quoted rates & nothing extra shall be paid on this account by the department.
- 11. In case DJB does not allow to fill water then the suppliers shall arrange his own convenient resources for supply of water to IGNOU Campus.
- 12. The Contractor shall instruct the tanker drivers to ride tanker vehicles very carefully inside the Campus to avoid any accident. The vehicles to be used by the Contractor for supply of water has to weighed (Gross and Tare) randomly as per direction of Engineer-in-charge. If, Contractor change the vehicle/tankers during the contract period then he has to submit the Weight (Gross and Tare) for the changed tankers as and when used by them. The detail of tankers such as fitness certificate etc. shall also submit to the department to the contractor as and when demand. Nothing extra beyond to their quoted rates will be entertained by the department on this account.
