The Vice-Chancellor then highlighted certain issues and developments that will have a bearing on the functioning of the University:

- The University has started offering its programmes as per University Grants Commission (Open and Distance Learning) Regulations, 2017. Despite closing the admission on 31st August 2018 this year, the enrollment to various programmes of the University has been impressive with a growth of about 17 per cent over previous Academic year.
- The University is gearing up to undertake re-structuring of courses and other features including learner support centres, learner support system, conducting examination, staff structure etc. that would be required in line with UGC (ODL) Regulations. University has constituted a Committee to review the UGC (ODL)

Regulations, 2017 with regard to IGNOU. Report of the Committee is being placed before this Council.

- 3. IGNOU has started using social media for the benefits of its learners and to reach out and connect to learners who are widely spread geographically, economically and socially. Facebook and Twitter accounts have been created where information on dynamic basis is being updated. Students and other stakeholders are also getting all the information through these social media platforms.
- 4. Steps are being undertaken by the University for revision of programmes and courses in order to cope with the ongoing developments in the subject area and the industry requirement. The University is taking steps to implement the Choice Based Credit System of UGC that has been adopted by the University in 2015 itself. The Academic Council has already deliberated the variations especially credit structure mechanism between the earlier CBCS format and that given in ODL Regulations in its 68th meeting held on 6th July 2017.
- 5. With a view to ease out the pressure of study material distribution, the University has initiated the process of distributing Digitized course material through APP and emails. The University has decided to give a discount of 15 per cent in fee to those students who opt for digital Study materials.
- 6. With the increasing importance, disciplines like Yoga, Sanskrit, Vedic studies etc, the University is planning to offer new courses.
- 7. The University is also working hard to minimize students' grievances. Efforts are being made to have an integrated mechanism of handling learners' grievances.
- 8. The University is organizing a Conference on "Academic Leadership on Education for Resurgence" in collaboration with RFRF, UGC, AICTE, JNU, IGNTC, etc. at Vigyan Bhawan, New Delhi on 29th September 2018. This Conference would be inaugurated by the Hon'ble Prime Minister of the India. It would be primarily attended by the Vice Chancellors of Universities and Directors of Institutes.
- 9. The University is planning to organise its 31st Convocation soon. More than 2 lacs 08 thousand students are likely to be awarded Degrees/diplomas during this convocation.

The Chairperson then invited Dr Dev Kant Rao, Director (I/c), AC and the Member Secretary of the Council to make a brief presentation about Indira Gandhi National Open University (IGNOU). A powerpoint presentation was made by the Member Secretary. Responding to the presentation on IGNOU, the Members of the Academic Council appreciated the University for the great stride it has taken over a period of time. They also put on record the contributions made by the University in growth and development of the Open and Distance Learning System in the Country. Areas of concern were also being identified by them. They appreciated the quality of IGNOU's learning resources.

It was also suggested to strengthen placement initiatives and develop a strong alumni network. The members also mentioned the importance of proper planning and learner support in furthering the growth of ODL system and IGNOU. Reposing their faith in the leadership role provided by IGNOU in ODL system, the Council offered its full support and guidance and wisdom in future also. Insights and vision of members of the Planning Board were also shared with the council placed at **Annexure 1**.

- ITEM NO. 2 To consider the Minutes of the 46th Meeting of the Academic Councils' Standing Committee held on 24th May 2018 and to note the Action Taken thereon reg.
- AC 70.2.1 The Member Secretary informed that the 46th Meeting of the Academic Council's Standing Committee (ACSC) was held on 24th May 2018. The Minutes were circulated to the Members of ACSC. The comments have been received from Prof. Nita Mathur, SOSS and Member of ACSC with respect to Item No. 46.36. She has requested that the second para under ACSC 46.36.1 may be corrected as follows:

The Course Coordinator of the above programme informed the ACSC that the <u>sub-title</u> of Unit <u>on Rationality</u> may be read as "Regional, <u>Politics/State"</u> instead of "Regional, Ideology and Power".

Member Secretary further informed that the decisions taken by the ACSC with regard to the Item No. ACSC 46.31 and 46.55 have been placed as separate Agenda Items before the Council. Further, the decision taken vide Item No. 46.44 is being further examined with regard to approvals of Statutory Authorities viz. NCTE etc.

The Member Secretary also presented the Action Taken Report on the decisions of 46th Academic Council's Standing Committee.

- AC 70.2.2 The decisions taken by the Academic Councils' Standing Committee in its 46th meeting were discussed in detail. After detailed deliberations, the Academic Council decided as under:
 - ACSC 46.8.2: Academic Council accepted the request of Director, School of Agriculture (SOA) to continue with the title "Advance" in the course titles RDR-101, RDR-102, and RDR-103, of the Course work of Ph.D. programme in Dairy Science & Technology.
 - ACSC 46.16: The Council noted that the SOPVA, in various other Certificate level programmes, has a very low enrolment. Therefore, the School should take immediate and strategic steps to enhance the enrolment.
 - ACSC 46.19.3: Academic Council requested the Director, School of Journalism and New Media Studies (SOJNMS) to place the proposal before the next meeting of the Academic Council's Standing Committee.
 - 4. ACSC 46.26.2: Academic Council accepted the request of Director, SOGDS to acknowledge that Elective courses (i) MWG-011: Women in the Economy, and (ii) MGSE-009: Gender Issues in work Employment and Productivity, have been adopted from School of Gender and Development Studies (SOGDS) by Economics Discipline of School of Social Sciences (SOSS) in their MA Economics Programme.
 - ACSC 46.30: Academic Council did not accept the request of Director, SOITS for re-consideration of the decision of ACSC (vide ACSC 46.30.3) and directed the School to re-submit the proposal as per decision of the Academic Council's Standing Committee.
 - ACSC 46.31: The decision of Academic Council has been recorded separately vide Item No. AC. 70.7.
 - ACSC 46.36.1: Academic Council accepted the request of Prof. Nita Mathur, SOSS and decided that the <u>sub-title</u> of Unit <u>on</u> <u>Rationality</u> may be read as "Regional, <u>Politics/State</u>" instead of "Regional, Ideology and Power".
 - 8. ACSC 46.44.2: The decision of Academic Council's Standing Committee would be subject to necessary approvals from respective Statutory Authorities, wherever required.
 - ACSC 46.55.2: The decision of Academic Council's Standing Committee has been recorded separately vide Item No. AC. 70.11.



Action Taken Report: It was pointed out that a few Schools of Studies/Divisions have not submitted the Action Taken Report with respect to the decisions taken by the Academic Council's Standing Committee at its 46th meeting. The Academic Council impressed upon the respective Schools/Divisions to be more proactive in submitting the Action Taken Reports in time.

- AC 70.2.3 With above observations and emendations, the Academic Council approved the Minutes of Academic Council's Standing Committee held on 24th May 2018 as given in **Annexure 3** and noted the Action Taken thereon.
- ITEM NO. 3 To apprise the initiatives taken by the Consortium for Educational Communications (CEC), UGC for educational knowledge dissemination using media and ICT- resources reg.,
- AC 70.3.1 The Member Secretary informed the Council that the Consortium for Educational Communication, popularly known as CEC, is one of the Inter University Centres set up by the University Grants Commission with the goal of addressing the needs of Higher Education through the use of medium of Television alongwith the appropriate use of emerging Information Communication Technology (ICT).

The Chairperson invited Prof. J. B. Nadda, Director, CEC for apprising the activities undertaken by the CEC to the council.

AC 70.3.2 Prof. J. B. Nadda, Director, CEE, New Delhi made a presentation before the Council. He informed that CEC, one of the Inter University Centres set up by the University Grants Commission, is a nodal agency to coordinate, guide & facilitate such Educational production at the National level. There are 21 Media Centres across the country under the umbrella of CEC.

CEC is one of the largest repositories of digitised educational content in the country, and also the National Coordinator for Massive Open Online Courses (MOOCs) for SWAYAM platform of MHRD and also for SWAYAM Prabha DTH channels offering a bouquet of 11 educational channels in various disciplines.

The Digital Media Library at CEC is a Central Repository of all the Educational Video Programmes produced by the Educational Multimedia Research Centres set up by UGC in the Universities and Institutions of Higher Education across the country. The Media Library houses all the Masters Tapes of the educational video programmes, e-Contents and LOR's produced on various subjects and is a storehouse of a wealth of knowledge.

CEC has a collection of more than 20000 Educational Video Programmes on various formats like U-matic Cassettes, Betacam Cassettes, CD's, DVD's, Mini–DVD's and PD's/OD's (Optical Discs) which consists of the categories of collections like enrichment video programmes, syllabus oriented programmes like the University video lectures, e-Contents and LOR's which are available both in English and Hindi. The CEC also has a repository of more than a thousand e content lectures covering Programmes in various broad areas. The CEC also has a Learning Object based repository. All these resources of CEC can be accessed by visiting the website of CEC at http://cec.nic.in/Pages/Home.aspx

He then offered to provide all the contents available with CEC. He mentioned that several Universities and Institutes are using CEC resources and have entered into an agreement for the same. However, all these are conventional Institutions having limited outreach. IGNOU being a National Open University, has a countrywide outreach and would be better placed to use these resources at national level. He assured that being a Govt body, all these resources would be for free and CEC would not charge any money for that. He also clarified that IGNOU can adopt/adept these resources as per its requirements.

AC 70.3.3 After detailed deliberations, the Academic Council in-principle approved the collaboration between IGNOU and Consortium for Educational Communication for use of CEC content by IGNOU.

ITEM NO. 4 To report the renewal of MoU between Indian Institute of Banking and Finance (IIBF) and IGNOU - SOMS

- AC 70.4.1 The Member Secretary informed that the University was having an MoU between Indian Institute of Banking and Finance (IIBF) for offering programmes in the sector of Banking & Finance. The said MoU between Indian Institute of Banking and Finance (IIBF) and IGNOU has been renewed on August 28, 2018. The MOU was signed for the first time in 1998. The renewal of MoU with IIBF has been in principle approved by the School Board of School of Management Studies (SOMS) in its 40th meeting held on May 18, 2018.
- AC 70.4.2 The Academic Council noted the renewal of MoU between Indian Institute of Banking and Finance (IIBF) and IGNOU. A copy of the MoU is placed as **Annexure 4**.
- ITEM NO. 5 To report the signing of MoU between IGNOU and BSE Institute Limited (BSEIL) for Non Credit Awareness Programmes SOMS

- AC 70.5.1 The Member Secretary informed that the School of Management Studies (SOMS), IGNOU and BSE Institute Limited (BSEIL) have signed an MoU on November 21st, 2017 for development and launching of Awareness Programme (Non Credit) in Capital Markets, Mutual Funds and GST. The MoU has been noted by the School Board of School of Management Studies in its 39th Meeting held on December 15, 2017.
- AC 70.5.2 The Academic Council noted the signing of MoU between IGNOU and BSE Institute Limited (BSEIL) for development and launching of Awareness Programme in Capital Markets, Mutual Funds and GST. A copy of the MoU is placed as **Annexure 5**.

The Academic Council suggested the School to explore the possibility of offering Credit based programmes in place of Non-credit programmes. It also advised the School Board of SOMS to categorically mention its 'approval or otherwise', of such MoUs in place of merely taking 'note' of the same.

ITEM NO. 6 To apprise the Status Report of the activities undertaken by the Defence Unit – Defence Unit

- AC 70.6.1 A comprehensive status note of the activities undertaken by the Defence Unit of the University was presented by the Director, Defence Unit, Prof Manjulika Srivastava. A copy of the presentation is enclosed as **Annexure 6**.
- AC 70.6.3 The Academic Council noted the status of activities undertaken by the Defence Unit of the University as presented by the Defence Unit of the University.
- ITEM NO. 7 To consider the non 10th and non 10+2 holders of Associate Degree (Advanced Diploma) to register into the 3rd Year of B.A./B.Com./BTS along with BPP under project Gyandeep Defence Unit
- AC 70.7.1 The Member Secretary informed that the Defence Unit received a communication from the Indian Army (Gyandeep) vide their letter no. B/25420/GD/AG/PS-1 dated 30th August, 2017 wherein at point no. 2(c) they expressed their agreement for 'Starting Bachelor Preparatory Programme (BPP) for non 10+2 candidates who meet the minimum age requirement of 18 years. The Academic Council, with regard to commencing registrations under Vertical Mobility (Gyandeep) into the 3rd Year of BA, B.Com. & BTS of the students who are non 10+2 and awarded 'Statement of Marks' of the Associate Degree (Advanced Diploma) under Gyandeep, was informed that:
 - 1. The Vertical Mobility into 3rd year of BA, B.Com., BSc (Hons) in

Applied Sciences of the successful students under Akashdeep and Gyandeep commenced since July 2015 session and onwards with the approval of 64th Academic Council held on 10th July, 2015.

A meeting of the Joint Committee of IGNOU & Armed Forces, Army-IGNOU Academic Committee and Air-Force IGNOU Academic Committee was held on 8th October, 2015 wherein it was resolved to permit the successful students of Gyandeep and Akashdeep who are non 10+2 to register for the BPP and 3rd Year of BA/B.Com programme under Vertical Mobility with a concessional fee of Rs. 500/- on request of the Indian Air Force (IAF). The same was reported in the 65th meeting of the Academic Council of the University held on 21st March, 2016.

- Further, the Academic Council in its 66th meeting held on 8th September, 2016 accorded approval for offering BPP for the existing non 10+2 candidates enrolled upto January 2012 and having awarded Associate Degree (Advance Diploma) in Science under Akashdeep for their Vertical Mobility into 3rd Year of BTS & BSW programme.
- 3. At present, based on the consent of Indian Air Force and approvals of the Competent Authority/Bodies, students of Akashdeep who are non 10+2 and awarded Associate Degree (Advance Diploma) are permitted to register into the relevant 3rd Year of B.A., B.Com., BTS & BSW with BPP simultaneously.

In view of above, a proposal was placed before the 46th meeting of the Academic Council's Standing Committee (ACSC) held on 24th May 2018 to consider the following:

- a. Granting approval to permit registrations into 3rd Year of B.A./B.Com. along with Bachelor Preparatory Course (BPP) to those learners who have attained at least 18 years of age and are Non 10+2 and have been issued 'Statement of Marks' of Associate Degree (Advanced Diploma) in Arts/Commerce under Gyandeep in the current ongoing session itself.
- b. Granting a fee concession to such students and permitting them to register with a concessional fee of Rs. 500/- for the BPP, as has been provided to their counterpart Akashdeep learners.
- c. Approving commencement of registrations into 3rd Year of BTS along with Bachelor Preparatory Course (BPP) to those learners who have attained at least 18 years of age and are Non 10+2 and have been issued 'Statement of Marks' of Associate Degree (Advance Diploma) in Arts/Commerce/Science under Gyandeep in the current ongoing session itself.

The ACSC in its 46th meeting suggested that the proposal may be placed before the Academic Council for its consideration, since the earlier decision was taken by it.

- AC 70.7.2 After detailed deliberations, the Academic Council considered and approved the proposal of Defence Unit as under:
 - (i) permitting registrations into 3rd Year of B.A./B.Com./BTS along with Bachelor Preparatory Course (BPP) to those learners who have attained at least 18 years of age and are Non 10+2 and have been issued 'Statement of Marks' of Associate Degree (Advanced Diploma) in Arts/Commerce under project Gyandeep from the current ongoing session. This facility of BPP, however, would not be allowed for registrations into 3rd Year B.Sc. (Applied Sciences) programme and the eligibility criteria approved by the School Board of SOS would be adhered to.
 - (ii) Granting a fee concession to such students and permitting them to register with a concessional fee of Rs. 500/- for the BPP, as has been provided to their counterpart Akashdeep learners.
 - (iii) This scheme shall be applicable only to existing students enrolled upto January 2012 session.
- ITEM NO. 8 To ratify the action taken by the Vice Chancellor in approving the provision of Re-admission for the students enrolled into 3rd Year of BA/B.Com/B.Sc. (Hons. in Applied Sciences)/BTS/BSW through vertical mobility scheme of Gyandeep and Akashdeep after lapse of validity of registration Defence Unit
- AC 70.8.1 The Member Secretary informed that the Defence Unit has informed that they have been receiving a number of grievances in respect of provisions of re-admission after lapse of validity of registration provided under the vertical mobility/lateral entry under the Gyandeep and Akashdeep schemes. As of now, some of the learners who reregistered into the 3rd Year of BA/B.Com/B.Sc. (Hons. in Applied Sciences)/BTS/BSW through vertical mobility scheme of Gyandeep and Akashdeep in the July 2015 sessions could not complete the programmes within the stipulated time frame of 03 years and have been continuously contacting the Defence Unit for guidance in the issue.

Further, the Board of Management at its 118th meeting held on 15th June 2013, while accepting the recommendations of the Review Committee on Community College Scheme, had resolved that "As per the Army community college scheme, these students have to complete

32 credits to earn a Bachelor's Degree. The Scheme is part of the MoU with Army and Scheme of lateral entry was approved by the Academic Council. Students eligible for admission to BA 3rd year through lateral entry shall be treated as IGNOU students and admission, examination and support services will be provided through IGNOU".

Since the matter was related to Student Registration Division, the proposal was forwarded to SRD. The SRD placed the matter before the Vice-Chancellor, who approved the proposal for provision of readmission for the students enrolled into 3rd Year of BA/B.Com/B.Sc. (Hons. in Applied Sciences)/BTS/BSW through vertical mobility scheme of Gyandeep and Akashdeep after lapse of validity of registration, which has been extended for a period of one year only. Accordingly, the SRD has notified the same vide No. IG/SRD/R-I/Ver.Mob/Readmission/2018/8883 dated September 5, 2018 with the detailed rules and guidelines of Re-admission.

AC 70.8.2 The Academic Council ratified the action taken by the Vice Chancellor in approving the provision of Re-admission for the students enrolled into 3rd Year of BA/B.Com/B.Sc. (Hons. in Applied Sciences)/BTS/BSW through vertical mobility scheme of Gyandeep and Akashdeep.

ITEM NO. 9 To apprise the Digital Initiatives of the University - IUC

- AC 70.9.1 A comprehensive status note on the Digital Initiatives taken by the University was placed before the Academic Council for its appraisal. A copy of the same is placed as **Annexure 7**.
- AC 70.9.2 The Academic Council noted the status of digital initiatives taken by the University as reported by the Inter University Consortium of the University.

AC 70.10.1 The Academic Council was informed that consequent upon issuing of the University Grants Commission (Open and Distance Learning) Regulations, 2017 detailing therein the procedure of Programme Launching process and approval; and also the deliberations in the 68th and 69th meetings of Academic Council on revising the existing Phase forms and simplifying the Programme approval process, the Vice Chancellor had constituted a Committee for revising the existing Phase Forms and Programme Approval and Launching Process in light of the UGC (ODL) Regulations, 2017.

There would be a single Form, Programme Revision Form (PRF) for revision of existing programme/course / addition of new course(s) to an existing Programme.

The proposal of the School of Humanities for establishment of the Discipline of Linguistics has been approved by the School Board of Humanities at its 57th meeting held on 7th September 2018.

The University has been offering two programmes (B.A. in Philosophy and M.A. in Philosophy) under School of Inter-Disciplinary and Trans-Disciplinary Studies (SOITDS). The SOITDS has objected to the proposal to house the discipline in the SOH.

AC 70.12.1 It was informed that the University Grants Commission vide Gazette Notification dated 23rd June, 2017, had notified the University Grants Commission (Open and Distance Learning) Regulations, 2017. The matter was discussed at length in the 69th meeting of the Academic Council held on 18th April 2018, and after detailed deliberations, it was resolved that in order to safeguard the interest of the learners, but without circumventing its authority enshrined in IGNOU Act, as required by UGC (ODL) Regulations, 2017, the University would submit its application on online portal of DEB-UGC for existing programmes on offer/offered by the University as per existing norms and guidelines including Credit weightage followed by the University.

Vide Notification F.No. AD/2/NA/807, dated 2nd April 2018, a Committee had been constituted by the Vice Chancellor under the Chairpersonship of Prof Parvin Sinclair, SOS to review discrepancy of ODL regulations and IGNOU programmes towards taking up the matter with MHRD and the UGC. Subsequently, the Academic Council at its 69th meeting held on 18th April 2018, had resolved that the recommendations of the Committee may be placed before the next meeting of the Council.

The Report of the committee was placed before the Council. The

Report has been presented in two Sections:

Section 1: Issues pertaining to the autonomy of the University, which needs to be taken up with the MHRD and the UGC; and

Section 2: Discrepancies and difficulties in the implementation of the UGC (ODL) Regulations at IGNOU, which needs to be represented to the MHRD and the UGC.

AC 70.12.2 The Academic Council noted the Report of the Committee to review the University Grants Commission (Open and Distance Learning) Regulation, 2017 in the context of IGNOU and decided that the recommendations of the Committee may be forwarded to University Grants Commission / Ministry of Human Resources Development for their consideration. A copy of the Report of the Committee is placed as **Annexure 9**.

13 To consider re-scheduling of Examination of 2463 In-Service Teachers of Govt. of Tripura enrolled in D.El.Ed. Programme of IGNOU- SOE

AC 70.13.1 The Director, School of Education informed that IGNOU has enrolled 2463 in-service Teachers for D.EI.Ed. Programme after signing an MOC with SCERT, Govt. of Tripura on June 26, 2014, renewed in 2017 in pursuance of RTE Act. The Teachers admitted in July, 2017 would complete the 2 year Programme in June, 2019. In view of the amendment in the RTE Act in August, 2017 stipulating that State Governments will have to ensure that all Teachers acquire the essential qualifications by 31st March, 2019 and no further extension would be given for the same, letters were sent to all State Governments by MHRD pointing out that any Teacher who does not posses the minimum qualification (D.El.Ed) by 31st March would not be allowed to continue in service beyond 1st April 2019 and procedure for dismissal shall be initiated against such Teachers.

Following this, School of Education (SOE) received a letter from SCERT, Govt. of Tripura requesting IGNOU to hold exams for the 2463 students in the month of December, 2018 instead of June, 2019 so that the Teachers could attain the desired qualification by 31st March, 2019 and are not dismissed from service.

The matter was examined by a Committee comprising the representatives of SOE and RSD and SED, which recommended as under:

 The request of the Govt. of Tripura for holding the examination in December, 2018 instead of June, 2019, may be taken up in the light of the amended RTE Act by the Parliamentary, making it mandatory

for all State Governments to ensure that all in-service Teachers at elementary level attain their essential qualifications (D.El.Ed.) by 31st March, 2019, failing which it will be incumbent on State Governments to dismiss them from service. This amendment was introduced in August 2017 after signing of MoC and admitting students.

- National Institute of Open Schooling (NIOS), the principal agency for offering the Programme to untrained in-service teachers under the RTE Act (nearly 16 lakhs, under the aegis of MHRD) has already been offering an 18 month D.El.Ed. Programme to meet the deadline of March, 2019 for completing the Programme.
- 3. The examinations may be held in December, 2018 with the provision that they would continue the academic session till March 2019 to enable the Teachers to complete their Practical etc. In this way, the loss in the academic year would be only for 2 months i.e., April and May, 2019. June being the month in which exams are held. Consequently, the duration of the 2 year diploma would be compressed to 22 months instead of 24 months and the Programme would end in March 2019 instead of May 2019.
- 4. Intensive counseling may be conducted in the months of October-November, 2018 at the DIETs and SCERT to take care of learning which would have taken in April and May 2019, had the programme proceeded as per the Academic Callender. IGNOU shall make all arrangements to address all the academic issues related to the Programme in this period.
- 5. The students would submit their assignments before taking the examinations as is the requirement for taking the exams.

The Director, SOE informed that NIOS has obtained approval from NCTE as well as from MHRD to complete their prescribed D.El.Ed. Programme in 18 months to meet the deadline of March, 2019.

AC 70.13.2 The matter was discussed in detail. The Academic Council, keeping in view the circumstances and interest of the enrolled in-service Teachers, was of the opinion to consider the request of the State Govt of Tripura. For that, the Academic Council decided that School of Education must seek permission from NCTE/MHRD as permission was being sought by NIOS and authorized the Vice-Chancellor to take a final decision on matter.

ITEM NO. To consider and approve the Enhancement of examination fee from Rs.120/- to Rs.150/- per Course - SED

AC 70.14.1 The Member Secretary informed that presently, the University is charging Rs.120/- per Course towards examination fee for term-end

examination (both for Theory and Practical). Huge expenditure is involved in the preparations, conduct of examinations and post – examination preparations annually which comprises activities such as payment to Examination Centres for arrangement of exam invigilation, etc., evaluation of answer scripts, printing of answer books and OMR sheets, expenditure on packing and postage, expenditure on deputing Observers & Flying Squads and other incidental expenditure.

Further, in view of the UGC (ODL) Regulations 2017, the University is required to further strengthen the infrastructure for conduct of examination including installing CCTVs during examination time in all Examination Centres. The University conducts term-end examinations at about 900 examination centres for 25 days both in the morning and evening in the months of June and December every year. Installation/hiring of CCTVs on a mega scale would involve huge expenditure taking into account the number of Examination Centres and number of days/sessions.

The examination fee was last revised to Rs. 120/- per course for Indian students through Finance Committee in its 86th & 87th meeting held on 09.06.2015 and 27.11.2015, respectively and approved by the Board of Management in its 124th meeting held on 23.01.2016.

In order to meet out this additional expenditure for the purposes specified above, there was a need to enhance the term-end examination fee for both theory and practical examinations for the Indian students from the existing fee of Rs.120/- per course to Rs.150/- per course from the Term-end Examination, June 2019 onwards.

The Examination Monitoring Committee constituted for Term-end Examination, June 2018 in its meeting held on June 13, 2018 recommended for the enhancement of examination fee from Rs. 120/-to Rs.150/- per course. The Proposal has also been placed before the Finance Committee held on 7th September, 2018 and has approved the same.

AC 70.14.2 The Academic Council approved the Enhancement of examination fee from Rs.120/- to Rs.150/- per Course from the Term-end Examination, June 2019 onwards.

NO. To consider the Report of the Committee on Extension of the Validity of the Registration Period of the Students of BTME Programme - SRD/SOET

AC 70.15.1 The Member Secretary informed that School of Engineering and Technology (SOET) had submitted a proposal for extension of the

validity of registration period of the students of Bachelor of Technology in Mechanical Engineering (BTME) Programme. The minimum duration of the programme was 4 years, however, the maximum duration with the valid registration was upto 8 years. After the expiry of maximum duration, the students were given re-admission for 2 years immediately after the maximum duration, as per University's norms. Even after 2 years of grace period, there were students who still had 50% or less course(s) left unfinished (s), could not take re-admission in the programme to complete their balance courses as the programes was put on hold since 2010 as per the decision of Boad of Management. The matter was placed before the 54th meeting of the School Board of SOET. The School Board approved the proposal.

Accordingly, the proposal was submitted to ACD for placing it in ACSC, however, ACD requested the School to get the matter first examined by SRD and SED, as decided by the 42nd ACSC held on 1st August 2016 on similar matter under FDDI. Taking the reference of 42nd meeting of ACSC in the similar matter, SRD, SED and SOET had convened the meeting on 30th January, 2018 and deliberated the issue and recommended two years extension to those learners with the backlog of not exceeding 50% of courses on paying the pro-rata fee with December, 2019 as the last term examination for BTME Programme subject to certain conditions. The recommendations of the Committee of SRD, SED and SOET were placed before the then Vice Chancellor, who had approved the the same on 16.1.2018. On approval of the Minutes of the Committee, the SRD gave the facility for extension on payment of pro-rata fee for the then ensuing term-end examination in June 2018. The matter was simultaneously placed before the ACSC in its 46th meeting held on 24th May, 2018.

The ACSC deliberated on the matter at length and observed that the School has not submitted the details of number of students, cumulative, admission cycle wise and centre-wise, having 50% or less courses, timeline under which each centre carried out/stopped lab facility; as well as detailed status of Engineering programme; if there had been any Court cases, guidelines for re-admission in such cases etc., before the ACSC/ or even Vice Chancellor so as to take a holistic view of the matter. These details need to be compiled and placed before the Competent Authority for taking a decision. Therefore, the ACSC decided to refer the proposal back to the School Board of SOET. The ACSC also decided that till such time a final view is taken by the Academic Council, the fee so received by the SRD from such students may be returned and any further admissions stopped.

The SOET discussed the matter with the Vice-Chancellor in a meeting

dated 30.05.2018 attended by the Heads, Officers and faculty of VCO, SRD and SOET and it was decided that a Committee be constituted under the Chairpersonship of Prof. Parvin Sinclair, Professor, SOS. The Committee has submitted its Report containing following recommendations:

- To extend the validity period of registration up to December, 2019, of all those students admitted to the BTME programme through ODL from January 2005 session onwards who had registered for all the four years, irrespective of the number of courses completed till date.
- 2. No pro-rata fee be charged for students belonging to the 2005-2009 batches, as the onus of conducting the laboratory courses and having the assignments assessed lies with IGNOU. The 2010 batch will pay for registration up to December 2019, as applicable under the existing normal re-admission provision.
- SOET will take the responsibility for preparing and uploading the fresh assignments, evaluating the assignments, and undertake all other academic activities required for supporting the left-over students to complete the BTME programme by December, 2019.
- 4. SOET will prepare the schedule for the laboratory courses for all the five designated PSCs, and inform all the affected 3160 students accordingly. SOET will also continuously follow up, and monitor the academic activities in particular, at the five designated PSCs with the Regional Centres concerned.
- 5. Since the recommendations given above are problem and programme specific, these recommendations shall not be considered as precedence for any other academic programme offered by the University.

AC 70.15.2 The matter was discussed in detail. The Academic Council opined that Engineering programmes, like other programmes, have a minimum and maximum duration and should be run within the prescribed norms and guidelines of AICTE. The school should be more cautious in following the norms of regulatory body. Therefore, the Academic Council decided to refer it back to the School Board of SOET to re-examine the same. The Academic Council also decided that the concerned Programme Coordinator(s) would submit an Affidavit that the extension of the validity of registration period of the programme is being made strictly as per the AICTE norms to protect the interest of our engineering graduates.

ITEM NO. To consider special re-admission for (i) Diploma in Civil Engineering Programme DCLE(G), (ii) Diploma in Mechanical

Engineering (DME) students for two years, and (iii) considering students of Degree and Diploma Programmes under IGNOU-VIEP to clear their left over subjects beyond duration - SOET

AC 70.16.1 The Item was taken up with Item No. 15.

The School of Engineering and Technology (SOET) submitted a proposal for considering special re-admission for (i) Diploma in Civil Engineering Programme DCLE(G), (ii) Diploma in Mechanical Engineering (DME) students for two years, and (iii) considering students of Degree and Diploma Programmes under IGNOU-VIEP to clear their left over subjects beyond permissible maximum duration.

(i) Diploma in Civil Engineering (DCLE(G):

Diploma in Civil Engineering programme [DCLE(G)] was first launched in January 2006. The last batch was admitted in July 2010. Students of all batches have completed their maximum duration of 5 years. Students of all batched have exhausted the provision of extension of validity of registration for two more years after completion of maximum duration. But there were a few students who have not been able to complete their programme because of certain reasons. Such students have requested for providing them some more time to complete their programme. Keeping in view their request and the fact that the programme is not on offer for fresh registration, the School of Engineering and Technology (SOET) has proposed that a provision for special re-admission may be made for theses students with following features:

- (a) Validity of special re-admission period: 2 years i.e. January, 2019 to December 2020
- (b) Provision of submission of assignments and the project report at SOET
- (c) Provision of appearing in term and examination (TEEs) during two years validity period i.e. TEEs in June 2019, December 2019, June 2020 and December 2020.

SOET has also proposed that this special re-admission facility may be offered only to those students who have already registered for all three years of study and have completed successfully their 50% of the courses.

(ii) Diploma in Mechanical Engineering:

Diploma in Mechanical Engineering programme (DME) was first launched in January 2009. The last batch was admitted in July 2010. Around 3023 students were admission in DME programme and around

850 students successfully completed the DME programme. Students of all batches have completed their maximum duration of 6 years. They have also exhausted the provision of extension of validity of registration for two years after completion of maximum duration. There were a few students who have not been able to complete their programme because of certain reasons.

Such students have requested for providing them some more time to complete their programme. In view their request and the fact that this programme is not on offer (i.e; programme is on hold since 2011) for fresh registration and credit transfer also, students are unable to take fresh registration to complete their backlog courses. So, SOET has proposed that a provision for special re-admission may be made for these students with following features:

- (a) Validity of special re-admission period: 02 years i.e. July 2018 to June 2020;
- (b) Provision of submission of assignments and the project report at SOET;
- (c) Provision of appearing in term end exams (TEEs) during the two years validity period i.e. TEEs in June 2019, Dec 2019 and June 2020.

(iii) Degree and Diploma programme under IGNOU-VIEP

IGNOU-VIEP signed an MoU dated 25th March 2009 to launch Vertically Integrated Engineering Programmes (VIEP) and to develop programmes in the area of Civil, Mechanical, Electrical, Electronics, and Computer Science in order to promote professional education in the country through use of various educational methodologies. There were only two admission cycles in these programmes in year 2010 and 2011. However, as per the decision of the Board of Management IGNOU on 2012, the Admission in IGNOU-VIEP was kept on hold from 2012 onward and stopped further admission. Degree and Diploma student's registration data from 2010 and 2011 Session is as under:

The SOET has proposed that special permission may be granted to students to appear in their left over subjects, in the Term End Examination in order to clear their degree and diploma beyond completing their maximum duration. The School Board of SOET in its 56th meeting held on 14.05.2018 has approved the proposals vide item No. 56.5, 56.20, and 56.21.

NO. To consider inclusion of Rights of Persons with Disabilities in various course curricula of IGNOU, as per the direction of UGC vide letter F.No. 6-5/2017 (SCT) dated 19th January 2018 – NCDS

AC 70.17.1

The Member Secretary informed that the University received a letter from UGC letter F.No. 6-5/2017 (SCT) dated 19th January 2018 with a direction to include rights of persons with disabilities in the curriculum in the Colleges and Universities in terms of Section 39 (2) (f) of the Rights of Persons with Disabilities (RPD) Act of 2016.

Section 39 (2) (f) of Chapter VIII on Duties and Responsibilities of Appropriate Governments of the RPD Act (2016) specifies as follows:

"Ensure that the rights of persons with disabilities are included in the curriculum in universities, colleges and schools"

In view of the above, an expert committee was constituted to discuss and finalize the course content and also to discuss its implementation. As mandated in the RPD Act (2016), and as recommended by the Committee, the National Centre for Disability Studies (NCDS) has proposed that the IGNOU learners will be sensitized about the rights of persons with disabilities through an add-on course. The content outline

and evaluation methodology as decided by the expert committee was placed before the Council.

The NCDS has proposed the following with regard to launching of the course / Implementation:

- (i) Self Learning Materials will be prepared by NCDS by following IGNOU guidelines.
- (ii) The course will be implemented in two phases. While in the first phase the course content will be included in all the new/future programmes of IGNOU and programmes under revision. For ongoing programmes, NCDS will hold meetings with the Programme Coordinators of each School for incorporating the contents of the proposed course in their respective programme/courses.
- (iii) Some of the ongoing programmes in Education, Social Work, Health, Psychology, etc might have some content on disability. The additional content, if any, can also be included without much effort.
- (iv) NCDS will provide resource support to the Programme Coordinators/Schools through a pool of experts. The experts may be drawn from within and outside IGNOU.
- (v) The evaluation of the knowledge gained by the learners will be through assignments which can be prepared and evaluated by a pool of experts. Simultaneously, faculty members from each School will be oriented about the course content who will, in due course, take over the assignment preparation and evaluation work.
- (vi) After incorporating the contents in the programmes, the Programme Coordinators will share the same with NCDS for smooth implementation.
- AC 70.17.2 After deliberations, the Academic Council directed the Schools of Studies to place the same before their respective School Boards for their consideration.

The Council put on record its appreciation for the work done by the Academic Coordination Division in successful coordination of the meeting.

A vote of thanks to the Chair was endorsed by the Council at the end of the meeting.
