The Board also authorised the Vice Chancellor/Chairperson, BOM to nominate members on the Works Committee under Clause (3) of its composition and report the same to the BOM in its next meeting.
- Item No. 5 To appraise the decision of Honourable President of India in her capacity as Visitor of IGNOU in the WP No 37684/2018 filed by Prof. V. N. Rajasekharan Pillai, against IGNOU before the Hon'ble High Court of Kerala and grant of eligible/admissible benefit to Prof. V. N. Rajasekharan Pillai, the then Vice- Chancellor, IGNOU
- BM 162.5.1 It was informed that Prof. V N Rajasekharan Pillai, Former Vice-Chancellor had filed a Writ Petition No.37684/2018 before the Hon'ble High Court of Kerala and Hon'ble High Court has given judgment on above writ petition vide order dated 12/10/2022 and also a representation received from Prof. V N Rajasekharan Pillai for grant of Pensionary Benefits. The matter was placed before the Board of Management in its 154th meeting held on 27/02/2023 to apprise the status on the Orders dated 12/10/2022 of the Hon'ble High Court Kerala and the Board noted the same. Prof. V N Rajasekharan Pillai has also filed WP No. 35069/2023 Titled "Prof. V N Rajasekharan Pillai Vs Mahatma Gandhi University & ors" before the Hon'ble High Court of Kerala.

In the meanwhile, the Ministry of Education vide its letter F.No.3-9/2017-dl dated 28/02/2023 has conveyed the decision of Honourable President of India in her capacity as Visitor of IGNOU as under:

i. Prof. V N Rajasekharan Pillai, Former Vice-Chancellor, IGNOU may

- not be allowed to get terminal/pensionary benefits from IGNOU.
- ii. Has not approved the resolution passed in the 109th meeting of the Board of Management (BOM) of IGNOU held on 29/08/2011 allowing pensionary benefits to Prof. Pillai, since the said resolution should be read together with the resolution passed by the BOM in its 111th and 128th BoM meeting held on 29/12/2011 and 30/06/2017 wherein the resolution passed by the 109th BoM meeting was annulled.

In view of the above, a proposal was placed before the Board to remit the Leave Salary Contribution & Pension Contribution to the Mahatma Gandhi University during his tenure with IGNOU from 21/10/2006 to 20/10/2011 after obtaining vigilance clearance. It was intimated that the Leave Salary and Pension Contribution has been calculated from 21/10/2006 to 31/03/2010, since he had retired on 31/03/2010 from Mahatma Gandhi University which has already been concurred by Finance & Accounts Division, as per the agenda note.

- BM 162.5.2 The Board noted the decision of Honourable President of India in her capacity as Visitor of the University in the aforesaid Writ Petition and grant of eligible/admissible benefit to Prof. V.N. Rajasekharan Pillai, former Vice-Chancellor, IGNOU. The Board resolved to abide by the decision of Honourable President of India in the matter and directed to release admissible amount in respect of leave salary, pension contribution etc. to Mahatma Gandhi University.
- Item No.6 To consider extension of validity period of advertisement for various teaching and academic posts advertised vide (i) Advertisement No.2/ACD/2022 dt.31.12.2022 (Employment News dated 7-14 January 2023); (ii) Advertisement No.1/2023/ACD dt.28.02.2023 (Employment News dated 11-17 March 2023); (iii) Advertisement No.2/ACD/2023 dt.15.10.2023 (Employment News dated 21-27 October 2023) upto 31.01.2026 beyond 31.07.2025
- BM 162.6.1 Keeping in view the administrative reasons beyond the control of the University since regular Vice Chancellor is yet to be appointed in the University and the acting Vice Chancellor cannot fill up the permanent posts, as well as the fact that in several cases the list of shortlisted candidates has already been uploaded on the university website in public domain and cancelling the process may have legal issues, the Board approved the extension of validity period of the following Advertisements for further period of six months w.e.f. 31.07.2025 i.e. upto 31.01.2026 to complete the selection process for various teaching and academic posts:
 - (i) Advertisement No.2/ACD/2022 dt.31.12.2022 (Employment News dated 7-14 January 2023);
 - (ii) Advertisement No.1/2023/ACD dt.28.02.2023 (Employment News dated 11-17 March 2023); and

- (iii) Advertisement No.2/ACD/2023 dt.15.10.2023 (Employment News dated 21-27 October 2023).
- Item No. 7 To report extension of the term of Dr. Vidya Bhagat Negi as Officer on Special Duty in Student Evaluation Division
- BM 162.7.1 Keeping in view the administrative reasons beyond the control of the University since regular Vice Chancellor is yet to be appointed in the University and several posts lying vacant, including that of Registrar (Students Evaluation Division) cannot be filled up by the acting Vice Chancellor, the Board ratified the action taken by the University in extending the term of Dr. Vidya Bhagat Negi as Officer on Special Duty in Student Evaluation Division for a period of six months w.e.f. 25.05.2025.
- Item No. 8 To consider the Report of the Committee constituted pursuant to the Orders passed by the Hon'ble High Court of Delhi in W.P. (C) 6193/2025, CM APPL. 28252/2025, CM APPL. 28253/2025, CM APPL. 28254/2025 & CM APPL. 28255/2025 filed by Dr. Sanjay Kant Prasad, Additional Director, NCDS Vs. Director, Academic Coordination Division, IGNOU & ORS. vide its Judgment & Order dated 09.05.2025
- BM 162.8.1 The Board was informed that Dr. S. K. Prasad had joined Indira Gandhi National Open University (IGNOU) as the Deputy Director in National Centre for Disability Studies (NCDS) on 14.05.2008 in the pay scale of Rs. 12000-420-18300/- (5th CPC) revised to PBIII, AGP 8000. Prior to joining IGNOU, he was working in DEP-SSA project as Programme Officer which was a tenurial post for one year with extension on need-to-need basis of the project. Based on the LPC received from DEP-SSA project, the pay of Dr. S. K. Prasad was protected and fixed initially at Rs. 13,260/- as per the administrative approval of the Vice Chancellor, but without financial concurrence of the then Finance Officer, IGNOU under FR 22/FR 26. Consequent upon the implementation of the revised pay scale under 6th CPC dated 31.12.2008, the pay of Dr. S. K. Prasad, NCDS was revised by DEP-SSA, IGNOU project wherein his pay was fixed in Pay Band PB-4 Rs. 37400-67000/- with AGP 9000 w.e.f. September 2007. Accordingly, he requested for pay protection and his pay was protected in the pay band of Rs. 37400-67000 (PB-4) with AGP 9000/- w.e.f. 14th May 2008.
 - Dr. S. K. Prasad was promoted to the post of Additional Director w.e.f. 14.05.2014. Consequent upon his promotion in Academic level 14, w.e.f. 14.5.2014, his pay fixation was carried out in consultation with Finance & Accounts Division and it was observed that the initial pay protection given to Dr. S. K. Prasad, Deputy Director at the time of joining in NCDS, IGNOU in 2008 was not in accordance with FR 22 since Dr. S. K. Prasad has been working in the DEP-SSA project as Programme Officer which

was a tenurial post (contractual). Accordingly, his pay was refixed in Academic Level-14 of 7th CPC (1,44,200-2,18,200) (pre-revised-6th CPC Pay band IV of Rs. 37,400-67,000/- with AGP of Rs. 10000) leading to recoveries of more than 32 lacs vide Office Order no. 496 dated 28th November 2024 (Apppendix-1).

Dr. S. K. Prasad represented against the recovery vide his representation dated 17th December, 2024 and requested to revoke the recovery and restoration of increment in pay scale. He subsequently filed a Writ Petition (Civil) bearing No. 6193/2025 titled Dr. Sanjay Kant Prasad, Additional Director, NCDS Vs. Director, Academic Coordination Division, IGNOU & Ors. before Hon'ble High Court of Delhi dated 23rd April 2025 praying to revoke Office Order No. 496 dated 28.11.2024 by which recovery of Rs. 32,73,312/- was issued and to partially revoke Office Order No. 462 dated 01.11.2024, so far as it fixes the Petitioner's pay at Rs. 40.240/- with an AGP 10000 and a basic pay of Rs. 1,82,700/- as on 01.07.2023 which resulted in the reduction of four increments.

The Board was further informed that the Hon'ble High Court of Delhi has directed as under:

- "6. The point raised by the petitioner must be addressed by the employer. Further judgment of the Supreme Court in State of Punjab &Ors. v/s Rafig Masih (White Washer) and Ors. (2015) 4 SCC 334, decided on 18.12.2014), Thomas Daniel v/s State of Kerela &Ors. (2022 SCC OnLine SC 536, decided on 02.05.2022), and Jogeswar Sahoo v/s District Judge, Cuttack and Ors. (SLP(c) No. 5918/2024, decided on 04.04.2025) also clearly delineate the limited circumstances under which an employer may recover from an employee excess emoluments paid to him. In the present case, there does not appear, on the face of the Orders dated 01.11.2024 and 28.11.2024, to be any allegation of fraud or misrepresentation on the part of the petitioner.
- 7. Having regard to these circumstances, the writ petitioner disposed of, with the direction that the respondents will consider the petitioner's representation dated 17.12.2024, alongwith the grounds and documents annexed to the writ petition. The disposal of the representation should take place within a period of six weeks from today, after a personal hearing is granted top the petitioner.
- 8. Having regard to the fact that purported recovery relates back to 2008, it is directed that no further recovery will be made from the petitioner's emoluments until the representation is decided, and for a further period of four weeks thereafter.
- 9. The petitioner will, however, continued to be paid at the rate of which he is paid in accordance with the salary he has drawn in April 2025, subject to any increments that may accrued to him in the normal course. If the petitioner ultimately succeeds in his representation, the arrear payable to him will also be paid within four weeks thereafter...."

A copy of the Orders dated 09.05.2025 of the Hon'ble High Court of Delhi was placed before the Board (**Appendix-2**).

BM 162.8.2 The Board was further informed that in view of above, the University has stopped the recovery of Rs. 60,000/- (Sixty Thousand) per month from the salary of Dr. S. K. Prasad vide Office Order No. 202 Dated 19th May, 2025 (Appendix-3). In addition, keeping in view the timeline set up by the Hon'ble High Court of Delhi, a committee was constituted by the Vice Chancellor to consider the representation of Dr. Sanjay Kant Prasad, Petitioner and to provide hearing opportunity to him by representing his case in person to the extent as ordered by the Hon'ble High Court. The Committee after hearing the petitioner, Dr. Sanjay Kant Prasad in person and also keeping in view his representation and Orders of Hon'ble High Court of Delhi has submitted its report, a copy of which was placed before the Board (Appendix-4).

The conclusion and recommendations of the Committee are as under:

- 1. The pay fixation is done in terms of FR 22. FR 22 in the context of Central Government employee pay fixation refers to a set of rules governing the process of fixing pay on promotion, appointment, or reappointment, particularly when a government servant is moving from one post or cadre to another. "pay protection under Rule FR 22-B(1) will be available to the Government servant if he holds a lien on his previous permanent post".
- 2. Dr. Sanjay Kant Prasad did not obtain/hold any lien against his contractual post in DEP-SSA Project as it was not possible for Dr Sanjay Kant Prasad to hold a lien from DEP-SSA since DEP-SSA project was neither a permanent department of IGNOU nor a Central Govt or State Govt Institute. It was a Project under MHRD and IGNOU was only a nodal agency to help in execution of that Project. Therefore, the conditions set out in the FR-22 were not fulfilled and hence the pay protection was not proper.
- 3. Dr Sanjay Kant Prasad was appointed in IGNOU on a post carrying PB-III GP 8000/-. Therefore, it was also not proper to fix his salary in higher pay scale of PB-IV GP 9000 on joining by protecting his revised pay in DEP-SSA.
- 4. In the instant case, the pay fixation was revised consequent upon his promotion to Additional Director. The effective date of promotion of Dr Sanjay Kant Prasad was 14.05.2014. He was communicated the result of promotion vide office order no. 104 dated 10th March 2023. Consequent upon his promotion in Academic level 14, w.e.f. 14.5.2014, his pay fixation was carried out in consultation with Finance Division and vide Office Order no. 462 dated 1st November 2024, his pay fixation in Academic Level-14 of 7th CPC (1,44,200-2,18,200) (pre-revised-6th CPC Pay band IV of Rs. 37,400-67,000/- with AGP of Rs. 10000) was issued. Since the matter was complicated it took some time between

- issuing of Office Order on promotion and issue of Office Order on pay fixation. However, the revision in pay and pay fixation on promotion is correct and as per rules and he may be continued to be paid his salaries as per revised pay fixation orders alongwith annual increments due as per rules.
- 5. As regards the issue of recoveries arising from retrospective pay fixation amounting to Rs. 32,73,312/- (Office Order No. 496 Dated 28.11.2024) and Office Order No. 462 Dated 01.11.2024), the Hon'ble Supreme Court of India in the State of Punjab & Ors. v/s Rafig Masih (White Washer) (CA No. 11527 of 2014 arising out of SLP (c) No. 11684 of 2012) has laid down certain situations wherein recoveries by employers would be impermissible in law, one of which includes 'Recovery from employees when the excess payments has been made for a period in excess of five years before the order of recovery is issued'. Further, the Hon'ble Supreme Court of India in Jogeshwar Sahoo v/s District Judge, Cuttack; 2025 INSC 449 has reiterated that if an employee has not committed fraud or made any misrepresentation, and excess payments were made due to an error or misappropriation of rules by the employer. such recoveries are not legally sustainable. The above said case laws have also been referred to in the Orders dated 09.05.2025 passed by the Hon'ble of High Court of Delhi in W. P. (C) No. 6193/2025 titled Dr. Sanjay Kant Prasad Vs IGNOU & Others. In light of the above settled case laws and after deliberating upon the representation of Dr. Sanjay Kant Prasad dated 17.12.2024 and the subsequent personal hearing held with him, the Committee was of the considered view that the matter of Dr. S. K. Prasad may be dealt in accordance with the parameters set out in the said case laws. Further, there is an Officer Memorandum No. F. No. 18/03/2015-Estt. (Pay-I) dated 02.03.2016 on the subject issued by the Department of Personnel & Training (DoPT) in consultation with the Department of Expenditure and the Department of Legal Affairs, which directs Ministries/ Departments to handle cases of wrongful or excess payments to government servants in accordance with the Supreme Court's decision in the above case.

Therefore, in view of above stated legal position, the Committee has recommended that the overpayment/recoveries arising out of pay fixation prior to 10.3.2023 (when the office order for promotion of Dr SK Prasad was issued vide order No. 104, dated 10th March 2023) may not be recoverable. However, he would be continued to be paid his revised pay w.e.f. 10.3.2023 as notified vide Office Order No. 496 dated 28th November, 2024.

BM 162.8.3 The matter was discussed in details. After detailed deliberations, the Board accepted the recommendations of the Committee and decided to dispose off the representation of Dr. S.K. Prasad as sought by Hon'ble High Court of Delhi, as under:

- 1. The overpayment/recoveries arising out of pay fixation prior to 10.3.2023 (when the office order for promotion of Dr S.K. Prasad was issued vide order No. 104, dated 10th March 2023) may not be recovered. However, he would be continued to be paid his revised pay w.e.f. 10.3.2023 as notified vide Office Order No.496 dated 28th November, 2024.
- Item No. 9 To consider the extension of panel drawn by the Departmental Promotion Committee in respect of officials for promotion to the Group-A positions
- BM 162.9.1 The Board approved the extension of panel drawn by the Departmental Promotion Committee in respect of officials for promotion to Group-A positions for a further period of six months w.e.f. 27.6.2025 or till the conduct of a fresh DPC meeting, whichever is earlier.

The Board confirmed the above items and directed to issue the relevant extracts to the concerned Units for taking necessary action.

The meeting ended with a vote of thanks to the Chair.
