	The members expressed the opinion that it is a very useful programme. Considered and approved.

	The Director explained that due to certain circumstances, the then coordinator shifted these two courses for which statutory approvals are required. There has been no change in title or content of either of these courses.

63.6 To consider and approve an exit option with a PG Diploma in the existing MA English Programme. (Annexure 6) The Director explained that flexibility and ease of learning being the hallmark of IGNOU, this change would help those who enroll for the MA programme in English but for some reasons, are unable to complete it. If they have done 40 credits worth of study in the meanwhile - 5 courses of eight credits each (with 2 compulsory courses and a number of electives to choose from - they need not leave empty handed as they would be awarded a PG Diploma. The proposal also envisaged a modular approach by placing certain courses in modules both for the MA and the PG diploma. Students need to do 2 compulsory courses and 6 electives of 8 credits each, totaling up to 64 credits in all, for an MA degree. Students who wish to specialize in a particular genre/area would benefit from this approach. This, and the exit option is in accordance with the NEP as well. After discussion and clarification of details, the members welcomed the proposal and expressed the opinion that this was a step in the right direction and would indeed offer greater flexibility to students. It was also brought to the notice of the members that with the existing modules, it would be possible to offer 4 PG Diplomas (in British Literature, New Literatures, Writings from the Margins, Writings from India) to students who wish to enroll for a PG Diploma only. More modules will be added for both programmes as and when courses under preparation are ready. None of the proposed changes would entail reworking of syllabi as it would utilize existing materials to the best advantage. Considered and approved. 63.7 To consider and approve opening up admissions for PGDBP in both the cycles – January and July since it is a low enrolment programme. (Annexure 7) PGDBP is a low enrollment programme and certain steps have been taken by the School recently in this regard. One of them was to offer students an alternative to the mandatory internship which was approved by the previous AC. The Programme was on offer to students only in the July cycle and it is proposed to put it on offer in both January and July cycles to enhance enrollment. Considered and approved. 63.8 To consider and approve the change of text from one course to another of CBCS English Honours, from BEGE-141 (Understanding Prose) to BEGC-111 (Women's Writing) and another story to be added in BEGE-141 (Understanding Prose). (Annexure 8) At the time of course writing, it was discovered that there had been inadvertent duplication of one text in two courses. This change has therefore been proposed. The additions already figure in existing IGNOU materials of the BDP programme.
