- Dr. Gurupada Saren, Programme Coordinator, Ph.D. in Rural Development presented the Minutes of the Doctoral Committee Meeting of the Discipline of Rural Development that was held on 14th September, 2018.

- The Programme Coordinator, Prof. Neerja Chadha informed the School Board that the programmes PGDCFT & MSCCFT were launched in 2010, and thus it is important to update the programmes of study based on contemporary developments in the field as well as feedback obtained from the stakeholders. The Phase-Zero form for minor revision of PGDCFT and MSCCFT was approved by the School Board of SOCE in its 56th meeting held on 24.7.2017 and by the ACSC in its 46th meeting held on 24.5.2018. The Expert Committee Meeting for Minor Revision of the Modular Programmes Post Graduate Diploma in Counselling and Family Therapy (PGDCFT) and Master of Science in Counselling and Family Therapy (MSCCFT) was held on 12th and 13th October, 2017 (Minutes attached at Annexure). Prof. Chadha further added that the Expert Committee, inter alia, made the following major recommendations:
 - (i) To update the study material and add to it information on relevant policies and Acts that came up later.

In the meeting, the content of the theory blocks was discussed thoroughly and it was agreed to include in the programmes of study, information on the following:

Protection of Children from Sexual Offences (POCSO) Act, 2012 [to be added to Unit 10f MCFT-004 (of PGDCFT/MSCCFT 1st Year course material), and Unit 1 of MCFT-007 (of MSCCFT 2nd Year course material)]

National Mental Health Policy of India, 2014 [to be added to Unit 1 of MCFT-002 (of PGDCFT/MSCCFT 1st Year course material), and Unit 17 of MCFT-007 (of MSCCFT 2nd Year course material)]

Mental Healthcare Act, 2017 [to be added to Unit 6 of MCFT-002(of PGDCFT/MSCCFT 1st Year course material), and Unit 17 of MCFT-007 (of MSCCFT 2nd Year course material)]

Juvenile Justice (Care and Protection of Children) Act, 2015 [to be added to Unit 15 of MCFT-001(of PGDCFT/MSCCFT 1st Year course material), and Unit 2 of MCFT-007 (of MSCCFT 2nd Year course material)]

Rights of Persons with Disabilities Act, 2016 [to be added to Unit 15 of MCFT-002 (of PGDCFT/MSCCFT 1st Year course material), and Unit 4 of MCFT-007 (of MSCCFT 2nd Year course material)]

National Policy for Children, 2013 [to be added to Unit 14 of MCFT-001(of PGDCFT/MSCCFT 1st Year course material), and Unit 1 of MCFT-007 (of MSCCFT 2nd Year course material)]

National ECCE Policy, 2013 [to be added to Unit 13 of MCFT-001(of PGDCFT/MSCCFT 1st Year course material), and Unit 1 of MCFT-007 (of MSCCFT 2nd Year course material)]

Transplantation of Human Organs and Tissues Rules, 2014 [to be added to Unit 5 of MCFT-002(of PGDCFT/MSCCFT 1" Year course material), and Unit 10 of MCFT-007 (of MSCCFT 2" Year course material)]

Safety and security of children in schools [to be added to Unit 14 of MCFT-001(of PGDCFT/MSCCFT 1" Year course material), and Unit 3 of MCFT-007 (of MSCCFT 2nd Year course material)]

For old students, it was recommended that the above be printed as a separate booklet and mailed to them.

- (ii) To render admission to PGDCFT and MSCCFT open to all graduates. In view of the academic content of the programmes being exhaustive, comprehensive, and complete in itself, the Expert Committee strongly recommended the eligibility criteria for PGDCFT and MSCCFT to be changed to "Bachelor's degree in any subject from a recognized University".
- (iii) To rationalize the quantum of practical reports required to be submitted for evaluation by stipulating that for each two credit Supervised Practicum course, the learner may submit three practicals for evaluation. Further, for the Supervised Practicum of the elective courses (4 credits) and Internship (6 credits), the learner may observe, assist, or conduct the counselling and family therapy sessions. The Expert Committee recommended that these benefits also be extended to old students who are yet to complete these courses.
 An increase in remuneration for Academic Counsellors, particularly with respect to practical courses, was also recommended.

The Minutes of the Expert Committee Meeting for minor revision of PGDCFT and MSCCFT held on 12.10.2017 & 13.10.2017, including the above major recommendations, were placed for consideration and approval of the School Board.
