Agenda Item 3

To consider and approve the Programme Proposal Form and concept note of Four-Year Undergraduate Degree Programme Bachelor of Arts in Home Science.

SB 69.3.1

Prof. Heena K.Bijli, Programme Coordinator, presented the Programme Proposal Form for Four-Year Undergraduate Programme (FYUP) of Bachelor of Arts in Home Science, along with the Concept Note and detailed Need Assessment Study for consideration and approval of the School Board of SOCE. The other Programme Coordinators of this programme - Dr. Priyanka Dr. Hemlata Chand also Suryavanshi, Dr. Meenu Verma and discussed and provided clarifications, as asked by members of the School Board. Prof. Bijli articulated that the PPF, Concept Note and items used in the study were based on UGC-LOCF of B.Sc. / B.A. in Home Science, and/are in accordance with the UGC-LOCF which mentions B.Sc. / B.A. in Home Science, and in accordance with the UGC Curriculum and Credit Framework, in alignment with NEP 2020; hence this is an opportune time to start FYUP in Home Science. Both B.A. and B.Sc. (Home Science) programmes cover the same core subjects - Resource Management and Design Applications, Food Science and Nutrition, Human Development and Family Studies, Textiles and Clothing, and Extension and Communication. It was proposed to begin with FYUP in B.A. (Home Science), with the intention to develop a separate B.Sc. (Home Science) Programme in the future, as the Need Assessment study comprising of a sample of 594 respondents from 98 HEIs across the country revealed a great demand for both B.A. (Home Science) and B.Sc. (Home Science).

The School Board deliberated extensively and rigorously upon the nomenclature, eligibility and the job prospects of the programme. The School Board members stated that the concept of the Four-Year Degree Programme in the area of Home Science is a welcome idea. It was discussed whether the programme should be B.Sc. or B.A., what would be the difference in the eligibility criteria for the two streams or would these be the same, and what would be the difference in the syllabus structure for the two streams. Three

experts of Home Science (Dr. Kumud Khanna, Prof. Shagufa Kapadia and Prof. Manisha Gahlot) strongly expressed the view that the Four-Year Degree programme should be a Bachelor of Science as it is a well known name now and has a larger scope in terms of further study and employability.

Regarding the nomenclature, Dr. Priyanka Suryavanshi clarified that both B.A. (Home Science) and B.Sc. (Home Science) feature in the list of programmes recognised by the UGC-Distance Education Bureau (DEB). These programmes are currently being offered in various parts of the country. The demand for the programme in rural and tribal areas needs to be met, and based on IGNOU's mandate that the programme has to be inclusive, both B.A. and B.Sc. (Home Science) are required. Both are being run by different HEIs and cover the core subjects covered in the UGC-LOCF, as already mentioned by Prof. Bijli. However, the B.A. programme offers a broader perspective, concentrating on social sciences and humanities, and the B.Sc. programme provides a more specialized and scientific approach, emphasizing natural and applied sciences. The nomenclature and eligibility of the proposed B.A. (Home Science) are accordingly mentioned in PPF form. This agenda item is PPF of B.A. Home Science and its nomenclature does not pose any legal controversies in the old system or NEP 2020.

Prof. Meenakshi Mittal expressed that initiating B.A. (Home Science) would be advantageous to girls in rural areas who mostly study arts at 10+2 level and this will ensure uptake of this programme along with skill enhancement. She further added that UGC-NET exam is offered in Home Science, and hence all courses highlighted in UGC-LOCF which are taught to students in FYUP Home Science will prepare them for Masters' programmes in Home Science. Regarding employability, Dr. Meenu Verma responded that several government and non-governmental jobs are available for Graduates in Home Science and listed a few.

Prof Arbind Kumar Jha sought clarification about preference of respondents for B.A./B.Sc. (Home Science) and syllabus structure, based on the Need Assessment Study. Dr. Hemlata Chand informed that majority of the respondents expressed need for both B.A. and B.Sc. (Home Science) and only a small number expressed demand for either B.Sc. or B.A. (Home Science). Regarding syllabus, she clarified that the syllabus followed by different HEIs include multidisciplinary courses from physical and life sciences for B.Sc. (Home Science), and multidisciplinary courses from humanities and social sciences for B.A. (Home Science). Prof. Jha accepted the justification and noted that it may be more feasible to start B.A. (Home Science) than B.Sc. (Home Science) in the interest of the University and students at large.

It was also suggested that both the streams may be started together, since the Need Assessment revealed that a majority of the respondents had stated that both B.Sc. and B.A. should be offered by the University, and of the remaining respondents an equal number of respondents were in favour of either a B.A. or B.Sc.

Dr. Shagufa Kapadia suggested that the nomenclature should be 'Community Sciences' instead of Home Science to cater to contemporary needs and suitability of uptake by all genders, to which Prof. Bijli clarified that IGNOU follows UGC nomenclature, and 'Home Science' is a UGC recognized nomenclature. Prof. Manisha Gahlot also supported Home Science

nomenclature, as otherwise students are facing constraints in getting jobs, credit transfer and continuation of higher degrees in Home Science. The School Board noted the same.

Regarding eligibility, some Experts expressed the view that the eligibility should be open for all irrespective of whether the programme is offered as B.Sc. or B.A., while others were of the view that the eligibility for B.Sc. programme should be the students from the Science stream in Class-XII while for B.A., it should be 10+2 qualification from any recognized board, following university norms.

After taking all the viewpoints into consideration, the School Board considered and approved the Programme Proposal Form, along with the Need Assessment study and Concept Note of the Four-Year Undergraduate Degree Programme (Bachelor's Programme) in the area of Home Science with the guidance to the Programme Coordinators to finalise the nomenclature of B.Sc. / B.A. and eligibility in the Expert Committee Meeting to be held in the near future and/or as guided in the APC meeting where the PPF form will be put up next.

Agenda Item 4

To consider and recommend the list of Expert Committee Members for Four-Year Undergraduate Degree Programme Bachelor of Arts in Home Science.

SB 69.4.1

Prof. Heena K.Bijli presented the list of Expert Committee Members for Four-Year Undergraduate Degree Programme in Home Science for consideration and recommendation of the School Board of SOCE. The School Board members asked the Programme Coordinators whether there was equal representation of Experts from the different branches (areas) of Home Science in the list.

The Programme Coordinators informed the Board that Experts from all areas of Home science were included in the list. Care was taken to include mostly those experts who have developed FYUP in Home Science. The same was confirmed by the Board members after checking the list. Additional names suggested during the meeting, including the name of Dr. Arockia Maraichelvi, Associate Professor in Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore, suggested by Dr. Shagufa Kapadia, got included in the list.

Dr. Monika Misra expressed the concern that the list of members of Expert Committee was too long. Prof. Deeksha Kapur noted that under Internal Expert heading the entire Listing of internal faculty, SOCE with Name, Designation, Affiliation (to Discipline) should be included, and not merely mentioned as SOCE Faculty. Further considering the academic and financial implications she enquired whether all faculty specific to Four Disciplines within the School, with or without academic background or interest in the said area should be part of Expert Committee. The Director clarified that the names of External Members were being got approved so that there is enough option available with the Programme Coordinators in case some experts are unable to give consent on the proposed dates of meeting. The final list of invited experts would be shorter and as per IGNOU norms.

Regarding the internal faculty as Expert Committee Members, the Director clarified that it is the practice in our own School and in most Schools that the

entire faculty of the discipline is invited for the Expert Committee Meetings. Prof. Arbind Kumar Jha, School of Education and Dr. Monika Misra, School of Social Sciences were in agreement with the Director that this was the practice in their respective Schools. The Director clarified that since the Four-Year Undergraduate Programme in the area of Home Science would have content from all branches of Home Science, all the faculty members of the different branches of Home Science represented in the School would be invited for the Expert Committee. The members expressed that the names of internal faculty members should be written in the list. Regarding the faculty members of Rural Development, the Director clarified since Rural Development is not a branch of Home Science, it is the decision of Programme Coordinators regarding whom to invite from the faculty for Expert Committee meeting.

SB 69.4.2

The School Board considered and recommended the list of Expert Committee Members for Four-Year Undergraduate Degree Programme Bachelor of Arts in Home Science with the additional names suggested by Prof. Kapadia as mentioned above. All the faculty members of the different branches of Home Science represented in the School would be invited for the Expert Committee. The decision regarding the faculty of Rural Development to be invited for the Expert Committee would be taken by the Programme Coordinators.

Agenda Item 5

To consider and approve the Programme Proposal Form (PPF) and Concept Note of the Four-Year Undergraduate Degree Programme BSc. Hons. (Food and Nutrition).

SB 69.5.1

Prof. Deeksha Kapur, Dr. Shalini Kushwaha, Dr. Ankita Gupta and Dr. Namrata Singh presented the Programme Proposal Form (PPF) and Concept Note of the Four-Year Undergraduate Degree Programme BSc. Hons. (Food and Nutrition) for consideration and approval of the School Board of SOCE. The School Board members welcomed the idea of a B.Sc. Programme in Food and Nutrition. The eligibility criteria was discussed and some School Board members expressed the view that the eligibility should be Class-XII with Science background. However, the Experts from the Discipline of Home Science stated that in the Delhi University, the intake is taken from all streams Science, Arts or Commerce. Prof. S.P.Mishra cautioned the IGNOU faculty to find out from relevant authorities whether admitting students from Non-Science background into a B.Sc. Programme would not cause difficulties in terms of equivalence of Degrees in the long run in national and international context as well as in access to higher education.

The Director pointed out that the nomenclature of the Programme should be BSc. (Food and Nutrition) and not BSc. Hons. (Food and Nutrition) as the student who exits in the 3rd Year would get the Degree of a Major and the student who exits in the 4th Year would get the Degree of Honours.

SB 69.5.2

The School Board considered and approved the Programme Proposal Form (PPF) and Concept Note of the Four-Year Undergraduate Degree Programme with the nomenclature BSc. (Food and Nutrition) instead of BSc. Hons. (Food and Nutrition), with the eligibility as open to all streams which could be further discussed in the Expert Committee meeting.

To consider and approve the Programme Development Form (PDF), Minutes of Expert Committee Meeting with detailed Programme Structure and Programme Project Report (PPR) for B.Sc. in Fabric and Apparel Design.

SB 69.6.1

Dr. Richa Prakash Presented the agenda and explained about the Programme requirements, structure and evaluation methodology. Dr. Anuradha Arya inform the members that the Programme is also aligned with the NSQF level and at each exit level of the Programme have some Job Role along with NSQF levels.

The nomenclature of Undergraduate Degree B.A. / B.Sc. for Fabric and Apparel Design was also discussed by the Board Members. Prof. Arbind Kumar Jha raised the issue of discrepancy in the name of the Degree from PPF to PDF Form. He stated that the PPF Form mentions that the programme is approved as B.A. programme whereas the PDF Form now mentions the programme as a B.Sc. programme. It was explained by Dr. Richa Prakash, that that the proposal in the PPF Form placed before the APC was that of a B.Sc./B.A., the APC had approved it as a B.A. programme. Subsequently, when during the Expert Committee Meeting held on 26th and 27th of February, 2024, it was unanimously decided by all the experts that the Degree must be B.Sc., as an Arts Degree would create obstacles for the enrolled learners to pursue further higher education/degrees. It was also advised by all the experts in the Expert Committee Meeting that the B.Sc. Programme should be 'open to all' for admissions in this Programme. Both these decisions of the Experts has been reflected in the current PDF Form and the same will be put up for approval of the ACSC/Academic Council.

The School Board members suggested maintaining uniformity in the nomenclatures of all the Undergraduate Programmes being proposed by the School. Accordingly, in keeping with the nomenclature for the proposed Four-Year Undergraduate Programmes in the area of Home Science and Foods and Nutrition, the Undergraduate Programme in the area of Fabric and Textile Design should have the nomenclature B.Sc. (Fabric and Apparel Design) instead of B.Sc. in Fabric and Apparel Design (FYUP).

Prof. Neerja Chadha suggested that in the evaluation methodology of practical courses it should be stated that the evaluation would be done by a Panel of Evaluators identified by IGNOU instead of only by Programmme Coordinators.

The School Board considered and approved the Programme Development Form (PDF), Minutes of Expert Committee Meeting with detailed Programme Structure and Programme Project Report (PPR) for B.Sc. (Fabric and Apparel Design).

They stated that revision of the programme was appropriate in order to make it contemporary. The shared structure for the revision of the Diploma Programme to 40 credits received validation by all the experts.

Prof. Rekha Sharma Sen highlighted that in order to make the learners accountable for carrying out the field based practical activities, these would be made a compulsory part of the assignments when the Diploma would be revised.
