While the NCAHP Act came into force in 2021, the Commission was formed in 2023-24 and the process of forming the syllabi and regulations for various sectors covered under the Act is still not complete. Accordingly, it was felt that in this window period, till the full and proper guidelines of the NCAHP Act

- 4. It was clarified by the members of the School Board that an Act cannot be enforced from retrospective effect. Accordingly, the students of IGNOU who have enrolled in the programme till date would be governed by previous provisions and cannot be discriminated against. The IGNOU should strive to get the University listed as a recognized institution on the portal which governs registration of students, so that the students who complete the programmes in the window period available till the guidelines are formulated and announced as finalized, are not penalized and do not suffer.

Additionally the following points were stated:

- a. The nomenclature of the Masters of Science (Nutrition & Dietetics) programme should be stated as the same across all PPF, PDF and PPR forms.
- b. While the IGNOU forms mention 'Number of Counseling Sessions', it should be clarified in the PDF form for Masters of Science (Nutrition & Dietetics) that these will actually be face-to-face theory classes.
