**Item No. 59.4      To consider and approve the implementation of plagiarism checks for MCA project synopsis submission and project report submission.**

**Discussion:**

The following points were discussed in the meeting:

- o The members unanimously expressed that there is a strong need for implementing plagiarism checks for MCA project report submissions to uphold academic integrity and ensure the originality of student work.
- o It was agreed that the University administration will explore and procure appropriate plagiarism detection software.
- o The financial expenses for conducting plagiarism checks should not be passed on to the students. Instead, the University should look into.

- Since many University programmes include a project component, the members emphasized the necessity of framing a comprehensive policy on plagiarism applicable to all Schools.
- The committee recommended preparing detailed modalities for implementing the plagiarism check, including submission protocols, plagiarism thresholds, and consequences for violations.
- These modalities should be integrated into the broader policy framework.
- The members highlighted the growing use of AI-generated content in academic work.
- It was proposed that the policy should define clear guidelines on the acceptable extent of AI-generated content in project reports.
- The framework should specify the permissible percentage or nature of AI-assisted content, ensuring it does not undermine academic integrity.

**Decision:**

The item was principally agreed, however, will be placed in the consecutive School Board Meeting with modalities which will be integrated into the broader policy framework of the University.

**Item No.59.5**

**To consider and approve the exemption of BCS-012 for the students who completed all the courses of MCA (Revised) except BCS-012, subject to completion of maximum duration.**

**Discussion:**

The matter was placed before the members of School Board by the Coordinator of the course BCS-012, and the same was discussed in detail in the meeting.

The members of the board understood the purpose of the course of BCS-012 is to form firm footing of mathematics (which was required to successfully complete the courses of MCA(Revised)), the course of BCS-012 was recommended to the students “*who took admission into MCA(Revised) - from July 2013 Onwards, and did not have mathematics at 10+2 level or at graduate level*”.

The members of the School Board considered that, if the student has already cleared all the courses of MCA(Revised) including project work, except BCS-012 (a bridge course of Basic Mathematics for MCA(Revised)), then it justifies that the student has sufficient understanding of the concepts of mathematics required for the completion of MCA (revised).

Hence, the members of the School Board of SOCIS felt that exemption from BCS-012 may be granted to all the students of MCA (Revised), who completed all the courses of MCA (Revised) except BCS-012, subject to completion of maximum duration.

**Decision:**

The members of the School Board of SOCIS felt that exemption from BCS-012 may be granted to all the students of MCA (Revised), who completed all the courses of MCA (Revised) except BCS-012, subject to completion of maximum duration.

**Item No. 59.6 To consider and approve the credit transfer policy from PGDCA\_NEW to PGDCA\_NEW**

**Discussion:** The coordinator of PGDCA\_NEW programme placed the credit transfer policy from PGDCA\_NEW to PGDCA\_NEW. The coordinator of PGDCA\_NEW informed the members of the school board that PGDCA programme was revised and the code of the new PGDCA programme is PGDCA\_NEW, which is on offer since January, 2021 cycle. The maximum duration for the completion of the PGDCA\_NEW programme is 36 Months i.e. three years, which is attained in January 2024. Now, The Students of PGDCA\_NEW who are not successful in all courses in the prescribed period, needs to apply for credit transfer from PGDCA\_NEW to PGDCA\_NEW after applying for admission to first semester of PGDCA\_NEW programme.

The proposed Credit Transfer Policy from PGDCA\_NEW to PGDCA\_NEW programme of School of Computer and Information Sciences (SOCIS) is herewith attached in Annexure-59.6.1, and placed before the members of School Board for approval.
