At the outset, Prof. B. K. Pattanaik, Director, SOEDS welcomed the Members of the School Board. The Members were briefed about the item-wise action taken on the various Agenda Items of the last (7th) School Board Minutes and current position with regard to the Academic Programmes of the School. This was followed by item-wise discussion on the agenda items. The outcomes of the School Board Meeting are placed below.

- SB 8.4.1 When the Chairman took up the item, he requested Dr. Lakshmi Reddy to present it. Dr. Reddy gave full details of the programme along with its background. He explained that the Post-Graduate Certificate in Adult Education. Participatory Adult Learning, Documentation and Information Networking (PGCAE) as proposed is carved out of the existing PGDAE programme, which is already on offer as an independent programme of one year duration. PGDAE has also been included as a module (First year) of MA (Adult Education), and Phase -III of it had already been approved by the School Board in the previous meeting. He also gave a brief history of as to how Participatory Adult Learning, Documentation and Information Networking had become part of the title of PGDAE. The sum and substance of his presentation made for consideration and approval included the following.
 - First two courses of PGDAE as a whole (as two theory courses) and part of its practical course (as a practical course) have been reorganised into PGCAE of six months duration with a view to offer short-term programme catering to the short-term needs and interests of professional development and capacity building in adult education.
 - The proposed PGCAE will be offered as an independent programme, and also as a module forming part of PGDAE. It means, the students entolled for PGDAE who complete its relevant courses and practical components which are constituted into PGCAE will also be awarded PGCAE. Also, those students who complete PGCAE can get enrolled for PGDAE and complete only remaining part of the course work to get PGDAE.
 - Similarly, since PGDAE is included as a module (First year) of MA (Adult Education), which is now under development, the students entolled for MA (Adult Education) and completing the courses that constitute PGCAE or PGDAE will accordingly be awarded PGCAE or PGDAE. Also, those students who complete PGCAE or PGDAE can get enrolled for MA(AE) and complete only remaining part of the course work to get MA(AE).
 - To be more precise, PGCAE, PGDAE and MA (AE) will be offered as independent programmes, but PGCAE and PGDAE will form integral modules of MA(AE) i. e. it will consist of PGCAE (Module-I), PGDAE (Module-II) and MA (AE) Module-III. There will be provision for lateral entry and exit into these modules/programmes.

When the matter was opened up for discussion there was suggestion from a member that the subtitle in the programme (i.e Participatory Adult Learning, Documentation and Information Networking) be deleted from the title and simply retained as Post-Graduate Certificate in Adult Education. All the

	members had unanimously endorsed the suggestion, which Dr. Reddy readily agreed to.	
	Accordingly, all the above points submitted for consideration of the Board have been unanimously approved. Dr. Reddy was also advised to complete the practical course work of PGCAE at the earliest and offer it from July 2010 session along with MA(AE) making clear provision for its (PGCAE) offer as an independent programme as well as integral modular component of PGDAE and MA(AE).
