SB 23.3.1	<p>The Programme Coordinators informed the School Board that, with the approval of 46<sup>th</sup> ACSC, the SOEDS had launched MA in Development Studies (MADVS) programme from July 2018 session with 72 credits (36 credits in 1<sup>st</sup> Year and 36 credits in 2<sup>nd</sup> Year). 1000 sets of study material and programme guides were printed for MADVS programme. In the launch year of MADVS programme 427 students have joined (266 in July 2018 and 161 in January 2019). Requests have been received from several students and working professionals who were already postgraduates to start a PG Diploma in Development Studies.</p> <p>Therefore, it is proposed to offer the 1<sup>st</sup> year of MADVS as PG Diploma in Development Studies (PGDDVS) from July 2019 session.</p> <p>During deliberations the School Board noted the following:</p> <ul style="list-style-type: none"> <li>• There will not be any additional cost except printing a Programme Guide for PGDDVS.</li> <li>• As on January 2019, 44 study centres have been activated for MADVS programme and the same will be utilized for PGDDVS without any additional cost.</li> <li>• After completing PGDDVS programme, interested students can take admission in MADVS 2<sup>nd</sup> Year directly by re-registration.</li> </ul> <p>After deliberations, the School Board approved the Programme Development Form (PDF) &amp; Programme Project Report (PPR) for PG Diploma in Development Studies (PGDDVS) (Annexure 2 &amp; 3).</p>
