S.B.11.1: The School Board members confirmed the minutes of 10th School Board meeting. (Annexure-1)

S.B.10.2: The School Board members approved the A.T.R on the 10th School Board. (Annexure-2)

S.B.11.3: The School Board members approved the names of Course Writers for PG Diploma in Spanish-English-Spanish Translation and Interpretation (PGDTISL). (Annexure- 3)

S.B.11.4: The School Board members approved the name of Ms. Jyoti Sharma, Consultant (German), SOFL as Evaluator of DTG (Diploma in Teaching German). (Annexure – 4). The School Board also approved Ms. Jyoti Sharma as moderator for CGL and DTG.

S.B.11.5: The School Board members approved Phase 0 Form for inclusion of Teaching of French as content based methodology course in B.Ed. Programme. (Annexure – 5)

S.B.11.6: The School Board members welcomed the idea of World Language Literature and Culture Studies (WLL&CS) as discipline of SOFL. However, it was suggested that before the declaration of any Discipline of SOFL, the matter should be discussed in a National Workshop and the recommendations of the National Workshop should be presented to the School Board for further deliberations and approvals (Annexure - 6)

S.B.11.7: The School Board members approved the development of a common Ph.D. programme of SOFL (Annexure - 7) and suggested that it be named Ph.D. Programme in Foreign Languages.

The School Board also suggested that the recommendations of the Experts Committee for declaring the discipline(s) of SOFL should be followed and accordingly new nomenclature for the Ph.D. programme be given once the discipline(s) is/are approved by the competent authorities. Until new disciplines are declared in SOFL, Ph.D. in new languages/areas may be launched following the due procedures subject to the availability of the qualified Supervisors approved by the School Board.

S.B.11.8: The School Board members approved the inclusion of Ph.D. in French in the common Ph.D. programme of SOFL and suggested that it be called Ph.D. in French (Foreign Languages). The School Board also suggested that all existing Research Scholars for Ph.D. in French be included in Ph.D. in French (Foreign Languages). (Annexure - 8)


