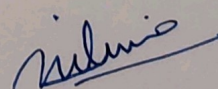

SCHOOL OF GENDER AND DEVELOPMENT STUDIES

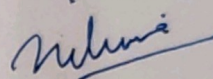


Based on the subject expertise and the academic requirement of the School, the following five names were considered for co-option as External Members under Clause 2 (e) of the Statute 10 A :
