School Board members elaborated on the various aspects of the software being used and pointed out salient shortcomings. It was also suggested that better results with translation software are obtained with para wise or line wise translation. In this context, it was decided to review the experience in consultation with the relevant Regional Centres for the regional languages in substantial demand before taking an appropriate decision. Vetting and editing by language experts and content experts/ faculty well versed with the language concerned would be considered.

The School Board recommended that coordination of the regional language versions which have a sizeable demand can be entrusted to the respective Regional Centres of IGNOU, if approved by the University authorities.

There was considerable discussion on the procedures in approval of evaluators by the Doctoral Research Committee and School Board in sealed envelope. Any focal areas added will be placed before the School Board for approval by circulation and reported to the School Board in its next subsequent meeting.

The School Board advised that instead of Mother Tongue/ Regional Language, the term “Indian Language” could be used in alignment with the NEP 2020. The School proposes to suggest to the Student Evaluation Division (SED) that interested students enrolled for SOGDS programmes may be permitted to write their answer scripts in 14 Indian Languages concerned, if they so desire, based on demand and specific requests made to the University. Candidates are already permitted to write their answers in Hindi even for courses offered only in English.

The School Board agreed to the proposal that the programme/ course coordinators/ faculty may identify evaluators in Indian Languages based on demand so that answer scripts written in the respective languages may be evaluated. Panels of such evaluators may be suggested.
