## AGENDA ITEM: 44.2 To Consider and Recommend Multiple Entry and Multiple Exit and Lateral Entry for BA (Gender Studies) (BAGS)

Prof. Himadri Roy, Programme Coordinator, BAGS presented the Item. School Board Members appreciated the initiative aligning with NEP, 2020. The need for deepening and strengthening such initiatives was mentioned. The possibility of including a skill development component worth 4 credits for incorporation into the FYUP programme in Gender Studies at the design stage was mentioned. It was clarified by the Programme Coordinator that this 4-credit component would be considered for the FYUP. It was not envisaged to be a part of the three-year BAGS programme being considered in the present meeting. A gap period of one year was suggested for Lateral Entry into BAGS.

The Item was recommended by the School Board for consideration of the Academic Council/Academic Council Standing Committee in consultation with concerned University Division's Student Registration Division (SRD) and Student Evaluation Division (SED).
