Agenda Item 1: Confirmation of Minutes of 5th School Board: The Minutes of the 5th Meeting held on July, 23, 2009 were confirmed as circulated.

Agenda Item 2: Offer of Certificate/Diploma in Gender and Agriculture: The School proposes to offer the Certificate/Diploma programmes in Gender, Agriculture and Sustainable Development jointly with School of Agriculture and the Chair for Sustainable Development, IGNOU. IDRC has also expressed willingness to collaborate. A communication has been received from School of Agriculture that the School is willing in principle to collaborate in the design and development of the programme.

The School Board approved the proposal and suggested that the Phase 1 Form be submitted to the School Board for approval

Agenda Item 3: Offer of Diploma or Certificate in Gender and Law: Prof. Srikrishna Deva Rao, Director, School of Law who attended the meeting as a Special Invitee, supported this collaborative initiative with School of Law. He suggested a modular approach beginning with offer of a Certificate Programme in Gender and Law.

The School Board approved the proposal and suggested that the Phase 1 Form be submitted to the School Board for approval.

Agenda Item 4: Collaboration with Centre of Gender and Cultural Studies, RWANDA: The Chairperson explained the nature and scope of the proposed collaboration with the Centre of Gender and Cultural Studies, RWANDA.

The School Board, while welcoming collaboration initiatives, suggested exploration of the scope and details of arrangements required to operationalize the collaboration.
