The outcome-oriented six-year project aims to improve sheric term skill training qualitatively and quantitatively through strengthening institutions, bringing in better market connectivity and inclusion of marginalized sections of the society. An MoU was signed on 22-11-2021 between Indira Gandhi National Open University (IGNOU) and Ministry of Skill Development and Entrepreneurship (MSDE) for capacity building of officials working under State Skill Development Mission and District Skill Committees under the SANKALP Project. The MSDE has approved a budget of Rs. 10,43,57,000/- for IGNOU to act as a knowledge partner in imparting training in a blended mode. A core group of teachers and academics will act as Master Trainers who will be trained by MSDE officials. Upon such training, the Master Trainers will train 400 TOTs who shall further train 4000 district officials. The training programme shall be offered in a modular form using the IGNOU model with a total of 16 credit programme offered at the Certificate level. The target date for completion of the entire Project by IGNOU is 31-03-2023. The competent authority has constituted a steering committee with a Principal Investigator for the Project. The agenda was approved in principle in the 54th Meeting of the Academic Council's Standing Committee held on 10th December 2021 and the Programme will be housed in SOITS.
