He mentioned that it is the first time that we are conducting School Board meeting through virtual/online mode and wish to welcome all the members in the School premises for the next meeting. Subsequently the Agenda Items of the 23<sup>rd</sup> School Board meeting were taken up for discussion.

Confirmation of the Minutes of the 22nd School Board Meeting held on February 19, 2020 and to note the action taken thereon.

The Chairperson informed that the Minutes of 22<sup>nd</sup> School Board Meeting held on February 19, 2020 were circulated among the members and no comments have been received. The Board confirmed the Minutes of the 22<sup>nd</sup> School Board Meeting and noted the action taken there on.

To apprise the School Board about the new developments and status of programmes 23.02: since the last School Board Meeting.

(i) To consider and approve the Concept of BA(JMC)

The School is not having any programme at graduate level and therefore a concept note was placed before the School Board. It will also allow the School to think of an integrated programme of five years with relevant entry and exit options. School Board approved the concept note in principle and suggested to take due caution while drafting a curriculum and integrating it with the existing MA programme.

(ii) To consider and approve the additional list of Course Writers of PGDDC

The School Board recommended the list for approval of the Competent Authority.

(iii)To consider and approve the List of Evaluators, Moderators and Question Paper Setters for MA (Journalism and Mass Communication)

It was reported that the names of paper setters, evaluators and moderators have been approved by the 22<sup>nd</sup> School Board for the revised PGJMC which is also the 1<sup>st</sup> Year of MAJMC. The same list has been proposed by only adding the course codes for the II year of MAJMC.

The School Board opined that as the names have already been approved by the 22<sup>nd</sup> School Board so the list stands ratified.
