At the outset, the Chairman welcomed all the Internal Members of the School Board. The Chairman informed the members that the tenure of the external members have expired aiready, hence, this meeting is called primarily for the purpose to co-opt new external members under clause 2(e) of statute 10 (A). The Chairman also placed on record the contributions made by the previous External Members of School Board of School of Law.

Thereafter, the Agenda items were taken up for discussion.

item No. 13.1 Confirmation of Minutes of the Twelfth School Board Meeting

SB 13.1.1 The Chairman and Director, SOL informed the Board Members that the Minutes of the Twelfth Meeting of the School Board of School of Law held on 19th June, 2012 were circulated among the Members on 25 July, 2012. The comments received from Dr Gurmeet Kaur, Dr. Suneet Kashyap, Ms. Mansi Sharma and Mr. Anand Gupta was brought to the notice of the Members.

The comments received from the said faculty members in connection with the objection to review of the progress of the work of SOL faculty by School Board was discussed at length and after detailed deliberations, it was resolved that it is well within the purview of School Board to review the work done by faculty of SOL. Accordingly, it was held that there is no need to effect any change in the paragraph 12.2.9 of the Minutes of 12th School Board Meeting.

- SB 13.1.2 The other observations made by the said faculty members have been noted and accepted.
- SB 13.1.3 The Minutes of the 12th School Board Meeting were confirmed with above observations.
- Item No. 13.2 The Action Taken Report on the Minutes of the Twelfth School Board Meeting.
- SB 13.2.1 The Action Taken Report on the Minutes of the Twelfth School Board Meeting was reviewed and noted by the School Board Members.

Item No.13.3 Recommendation of names of outside Experts for Co-option of School Board Members of SOL under Clause 2 (e) of Statute 10 (A)

SB13.3.1 The Chairman informed the School Board Members that the terms of External School Board Members of SOL has come to an end on 23 August, 2012. Hence, new external Members have to be recommended for reconstitution of School Board under Clause 2 (e) of Statute 10 (A). The names as recommended by the School in the 7th School Council Meeting held on 28 September, 2012 was placed before the Members.

The Chairman observed and suggested that it is desirable to have one female outside expert member in the school board. The Chairman also informed that Prof. K.N. Chandrashekaran Pillai, Director, National Judicial Academy Bhopal whose name has been recommend by School Council could not attend expert committee meetings called earlier due to his busy schedule. In view of the above, it was suggested that a female outside expert may be included against the name of Prof. Chandrashekeran Pillai for the reasons specified above.

Item No 13.10 To consider the offer of One Year LLM Programme

- SB 13.10.1 The Chairman informed the School Board Members about the offering of one Year LLM Programme by School of Law. The Chairman informed the members that an Expert Committee appointed by the UGC in 2010 submitted a report proposing LL.M one year for its early implementation. It is learnt that the UGC has accepted the recommendations one year only. The Chairman said that faculty position needs to be strengthened enhanced two years through distance mode.
- SB 13.10.2 The School Board Members appreciated and considered the proposal and requested the SOL to prepare detailed curriculum and place it before the next School Board Meeting.

Item No 13.11 To consider the offer of Programme on Laws governing Police Officials

SB 13.11.1 The Chairman informed the School Board Members that in the 13th Trafficking in Human Being Review Meeting held on 2nd November, 2012 organized by Ministry of Home Affairs, GOI, a suggestion—cum-request was made to SOL, IGNOU to consider the scope laws. It was felt in the meeting that a design of such a course will go a long way in helping the police personnel to understand clearly the relevant legal provisions they come across

The Director, SOL who participated in the meeting felt that it is desirable to initiate steps to design such a course. Initially the school will start the programme exclusively for the

Police Personnel at the Constable Level. The Chairman said that already ground level work has been initiated by the School. He said that SOL in collaboration with NHRC has already offered a one week online Training Programme for Police Personnel simultaneously at three places i.e. the police academies of Delhi at Delhi, UP at Moradabad and Haryana at Madhuban.

The Chairman said that National Police Academy, Hyderabad and BPR&D will be consulted to start this programme for police personnel by School of Law.

- SB 13.11.2 The School Board Members said it is a very good idea and it should be a bilingual programme for sensitization of police personnel. Discussion was held whether it should be a credit or non credit programme.
- SB13.11.3 The School Board approved this item for starting the Programme on Laws governing Police Officials
- Item No13.12 To discuss the composition and terms of reference of the Review of the Course Work for Ph.D. in Law
- SB 13.12.1 Director, SOL informed that School of Law informed the members that the candidates are admitted to PhD in law after fulfilling the required qualification and experience and thereafter they have to present the proposed topic before the doctoral committee and also have to under go one year course work. (Two compulsory and one optional) under Category A. Director, SOL, also informed that in the 10th School Board Meeting of SOL, the curriculum of course work as finalized in Expert Committee Meeting held on 15 November, 2010 was placed before the School Board. In that meeting, the School Board members felt it was felt by Members to streamline the process, and to reconsider and incorporate the changes in the curriculum and redraft it.
- SB13.12.2 After long discussion, it was felt by all the members that the Course Work need not be reviewed but appropriate steps may be taken for operationalization of Course work of Ph.D in Law.

The meeting ended with a vote of thanks to the Chair.
