SB 19.7.2 After detailed deliberations, the list of Moderators for above programmes along with course code as proposed by the programme coordinators were approved by the School Board.

Item No. 19.8 To consider and approve Programme Proposal Form (PPF) of PGCCL Programme.

SB 19.8.1 The Programe Coordinator, Dr. Gurmeet Kaur, informed that the Post Graduate Certificate in Cyber Law (PGCCL) programme is due for revision and the same was approved in 17th School Board Meeting held on 19th May 2016 ((Item No 7.6). The Expert Committee Meeting for revision of the programme was held on 10th and 11th August 2016. While updating the course contents for the programme, the level of the programme was also changed from Certificate to Diploma.

SB 19.8.2 The Programme Coordinator also informed that the 18th School Board Meeting held on 2nd March 2017, while deliberating on the agenda item (Phase Zero-PGCCL), suggested that since there is upgradation of the programme from PG Certificate to PG Diploma level and considering the fact that the revised curriculum has already been formulated in the Expert Committee Meeting, the Phase 1 & 2 forms may be placed before the next School Board.

- SB 19.8.3 The Programme Coordinator further informed that keep in view the fact that the existing Phase Forms have been revised and replaced with the revised Forms and the same have been notified by the university, the Programme Proposal Form (PPF) is placed before School Board for consideration and approval (Annexure-8).
- SB 19.8.4 During the deliberations it was suggested this programme PGCCL may be initially revised and thereafter may be upgraded to Diploma Programme due to reasons such as the upgradation of this programme into Diploma programme as proposed may not enable the earlier passed PGCCL students interested to get a Diploma Certificate by doing the additional courses etc.
- SB 19.8.5 After detail deliberations and to begin with, the revision of the PGCCL Programme was approved by the School Board and the Programme Coordinator, accordingly, was requested to initiate step in this direction.
- Item No. 19.9 To consider and approve Programme Revision Form (PRF) of CAHT Programme.
- SB 19.9.1 The Programme Coordinator, Dr. Mansi Sharma, informed that the Certificate in Anti Human Trafficking Programme was launched in July, 2010. The 17th School Board held on 19th May, 2016 Item No. 17.9 approved the proposal for revision of Certificate in Anti Human Trafficking programme. The Board also approved the names of the members of the Expert Committee Meeting for the purpose of revision of this programme. The Expert Committee Meeting was held on 25th August, 2017. After detailed deliberations the committee revised the existing curriculum for major revision of the programme.
- SB 19.9.2 The Programme Coordinator, Dr. Mansi Sharma, accordingly submitted the Programme Revision Form (PRF) alongwith the revised curriculum (Annexure-9) for consideration and approval of the School Board.
- During deliberations, it was observed that a budget of Rs.12 lakhs proposed for revision of this course appears to be on the higher side, hence, suggested to bring down to make it more realistic and also the time limit proposed for launching this course should be inconformity with the time line prescribed by the University Authorities.
- SB 19.9.4 After detailed deliberations, PRF form was approved by the School Board.
- During the deliberations, it was also observed that the CAHT revised curriculum contain only the names of Units and Blocks, whereas, the major aspects to be covered under each Unit should have also been included in the revised curriculum (as it is being done in other courses revised/under revision in SOL).
- SB 19.9.6 The Programme Coordinator was requested to take cognizance of the above and do the needful accordingly.
