The following Agenda Items were taken up for discussion.

Item No. 34.1 Confirmation of the Minutes of the 32nd School Board Meeting held on 3rd January, 2025 and to Note the action taken.

- S.B. 34.1.1 The Chairperson informed the Board that the Minutes of the 32nd School Board Meeting held on 3rd January, 2025 were circulated to all the members for approval and also reported the action taken on the agenda items.

Item No. 34.2 Reporting of agenda items approved by circulation in 33rd School Board on 6th February, 2025 and to Note the action taken.

Item No. 34.3 Confirmation of the Minutes of 22nd DRC held on 3rd April, 2025.

- SB 34.3.1 The Board approved the Minutes of the 22nd DRC Meeting of the School of Law held on 3rd April 2025 (**Annexure-5**).

Item No. 34.4 To consider and approve the extension of Period for Registration of Research Scholar, Ms. Vasundhra Enrolment no. 173102372 registered in 2017 session.

- SB 34.4.1 The programme coordinator informed the Board Members that Ms. Vasundhra enrolment no. 173102372 registered in 2017 session has requested for extension of the time by 6 months to complete her research as she met with an accident (eye injury) in middle of her thesis which have impacted her ability to complete the thesis. The topic of her research is 'Right of compensation to victims of crime in India: A critical analysis'. Her period of registration is expiring on 03/05/2025. The 22nd DRC meeting held on 03/04/2025 recommended her extension for 6th months which expired on 2nd November, 2025. She has completed her thesis; her supervisor Prof. Anand Gupta has recommended her extension till 2nd January, 2026.
- SB 34.4.2 The matter was discussed in the School Board and the members approved the extension of Period for Registration of Research Scholar; Ms. Vasundhra Enrolment no. 173102372 registered in 2017 up to 2nd January, 2026 keeping in view the best interest of the Research Scholar.

Item No. 34.5 To consider and approve the names of External Members for Doctoral Research Committee, SOL.

Item No. 34.6 To consider and approve list of Additional Unit Writers / Editors for the programme Diploma in Paralegal Practice (DIPP).

SB 34.6.1 The programme coordinator informed the Board Members that the Diploma in Paralegal Practice (DIPP) is under revision with the approval of Statutory Bodies of IGNOU and will be launched from January, 2026 session. The Units have been assigned to the Course Writers for writing. However, the need was felt for additional unit writers and editors.


Item No. 34.8 To consider and approve the list of Translator and Editors for translating the SLM of DIPP in Hindi.

SB 34.8.1 The programme coordinator informed the Board Members that the School of Law, IGNOU is revising the Diploma in Paralegal Practice (DIPP) programme. The programme will be offered in both English and Hindi medium. The list of Translator and Editors for translating the material in Hindi is placed before School Board for consideration and approval.

SB. 34.8.2 The matter was taken up for discussion and possibility of translation through machine was also discussed. The members opined that the translation should be in simple language and taking into account legal terminologies and to avoid any ambiguity the machine translation is not viable.

SB34.8.3 The Board approved the list of Translator and Editors for translating the SLM of DIPP in Hindi. (**Annexure-9**).
