Item No. 4: To consider and approve the Phase-1 Form and Phase-3 Form for Certificate Programme in Office Management for NGOs Staff.

Dr. M.S. S. Raju, Programme Coordinator, presented the details of the Phase-1 Form and Phase-3 Form and explained the programme structure as approved by the Expert Committee in the meeting held on September 5, 2006 and circulated the minutes of the said meeting. Dr. Subodh Kesarvani, Joint Programme Coordinator gave further details. It is informed that the Expert Committee suggested change in the title of the programme as 'Certificate in Business Skills'. It is also informed to the School Board that the programme is developed in collaboration with Rajeev Gandhi Foundation, New Delhi and Commonwealth of Learning, Canada. However, the programme will be offered by IGNOU like any other certificate programme of the university. Out of the four courses proposed in the certificate programme, three courses are adopted from the existing programmes of the university and one new course "Business Communications and Entrepreneurship" is developed for this Certificate in collaboration with Rajeev Gandhi Foundation and Commonwealth of Learning. The Programme Code and the Course Code for the new course are yet to be assigned by the Planning Division as per the University practice.

The School Board appreciated this initiative. The School Board authorized the faculty to incorporate the Programme Code and Course Code as and when assigned by the Planning Division. The change in the programme title as Certificate in Business Skills is noted and Phase-1 and Phase-3 are approved by the School Board.

Item No.5: Consider and approve Phase Zero Form for Application Oriented Course "BCE-01 Business Communication and Entrepreneurship" for the BDP Programme.

Dr. M.S.S. Raju, Course Coordinator presented the details of the course structure and informed that the course is developed in collaboration with Rajeev Gandhi Foundation, New Delhi and Commonwealth of Learning, Canada for the Certificate in Business Skills Programme. As this course is very much relevant and useful for the B.Com. students, faculty proposed the same to be included in the Application Oriented courses for the Bachelors Degree Programme. This proposal was discussed and approved by the Expert Committee held on September 5, 2006. The programme code

for the new course is to be assigned by the Planning Division as per the University practice.

The School Board authorized faculty to incorporate the course code as and when assigned by the Planning Division. Phase Zero is approved by the School Board.

Item No. 6:

To Consider and approve Phase Zero Form for MS-410 Financial Innovations and Engineering as a specialization course in the finance area of the Management Programme.
