Prof. M.S. Senam Raju, Director and Chairman extended a warm welcome and thankfulness to all the members who attended the meeting to provide the valuable suggestions and further improvement of the academic activities of the school. He further informed that considering the

increase in the cases of covid variant, the present meeting is being conducted through virtual mode.

He appreciated the faculty of SOMS for their proactive role of the actions taken on the decisions of the School Board in its 56th Meeting. He informed the members that this time also there are some agenda items pertaining to design and development of new courses.

Prof. M.S. Senam Raju, Director, SOMS further informed that after the previous meeting of the School Board, some important activities have been taken place in the university i.e. the MBA material was released in Hindi medium and the MBA programmes were launched in Oriya and Hindi medium from July 2025 admission session onwards. He further informed that recently an MOU was signed with the Odisha Government to translate all the study material of IGNOU in Oriya language.

Therefore, since their maximum period is going to lapse and they have requested for 45 days extra time which was recommended by the concerned supervisors also. Hence, in view of the urgency and time bound actions required, the DRC was conducted. The DRC recommended for extension on health and humanitarian grounds. Further, an agenda item in this regard was circulated alongwith the resolution for approval of the School Board by circulation. He informed that all the members have given the approval for this agenda. He expressed heartfelt thanks for cooperation from all the members. Subsequently, the matter was placed before the Research Council and the minutes of Research Council are awaited.

57.4	<p>To consider and approve the minutes of the Course Design and Development Committee Meeting for the Course BMP-003: Management of International Business under the Bachelor of Business Administration (BBA) Programme alongwith the List of Course Writers and Hindi Translators.</p>
57.4.1	<p>Prof. Nawal Kishor, Course Coordinator, presented the item and informed the members of the School Board that the university has launched the Bachelor of Business Administration Programme (BBA) from the admission cycle July, 2023 onwards. BBA is 3 years' program, based on the National Education Policy 2020 and have 20 credits in each semester.</p> <p>Except five new courses for design and development, the remaining all courses we have adopted from the existing courses of BCOM and BBA retailing programs. The presently proposed course BMP-003: Management of International Business is specially focused on the changes taken place due to dynamic nature of the international business. A list of seven Experts for Course Design and Development Committee was duly approved by the School Board in its 52nd Meeting (52.24) held on 20th April, 2023. Further, a list of four Experts for Course Design and Development Committee was duly approved by the School Board in its 55th Meeting (55.10) held on 25th October, 2024.</p> <p>With the approval of the competent authority the meeting of Course Design and Development Committee was held on 6th May, 2025 and recommended the course curriculum for the course on Management of International Business. It comprises four blocks with total 16 units. This course focused on the general operations of the</p>

	<p>international business in terms of the conceptual aspect, the global operations and the investment and international institutions aspects. The committee also recommended the names of experts for course writing and translation of same. The minutes of Course Design and Development Committee held on 6th May, 2025, alongwith the Course Curriculum and the list of experts for the Course Writers and Hindi Translators, were placed.</p> <p>Members suggested that the basics of foreign exchange in the international business should also be incorporated in the course curriculum. Prof. Nawal Kishor explained that the course is of 4 credits only and already having 16 units and adding further unit on foreign exchange will increase the load from the students' perspective. Prof. K. Ravi Sankar informed that this is a very basic elementary level course on international business, therefore, the detailed discussion of those things may be difficult.</p> <p>Prof. Nawal Kishor further explained that the conceptual aspect of economic, political, global operations and international financial institution will be touched including the foreign exchange.</p>

Sarkar, Course Coordinator, presented the item and informed the members of the School Board that as already explained by Prof. Nawal Kishor, the course BMP-004: Strategic Management is one of the five new courses in BBA Programme. This course will be offered in the 6th Semester from January 2026 session onwards. In this regard, a list of Experts for Course Design and Development Committee was duly approved by the School Board in its 52nd Meeting (52.24) held on 20th April, 2023.</p> <p>With the approval of the competent authority the meeting of Course Design and Development Committee was held on 20th May, 2025 and the committee recommended the course curriculum and the names of experts for course writers and translators for Hindi translations. The curriculum proposed is having 14 units divided into 4 blocks. The consent of the proposed course writers has already been obtained. The minutes of the Course Design and Development Committee held on 20th May, 2025, alongwith the Course Curriculum and the list of experts as Course Writers and Hindi Translators are placed.</p>

57.10 **To consider the proposal for renewal of MOU between the IGNOU and the Retailers Association of India (RAI).**

57.10.1 Director SOMS informed the members of the School Board that the proposed item is for consideration and approval for renewal of the MOU between the IGNOU and the Retailers Association of India. Under this MoU school launched the BBA Retailing in 2007 and its success story is continuing. He appreciated the initiators as well as the faculty members who are being monitored this program from time to time. Further, he informed that it is an industry linked program and all the students who have completed this programme got employed. Even now the industry is having lot of demand for the skilled and trained manpower.

Prof. Sunil Kumar, Programme Coordinator, presented the item and informed the members of the School Board that the IGNOU has entered into an MoU with the Retailers Association of India, Mumbai, on August 17, 2007, with an objective to develop and offer BBA (Retailing) programme. Subsequently, Diploma in Retailing

(DIR) programme was launched in the year 2008 and the BBA in Retailing programme was launched in July 2009.

BBA (Retailing) is a unique industrial exposed employment-oriented distance mode under graduate professional programme. Retailers Association of India provides 3 months internship to the BBA Retail Students which is the unique feature of this programme. RAI also provides sponsored candidates from retail sectors for pursuing the programmes. The industry linkages facilitate the skill development of the students and they are exposed to the retail working environment in the Retail sector. The exposure of the candidates to the retail industries makes this programme a unique university-industry linked professional programme. Retail sector is a prominent sector in Indian economy for the development of skills in the various operations in retail business. This programme serves the purpose of development of skills in the Retail sector by clubbing the theoretical knowledge and practical exposure by the way of Internship.

IGNOU and RAI have revised the Diploma in Retailing (DIR) and BBA (Retailing) (BBARL) programmes. The updated programmes are now titled Diploma in Retailing (DIRIL) and BBA in Retailing (BBARIL). As part of this revision, all Self Learning Materials (SLMs) have been thoroughly updated, and several new courses have been developed to align with current industry trends and requirements. The Diploma in Retailing (DIRIL) and BBA in Retailing (BBARIL) programmes have also been offered in Hindi medium from January 2024 admission cycle onwards, making them more accessible to a wider group of learners across the country.

IGNOU, in collaboration with the Retailers Association of India (RAI), has placed a strong emphasis on providing internship and placement opportunities for learners enrolled in the Diploma in Retailing (DIRIL) and BBA in Retailing (BBARIL) programmes. As part of this initiative, several leading retail brands are regularly invited to the IGNOU campus to offer internship and placement support, ensuring practical industry exposure and career advancement opportunities for the students.


The present MoU was signed between both the parties on 02nd March 2021 and the validity of the MoU was 60 months from the date of execution of MoU, which is going to lapse on 1st March 2026.

In view of the above and considering the time taking on further processes, Commerce Discipline has proposed for renewal of the MoU as mutually agreed by the IGNOU and the RAI for the validity periods of 60 months. This renewed MoU shall be effective from 02nd March 2026.
