The audit committee has also commented about the low enrolments of some SOPVA programmes (ODL). A learner registration data is collected from Student Registration Division which is self-explanatory. (Annexure 12-xv) Keeping in view it is proposed to consider and approve for keeping Certificate Programme in Visual Art-Sculpture (CVAS) in abeyance.
