Further to consider, approve and advice (if any) on the following remarks of the Research Committee for further necessary action:

"The members of the Doctoral Committee perused the details of the research work progress of each scholar. The Committee took serious note and showed their concern about non submission of two consecutive progress reports by Mr. Rishav Bhardwaj (127723353) and Ms. Shashi (127723360). As Dr. Seema Johari, Research Supervisor was not available for response, the members recommended that matter should be taken up with appropriate authorities for de-registration of these two scholars as per the University norms and accordingly inform Research Unit."

## **Recommendations:**

- a. The six-monthly reports submitted by the above Research Scholars, as recommended by the 6<sup>th</sup> Doctoral Committee, were approved by the 16<sup>th</sup> School Board.
- b. While considering the views expressed by the 6<sup>th</sup> Doctoral Committee, the members at the 16<sup>th</sup> School Board also viewed seriously the lapses on the part of the Research Scholars for none submission of mandatory Second year Fee and research progress Reports by Mr. Rishav Bharadwaj (127723353) and Ms. Preeti Kathuria (138000665). The members of School Board approved the recommendations of Doctoral Committee to Deregister these students from the PHDPVA programme and advised to take up the issue with concerned authorities for further necessary action.
- c. Further considering the views expressed by the 6<sup>th</sup> Doctoral Committee, the members serious noted of lapses on the part of the Research Scholars Ms. Shashi (127723360) for none submission of mandatory research progress Reports. The members of School Board approved the recommendations of Doctoral Committee to De-register the student from the PHDPVA (Music) programme and advised to take up the issue with concerned authorities for further necessary action.
- d. With regard to the absence of Dr. Seema Johari, Research Supervisor Music during consequent Doctoral Committee meetings, it was recommended that the concerned incumbent must be suitably advised to ensure such lapses do not recur as the quality of research cannot be compromised.

16.04.2 To approve up-gradation from JRF to SRF of Mr. Dinesh Yadav (127722638) a Ph. D. Student in Performing and Visual Arts (Theatre Arts)

16.04.3 To approve the Research Topic of Ms. Shashi, Ph. D student in Music (127723360).

**Recommendations**: The members were apprised that, as per the stipulated norms of IGNOU, a candidate registered for Research Programme has to get his/her Research Topic approved by the Doctoral Committee within six months of admission. Ms. Shashi had not submitted her Research Topic, even after two years of her registration and the Members not only viewed the candidate's lapse seriously but also felt the Research Supervisor must have been pro-active to ensure the candidate(s) registered under him/her does not get de-registered as it would not only reflect badly only the supervisor but also on the Research Programme Coordinator and the School as a whole. The School Board resolved that the recommendation cited under 16.04.1.c hold good in the matter.

16.04.4 To approve the Topic 'Theatre In-Education in Indian Scenario: A case study of NSD TIE Company' for M.Phil dissertation of Imran Raza (138000783) in Theatre Arts.

**Recommendations:** While considering the views expressed by the 6<sup>th</sup> Doctoral Committee, the members at the 16<sup>th</sup> Board of Studies meeting also viewed seriously the lapses on the part of the Research Scholars for none submission of mandatory Second year Fee and research progress Reports by Ms. Preeti Kathuria (138000665). The School Board resolved that the recommendation cited under 16.04.1.b hold good in the matter.

Bharadwaza, Director, SOPVA placed a concept note to initiate development of a Postgraduate Programme - MA in Performance Studies on the basis of the performance studies' being a multidisciplinary subject which includes Humanities, Art besides performance and such programme not offered on ODL mode by any institution.
		<b>Recommendations:</b> The members felt that the programme proposed is very broad in nature and not targeted to any aspiring professionals/clientele in the field of Performing Arts. However, it was suggested to re-think on the nomenclature of the programme as no Certificate or Diploma or Degree level programmes on 'Performance Studies' are offered by any institutions. While approving the proposal, it was also suggested to design the curriculum with sufficient care keeping in focus the skill & knowledge inputs, scope, employability, etc. and resolved the programme should be more specific and not generic in nature.
6	SOPVA-16.06	The Board of Studies were informed of a discussion held amongst the faculty members of the SOPVA with respect to the difficulties faced by the Programme Study Centres in offering support services to students, owing to low enrolment and on the light of this discussion, it was decided to place a proposal before the School Board to find the possibility of having a Model Study Centre at IGNOU Campus. It was also supplemented with another idea of the School to propose for a 'Single Window System' operation, which is currently adopted by the School of Tourism & Hospitality Services Management (SOTHSM). Further, the members were also informed that the SOPVA is having the required space and the services of faculty members, research scholars, already approved academic counsellors, approved experts, etc., can be taken to deliver the learner support services.  Recommendations: Keeping in focus the utmost and primary duty of any ODL
		system to deliver student support services to its learners, the School Board approved the proposal of the SOPVA to go ahead with the proposal of Model Study Centre in the university. It was suggested that the appropriate authorities be approached to ascertain the feasibility for such arrangements in IGNOU's Proviso.  SOPVA was suggested to ascertain the operational and other issues, related to the Single Window System, from the SOTHSM and prepare a road-map for

The School Board members were informed that IGNOU was earlier offering post-graduate programme in Hindustani Music, in face-to-face mode and due to certain reasons, it was discontinued. In the meantime, there were several queries from the students and other aspirants regarding the launch of a PG programme in Hindustani Music. Accordingly, an agenda was moved to propose initiating development of a P.G Programme in Hindustani Music: MA in Performing Arts – Hindustani Music. However, due to certain unavoidable reasons, the programme coordinator requested the School Board to defer the matter.  Recommendation: Matter deferred, as proposed.
8	SOPVA-16.08	The 12 <sup>th</sup> school Board in its meeting had approved the name of the Course writers
		(Theory) for Certificate Programme in Visual Arts – Painting (CVAP). The writing of theory materials was reported to be under development. Since, certain course writers had expressed their inability to develop the materials, additional names

	were proposed as course writers for theory courses of revised CVAP programme for approval of the School Board:
	<b>Recommendations:</b> While approving the additional names, the Board also suggested the following two experts in the field of Painting, whose services could be utilized:
	a. Dr. Sushma, Fine Arts, Maharishi Dayanand University, Rothak b. Dr. Meenakshmi Huda, Fine Arts, Maharishi Dayanand University, Rothak
SOPVA-16.09	As SOPVA is in the process of reviewing the syllabus of all the existing certificate programmes and developing other Diploma, Degree and Research programmes, a few names of experts were approved, in the 13 <sup>th</sup> School Board meeting, as content and language editors. Additional names of experts in the field of Painting were proposed for entrusting the activities of Content & Language editing for the Certificate in Visual Arts- Painting (CVAP), for approval of the School Board.
	<b>Recommendations</b> : While approving the names of additional names, the Board suggested the name of Ms. Raji Narasimhan whose services could be availed. Repetition of Dr. Shushmita Nandi at sl. 6 & 10 was pointed out for rectification. Further, it was also suggested to approach the School of Translation Studies, Humanities & Hindi Cell for identifying more experts for the task of language editing with a word of caution to ascertain if such identified experts are also familiar to Performance & Visual arts. It was resolved such identified names could be got approved by circulation, depending on the urgency.
SOPVA-16.10	As per recommendation of the 7 <sup>th</sup> School Board, revised syllabus of CPABN has been developed after review committee meetings held on 11 <sup>th</sup> Oct 2012 and 12 <sup>th</sup> Sep 2014. The minutes of the meeting with the revised programme structure and syllabus were placed for consideration and approval of the 16 <sup>th</sup> School Board. The Director – SOPVA, while explaining the reasons for revision, also informed the members about the reasons for reduction in credits, proposal for revision in fees based on the cost-analysis factor provided by Pⅅ, eligibility, etc.
	<b>Recommendation:</b> While approving the minutes of the review committee meeting, the Board of Studies resolved:
	<ul> <li>a. The eligibility for admission is proposed as a pass in 8<sup>th</sup> Standard after considering the nature of specialization the level of programme offered and the target audience. The members felt that this would hinder the candidate to move to the next level i.e., the Diploma and then to Degree, if he / she desires. It is also the general convention, both in IGNOU and outside, that the eligibility for Certificate Programme is a 10<sup>th</sup> Pass and the same may be followed in case of CPABN programme.</li> <li>b. Although the agenda was approved, in principle, a doubt arose among the members as to why the revision is being undertaken when there is hardly any enrolment for the CPABN. In this context, the School was suggested to think of a Diploma programme for Teachers teaching Dance in Schools at elementary and middle class levels, as it may attract reasonable enrolment. The School Board also felt, in general, that while revising the courses and launching them, the income generation from these programmes in the broader spectrum with more disciplines must also be considered.</li> </ul>

11	SOPVA-16.11	Subject to the approval of Minutes of the Review Committee meeting, at 16.10 above, additional names of the course writers as suggested by the Review Committee, was placed for approval by the School Board.
		<b>Recommendation</b> : The School Board approved the names of additional course writers. The name of another expert Ms. Nanda Eshwar, Mysore was suggested by a Board Member to be included and services utilized depending on the requirement.  The Board Members were of the opinion that the names proposed were undoubtedly experts in the field of Dance; however, the academics in the faculty of Dance from the University Departments must be considered to a larger extent in view of their close association with both teaching and performance with periodical updations in the knowledge & skills of Dance.

		<b>Recommendation</b> : The School Board approved the Phase -1 Form for developing the proposed undergraduate programme in Dance.

## Other Issues / suggestions:

During the course of discussion on the activities of SOPVA, in general and Research activities in particular, Prof. M.S. Rathore, Dept. of Visual Arts, Mohanlal Sukhadia University suggested that IGNOU and Mohanlal Sukhadia University, while praising the efforts of SOPVA and the availability experience & expertise proposed that Mohanlal Sukhadia University and SOPVA-IGNOU could jointly organize National Seminars on Research Methodology in the field of Performing & Visual Arts for the benefit of Research Scholars, as the requisite logistics are available with them. He felt that organization of such Seminars at the National Level will broaden the understanding of the quality Researches in Performing & Visual Arts. Since, SOPVA has methodology course is in its final stage of development, which is unique in nature as such kind of materials at the Research level is not developed by any institution in the field of Performing & Visual Arts, this suggestion was appreciated by all the School Board Members and the Director / Research Programme Coordinator was advised to initiate necessary steps for organizing the seminar in joint collaboration with Mohanlal Sukhadia University.

With respect to Dance, in the context of need to adapt to new developments in dance world and the entrusted unique mandate of SOPVA/IGNOU, it was suggested that the entire dance programme be re-envisioned afresh. It was also mentioned that efforts should be made to offer courses around specific 'styles with ample scope to branch out to areas that reflect the aspirations of young people in the field.

While apprehending on the relevance of courses offered by SOPVA, which are already offered by several institutions across the country, it was suggested to explore the possibilities of a course exclusively for Dance Teachers with specific reference to opportunities/employment available in schools - to enhance teaching skills of practitioners to deal with needs of school-based education system.

To a query on why only experts from Delhi, NCR & nearby places are preferred leaving other experts scattered across the country, the School Board members were informed that it was

mainly to get the task completed at the earliest with regular follow-up & interaction besides saving a huge amount that may have to be spent by way of TA/DA.

With regard to Bachelor Degree in Performing Arts – Dance, it was suggested that these courses needed to be overhauled and reframed with a new list of experts to ensure that all mechanisms are put in place to make courses in dance innovative and viable that attracts students.

The meeting concluded with a vote of thanks to all for sparing their time to attend the School Board meeting & provide valuable support & guidance.
