The Master of Arts (Drawing and Painting) programme has been launched in July 2021 session.

In this regard, it is submitted that UGC has notified the nomenclature of various degrees in 2014 through a gazette notification. (A copy is enclosed). The present programme of MADP (Master of Arts- Drawing and Painting) offered in IGNOU is not listed in the UGC Gazette notification. Further for the appointment teachers in Kendriya Vidyalaya Sanghatan and Navodaya Vidyalaya Sanghatan this degree is not considered because it is not a skill based programme. Hence it is proposed to rename the present degree of MADP (Masters of Arts-Drawing and Painting) as MFA-Painting (Master of Fine Arts-Painting).

It is also not out of place to mention that the other master's programme like Masters in Theatre Arts and Masters in Dance which are in pipe line are also designed according to the UGC nomenclature.
