Prof. Arvinder Kaur, School of Information and Communication, GGSIPU, Delhi and Prof.P.V. Suresh, Director, SOCIS, IGNOU could not attend the meeting.

At the outset, the Chairman of the School Board welcomed all the members to the 39th School Board meeting of the School of Vocational Education and Training (SOVET) and made a mention of the new members of the School Board Prof. Arvind Kumar, JNU, Prof. Sushila Madan, University of Delhi, Prof. Arvinder Kaur, GGSIPU, Prof. Vinay Swarup Mehrotra, Professor, PSSCIVE (NCERT) Bhopal and Dr. Rachna Mohan, University of Delhi appointed on the recommendations of the School Board and approved by competent authority. He expressed his gratitude to the member's especially the external members who helped the Board in shaping the academic endeavours of the School. He placed on record the valuable contribution made by the outgoing chairman Prof A K Gaba who completed his term as Director of the School on 24th June, 2022 and thanked him for his important contributions in the proceedings of the School Board, particularly during the visit of the team from National Assessment and Accreditation Council (NAAC) and launching of new programmes .

He apprised the members about the activities completed by the School since the last meeting of the School Board i.e. regarding launching of B.A (Vocational Education) MSME programme from July,2022 session; virtual counselling sessions through online/GY/GD (n=45), Google meet (n=10) recording of Video programmes (n-04) for SWAYAM, assignment evaluation and answer scripts by faculty, commencement of Ph D classes, development of new courses and editing of Units of MSCIS and MAER programmes. The chairman also apprised to the School Board that newly launched master-level and degree programmes of the school are doing very well. The school is also marketing these programmes through different mechanism including social network platforms.
