At the outset, the Vice-Chancellor briefly shared with the members the achievements and progress made by the University so far. 110 pointed out that there is a change in people's perception and attitude in the matters of potentialities and opportunities of distance mode of learning. He mentioned that the IGNOU is regarded as one of the ten premier institutions like IITs/IIMs as reported in a leading newspaper based on an objective survey. The emerging character of the University can be felt in terms of the positive response of the student population and of the Government towards distance education system. Today IGNOU is a major player in the education sector with student's enrolment over 5 Lakhs. The. continuing rise in enrolment is a pointer to the quality of education and services being provided by IGNOU. The recent launching of Gyan Darshan Educational TV Channel and Gyan Vani (Educational Radio) are the milestones heralding a new era in the field of distance education in India. Tlic current endeavours of the University have been directed to further improve in the area of delivery operations relating to study material and counselling and in particular for strengthening students' support service. ITEM NO. 3

TO REPORT ON "STANDING FINANCE COMMITTEE MEMORANDUM (SFC) FOR DD GYAN DARSHAN EDUCATIONAL TV CHANNEL AND GYAN VANI (EDUCATIONAL RADIO)".

PB 23.3.1

The Vice-Chancellor informed the members that launching of Gyan Darshan Educational TV Channel and Gyan Vani (Educational kadio) has marked the beginning of a new era in the use of information technology in the field of education. The involvement of a number of agencies like, UGC, Consortium of Educational Technology (CEC), MHRD, ISRO, NCERT, in this area of communication will particularly benefit the large number of students enrolled with IGNOU as also student community in India in general. The MHRD has entrusted the IGNOU with the task to act as nodal agency providing therewith a fund of Rs.7.5 Crores as budgetary requirement. Members were informed that DD Gyan Darshan Channel was inaugurated on January 26, 2000. The Vice-Chancellor envisaged that in future the State Open Universities will also become partners and NGOs will be involved so that entire scenario of the distance education programmes, communication and information technology use, the institutions involved in these areas can form what he has referred to as "Media Co-operative".

The Planning Board considered and ratified the Report on Project submitted to Department of Education, MHRD on Educational Development of North-East and Sikkini States. The Vice-Chancellor informed the members that keeping in view the objectives'of the University to reach out to the masses far and wide, the University had proposed for setting up of 3 Regional Centres, 25 Study Centres, 20 Multi Purpose Community Work Centres, 5 Mobile Study Centres and 01 Audio-Video Studio for the educational development of the North-Eastern States and the State of Sikkim. It was informed that the MHRD has released Rs.8.5 Crores as the first installment towards these Projects.

ITEM NO. 6

TO REPORT ON THE 11<sup>TH</sup> CONVOCATION HELD ON SATURDAY, MARCH 4, 2000.

Registrar informed the members regarding the holding of the 11th Convocation of the University on March 4, 2000. It was

informed that Prof. V.C. Kulandai Swamy, former Vice-Chancellor of IGNOU was awarded the degree of Doctor of Letters (Honoris Causa) by the University. It was also noted that more than 53,000 students had qualified in degrees/diplomas/certificates and more than 27,000 students were eligible to receive degrees/diplomas. The Convocation was telecast through tele-conferencing mode at 19 Regional Centres where 11<sup>th</sup> Convocation was held simultanelously.
