OFFICE MEMORANDUM

Subject: Post Graduate Diploma in Clinical Cardiology (PGDCC) – Reissue of Marksheet/Provisional Certificate and Diploma Certificates with new nomenclature with mandated conditions as directed by MoHFW/NMC.

With reference to the decision of the 84th meeting of the Academic Council vide item No.84.7.2 held on 30th May, 2025 for Post Graduate Diploma in Clinical Cardiology (PGDCC) Marksheet/Provisional Certificate, Diploma Certificate awarded by IGNOU during the period from 2006 to 2013 batches are being reissued as per the National Medical Commission (NMC) vide letter No.CDN-2011/39/2024-Coord-NMC (Part-1) dated 9th April, 2025. Accordingly, the University has reissued the Marksheet/Provisional Certificate, Diploma Certificates to the PGDCC Graduates from the period 2006 to 2013 batches, clearly reflecting the restrictions and conditions set forth in the MoHFW order dated 3rd February, 2025 and NMC (National Medical Commission) directives. These conditions include:

- a. The diploma holder shall now be designated as **“Clinical Cardio-Physician (Non-Invasive)”**.
- b. It is explicitly stated that the diploma holder is not permitted to perform any invasive cardiology procedures, including Transesophageal Echocardiography (TEE).
- c. Any investigations conducted by them (ECG, TMT, Echocardiography) that may warrant invasive intervention must be re-verified by a qualified cardiologist as per NMC regulations.
- d. These certificates should be duly stamped and endorsed by IGNOU in accordance with the Ministry's guidelines.

Therefore, the Post Graduate Diploma in Clinical Cardio-Physician (Non-Invasive) PGDCCP(NI) Marksheet/Provisional Certificate and Diploma Certificates are re-issued as per the direction of the National Medical Commission for those candidates who have successfully completed the Post Graduate Diploma in Clinical Cardiology (PGDCC) awarded by IGNOU ONLY during the period 2006 to 2013 batches.

Further, as per the direction of the National Medical Commission vide letters dated 10th March, 2025 and 9th April, 2025 for uploading the data of the verified list of PGDCC Graduate from the 2006 to 2013 batches, including their Indian Medical Register (IMR) number is placed on the Official website of IGNOU for Public reference and Transparency.

The first verified list of the students who had submitted the IMR Number has been attached for transparency & Public reference as per the NMC guidelines. The Marksheet/Provisional Certificate and Diploma Certificate of the Post Graduate Diploma in Clinical Cardiology (PGDCC) awarded by IGNOU prior to this Marksheet/Provisional Certificate/Diploma during the period from 2006 to 2013 batches shall be considered null and void.
