- 4 A renewable energy company wants to social audit its local environmental and employment impacts. Explain why this social audit is necessary. Outline a step-by-step action plan for conducting the audit for this specific programme.
- 5 How is Social Return on Investment (SROI) measured for CSR programmes? Develop a hypothetical framework to measure the SROI for a women's entrepreneurship training project.
