Reply: As far as IGNOU is concerned, the University offers academic programmes through Open and Distance Learning (ODL) mode. It promotes the unconventional or non-traditional system of education unlike traditional classroom based education. It provides education to millions of people by providing self learning materials and freedom to learners to study at their own pace and place, offering flexibility in entry and exit and choice of courses.

- 1. The University has adopted the UGC Guidelines for Multiple Entry and Exit in Academic Programmes offered in HEIs and also notified the modalities for facilitating students in multiple entry and exit (24th August, 2022).
- 2. The learner has the freedom to choose courses from the flexible curricular structures across disciplines (Academic Year 2021-2022 onwards). For example, learners of B.Sc. are provided with an option to choose Courses from multiple disciplines *viz*. Anthropology, Economics, Psychology, Indian and Foreign languages, Gender Studies, Commerce, Agriculture, Fashion Design; Environmental Studies, etc.
- 3. The University has registered on the ABC Portal. ABC IDs for over 20 lakh IGNOU students have been created. The students are encouraged to avail the transfer of credits available in the ABC. For example, the University offers Course-wise Registration and Certification and the credits earned are accumulated in the ABC.
- 4. The University has digitized the Self Learning Materials (SLMs) of all the programmes which are available to the learners on its web based repository: e-Gyankosh.
- 5. There are 4711 audio and 6007 video programmes of various disciplines and subjects available on YouTube (e-Gyankosh) for the convenient viewing of learners and the public at large.
- 6. IGNOU is one of the national coordinators for SWAYAMPRABHA, and is running four channels.
- 7. IGNOU is the National Coordinator of SWAYAM and is currently offering 221 massive open online courses (MOOCs) in different disciplines on the SWAYAM platform.
- 8. IGNOU has its own dedicated GyanDarshan education TV Channel which telecasts educational programmes and conducts live teleconferencing sessions. GyanDarshan conducts two hours of live sessions every day in interactive mode to build interactivity in the teaching-learning process. There is a dedicated FM radio channel GyanVani which broadcast programmes for 12 hours a day. Interactive Radio Counselling (IRC) facilities are provided through GyanVani stations to enable students (across the country/overseas) to interact with the Faculty, Academic counsellors and Student Support Staff. GyanDhara, an web-based counselling service is offered by IGNOU to internet users across the globe. Learners can interact with the teachers and experts through telephone, email and chat mode.

9. IGNOU is providing online counselling to its learners through various e platforms including IGNOU LMS.
