Minutes of the Thirty-Third **Meeting** of the Academic Programme Committee, **IGNOU** held on **12th** December 2007 at 10.30 a.m. In the Conference Room, Block-8, **IGNOU** Campus, New **Delhi** – 110 **068**.

Prof. V.N. Rajasekharan Pillai, Vice Chancellor could not attend the meeting. Shri Pankaj Khanna, Dy. Director, **P&DD** was present to assist Member Secretary.

At the outset, the Member Secretary **informed** the Committee that Vice Chancellor had some engagement around the same time and therefore requested Prof. Omprakash Mishra to kindly chair the meeting as authorized by the Vice Chancellor. Prof. Mishra chaired the meeting and requested Member Secretary to present the agenda items.

- AP.C. 33.1 To **confirm** the minutes of the 32nd **meeting** of the Academic Programme **Committee** held on 16th August 2007 and the Action Taken Report (ATR) from SOH and SOET
- A.P.C. **33.1.1** Dr. C.G. Naidu apprised the members that the minutes of the **32nd** meeting of **APC** were circulated to the members and respective Schools and Discipline Coordinators. No comments on the minutes received. The minutes may be approved.
- A.P.C. 33.1.2 The Committee noted action taken reports (ATR) of PG Certificate programme in Malyalam Hindi Translation, PG Certificate programme in Bangla Hindi Translation and Certificate Programme in Japanese Language. The ATR regarding the launch of Diploma in Civil Engineering (General) from January 2008 was also noted.

- AP.C. **33.1.3** . The Minutes of the 32nd APC were **confirmed** as circulated and the **committee noted** the above **action** taken reports.
- A.P.C. 33.2 To **consider** the Phase 2: (Programme Concept Form) of **Certificate** In Water **Harvesting** and Management

The Committee appreciated the idea of Region specific need based programmes and informed that the Academic programmes have to be developed and launched from the schools as per statutory requirement of the IGNOU Act and Statutes. The Committee further deliberated that concerned school should also study the impact and applicability of programme in other regions of the country while launching region specific programmes.

The Committee after going through the programme details observed that the counseling and practical component duration may be enhanced in consultation with experts and programme delivery cost is also required to be worked out as per IGNOU worksheet by the programme co-ordinator.

- A.P.C. **33.2.2** The Committee took note of the deliberations and approved the **Phase-2 (Programme** Concept Form) of Certificate in Water **Harvesting** and Management.
- AP.C. 33.3 To consider the **Phase-2** (Programme Concept Form) of **Revision** of **Diploma** In Early Childhood Care and **Education**
- AP.C. 33.3.1 The concerned Programme Co-ordinators (Dr. Neerja Chadha and Dr. Rekha S. Sen) explained the structure of the programme and informed the committee that there is a major revision in the content, duration and cost of the programme. The revision of the syllabus has been done in accordance with the programme of Early Childhood Care and Education run by SCERT and guidelines laid down by NCTE.

The Committee after going through the programme revision details and its proposed recognition from NCTE was of the opinion that programme coordinators should take all necessary initiatives to get the programme recognized by NCTE after its revision. On the query of Dr. Srikant Mohapatra regarding 64 credit Diploma programme, programme coordinators informed that the credits has been devised as per NCTE requirements and the duration of the programme is two years. Prof. Aslam further informed the committee that various similar or higher credit PG Diploma Diploma programmes are already on offer in the university. The Committee concurred to the information provided by Pmf. Aslam and Programme Coordinators.

The Committee informed the Programme Coordinators to devise a mechanism of credit transfer from existing one year Diploma holders to get enrolment in the revised 2-year Diploma programme. The duration of practical component may also be enhanced in consultation with the experts.

- AP.C. **33.3.2** The Committee took note of the revised content, **duration** and cost **of** the programme and approved 'the Phase-2 (Programme Concept Form) of Revision of Diploma in Early Childhood Care and Education.
- A.P.C. **33.4** To consider the Phase 2 (Programme Concept Form) of Awareness Certificate and Diploma Programmes in Handmade Paper **Items**
- A.P.C. 33.4.1 Dr. (Ms.) Vardhini Bhattacharya. Regional Director, Guwahati Regional Centre, Dr. M.C. Nair and Dr. (Ms.) J. Kurup informed the salient features of the need based programme designed for the North-East region. The structure of the modular Awareness, Certificate and Diploma programmes was also explained with the proposed target groups. The Committee appreciated environmental friendly and application of indigenous technology based programme for the North East Region.

The Committee after going through the complete details observed that Awareness programme (Non-Credit) may be offered by using various multimedia technologies leaflets so that it can be made available to illiterate and larger section of the society. The class 7" eligibility requirement for awareness programme may also be eased.

The Committee again deliberated over the Region-based programmes as it has been done in the item no. 33.2.1

regarding applicability in other regions of the country. The Committee **directed** the programme **co-ordinators** to identify a **school** (School of **Vocational** Education and Training or School of Extension and Development Studies) for launching Certificate and Diploma Programmes. Prof. Kapoor stated that collaborative arrangements may also **be** worked-upon **within** these two schools for the programme as per area of expertlse of the School. Committee informed the Programme **Coordinators** that the **Phase-1(Programme** Proposal Form) of the **Certificate** and Diploma Programmes may be placed in the School Board of the identified **School(s)**. The APC may dedde on Certificate and Diploma programmes after School Board approval.

The Programme Coordinator was directed to work-out costing of the programme as per prescribed worksheet for the programmes.

- A.P.C. **33.4.2** The Committee took note of the above deliberations and relevance of the programme for North-East Region approved the Phase-2 (Programme Concept Form) of Awareness Programme in Handmade Paper Items.
- A.P.C. **33.5** To consider **the** Phase 2: (Programme Concept Form) of Awareness, **Certificate** and **Diploma** Programmes In **Interior** Decoration
- A.P.C. **33.5.1** The programme is similar to the **tem** No. 33.4 in content and nature.
- AP.C. **33.5.2** The Committee took note of the deliberations and approved the **Phase-2** (Programme Concept Form) Awareness Programme in interior Decoration.
- AP.C. **33.6** To consider the Phase 2 (Programme Concept Form) of Post Graduate **Diploma** In **Computational Chemistry**
- AP.C. 33.6.1 Prof Sunita Malhotra explained the modular structure of the PG Diploma programme comprising of two Certificate programmes as well, namely, PG Certificate Programme in Computational Chemistry (16 Credits) and PG Certificate Programme in Applications of Computational Chemistry (16 credits). She informed that the programme is being developed in collaboration with IIITMK and is a Portal (Internet) based having continuous interaction with learners through web-based materials. Presently, no programme of

this type is on offer by any of the universities/institutions. The aim is to enroll at the first instance 100 students on a pilot basis and after stabilization of the programme with these numbers, it would be offered to a larger number of students.

The Committee after going through the complete details observed the programme objectives required to be made comprehensible and the programme delivery cost is to be worked as per **IGNOU** worksheet in consultation with **IIITMK** by the programme **co-ordinator**.

- A.P.C. **33.6.2** The Committee took note of the salient features of the programme approved the Phase9 (Programme Concept Form) of PG Certificate in Computational Chemistry, PG Certificate in Applications in Computational Chemistry and Post Graduate Diploma in Computational Chemistry.
- AP.C. 33.7 To **Inform** the approval of Phase 4 (Programme Launch Approval Form) of **M.Sc.** (Mathematics with applications in Computer Science) by Planning Board in **its 33rd** meeting.
- A.P.C. 33.7.1 The Committee noted the approval of Phase 4 (Programme Launch Approval Form) of M.Sc.(Mathematics with applications in Computer Science) by Planning Board in its 33rd meeting held on 17th September 2007.
- AP.C. 33.8 To consider the Phase 2 (Programme Concept Form) of Diploma in Legal **Literacy.**
- AP.C.33.8.1 Prof. Srikrishna Deva Rao briefly informed the **course** development history and relevance of legal iiteracy. Mr. **Anand** Gupta explained the modular structure of the programme proposed to be further developed into **B.A.(Law)**. Further to it, Ms. Jayashree, Consultant informed about the **curriculum** of the programme which would be made available and launched through 20 Programme Centres.

The Committee after going through the complete details of the programme deliberated over the Law as a subject and Law as a practice. It was informed that it needs to be clearly distinguished between these two aspects before the B.A. (Law) programme is finalized. Further, BA (Law) programme may be deliberated over again by the School Board for its recognition by the Bar Council of India.

AP.C. 33.8.2 The Committee, took note of the deliberations and approved the Phase-2 (Programme Concept Form) of Diploma in Legal Literacy.

- AP.C. **33.9** To consider the **Phase** 2: (Programme Concept Form) of MA In **Mass** Communication
- AP.C. **33.9.1** Dr. Kiron **Bansal** explained the salient features of **the** programme **and** informed that the School of Journalism and New Media Studles accepted the relocation of the programme **from** the School of continuing Education in its 1st Meeting held on 7th December 2007.

The Committee after going through the complete details **observed** that **the** telecast time for the programme is required to be enhanced and a proper planning for conducting **practical** training with Doordarshan. Prasar **Bharti** and other institutes **is** required to be worked-out by the Programmd Co-ordinator.

Dr. Sdkant Mohapatra, Registrar, SRED, raised concerns over the credit transfer from existing PGJMC and PGDAPP students **opting** for the programme in future after its launch. The Committee directed the programme coordinator to workout a proper credit transfer plan in advance from these **two** courses so that any ambiguity can be avoided.

The Committee deliberated over the programme name and directed the programme coordinator to re-examine the programme name for adding the word Journalism as it has been done in **Phase-I** form of the programme to have a wider reach.

- Dr. C.K.Ghosh, Director, RSD, raised concerns wer availability of list of partner institutions and counsellors for practical components in Regional centers. The Committee directed the programme coordinator to make available in advance the complete details of institutions and counsellors in Regional Centres for trouble free operation of the programme.
- A.P.C. **33.9.2** Committee took note of the deliberations and programme objectives and approved the Phase-2 (Programme Concept Form) for M.A. in Mass Communication.

- AP.C. 33.10 To consider the Phase-2 (Programme Concept Form) of Post Graduate **Diploma** In **Teaching** and Research In Management
- A.P.C. 33.10.1 Prof. N.V. Narasimham, Director, **SOMS**, explained that **PGDTRM** is proposed by **IGNOU** Regional Centre, Cochin and is being developed in collaboration with Prof. M.V. **Paylee** and Kerala Management Association. He presented the salient features **of** the programme and **informed** that it is a capacity building programme in management for management graduates and professionals.

The Committee deliberated over the Region-based programmes as it has been done in the item no. 33.2.1 regarding region specific programmes and applicability in other regions of the country. Further, School Board may work out its relevance for other regions for its launch if sufficient audience is available for the programme.

The Committee after going through the complete details suggested that teachers may also be included in the eligibility **criteria**.

Dr. Srikant Mohapatra raised **concerns** over the attendance in counseling session to be made compulsory for the evaluation scheme of **PGDTRM-07** and **PGDTRM-08** courses. The Committee informed the Programme Coordinator to re-work on the mandatory attendance and inform the School Board in its next Meeting.

- AP.C. **33.10.2** The Committee took note of the deliberations and approved the Phase 2 (Programme Concept Form) of Post Graduate Diploma in Teaching and Research in Management.
- AP.C. **33.11** To consider the Phase-2 (Programme Concept Form) of PG **Diploma** in Acupuncture
- AP.C. 33.11.1 Prof. S.B. **Arora briefed** the committee about structure and collaborative arrangements envisaged with Institute of Accupunture and Natural Medicines (IANM) for proposed PG Diploma in Accupunture.

Prof. **Parvin** Sinclair expressed **concern** over the availability of credible practitioners and institutes for programme centres. Also, we need to ensure the credibility of **IANM** for having collaborative arrangements.

The Committee after going through the complete details and

deliberations informed the programme coordinator to submit the details of credentials and network of the **IANM** with collaborative arrangements envisaged in the next APC meeting for taking • decision on the proposed programme.

- **A.P.C. 33.11.2** The Committee in view of the above deliberations deferred the approval of the Phase 2 (Programme Concept Form) of PG Diploma in Acupuncture and asked the Programme Coordinator to place it again in the APC along-with the details of **IANM** and availability of programme centers in other parts of the country.
- AP.C. 33.12 To consider **the** Phase-2 (Programme Concept Form) of Certificate **in** Early Childhood **Special** Education **(specializations** In Mental Retardation, **Visual** Impairment, Hearing impairment and Cerebral Palsy)
- A.P.C. **33.12.1** The Programme Coordinators (Dr. **Neerja** Chadha and Dr. Rekha Sen) **briefly** explained the history, structure, and the four areas of disability in each of the Certificate Programmes will be developed with broad objectives to facilitate parents and teachers to foster the children's package of children with disabilities for their all-round development. It was informed that **Awareness-cum-training** packages in disability (Mental Retardation, **Visual** Impalrment, Hearing Impairment and Cerebral Palsy) are already **on** offer in a **non-credit** mode in the university. Proposed new programmes are credit-based **Certificate** programmes and are being developed in collaboration **with** Rehabilitation Council of India (RCI).

The Committee after going through the complete details raised concern over the minimum 10th class eligibility requirement, delay in launching since 1998 and subsidy part for proposed fee.

The programme coordinators explained that the minimum 10th class **eligibility requirement** is laid down by RCI as a **certifying** authority in-order to get registration as 'personnel' **after** successful completion of the programme. After deliberations, Programme Co-ordinators assured that for students not having 10th Class qualification. BPP criteria for 8th pass students would be integrated as eligibility criteria in the programme. On the delay part, programme coordinators submitted that in the First Phase RCI have given approval to launch Awareness-cum-TrainIng programmes in the noncredit mode. After a positive feedback on implementation of these Awareness packages at the field level, the RCI have recently granted permission to launch these packages in the

credit mode with suitable **up-gradation**, in its meeting held on **23rd** August **2007**. Subsequently, to which the work to upgrade the programmes to Certificate level was initiated by the School, which is being the reason for delay. The Committee deliberated over the subsidy in fees and informed the programme-coordinators to put up a separate note regarding cost of delivery with justification for subsidy before the authorities of **IGNOU** and RCI to take decisions **collaboratively**.

A.P.C. 33.12.2 The Committee took note of the social relevance of the programmes and approved the Phase - 2 (Programme Concept Form) of **Certificate** Programme in Early Childhood Special Education (specializations in Mental Retardation, Visual Impairment, Hearing Impairment & Cerebral Palsy)

The meeting ended with a vote of thanks to the Chair.
