At the outset, Chairman welcomed all the members. He placed on record appreciation to the former member Prof. Udai Pratap Singh, Former Professor, BHU (Member, Planning Board).

A.P.C. 39.1 To confirm the minutes of the 38th meeting of the Academic Programme Committee held on November 11,2010 and the Action Taken Report(s) (ATRs).

- A.P.C. 39.1.1 Prof. A.K. Jha, Director, P&DD apprised the members that the minutes of the 38th meeting of APC were circulated to the members. Comments on the minutes were received from Prof. Parvin Sinclair, Pro-Vice-Chancellor, Member, APC vide letter placed at Annexure 1/8. Member has suggested changing the word 'deferred' to 'withdrawn' in the items listed in the minutes at APC 38.13.1 and APC 38.14.1. In view of these comments on the 38th APC minutes from the member, the committee may consider it and 63 such. the minutes might be approved.
- The Committee noted following Action Taken Reports (ATRs) of School of A.P.C. 39.1.2 Vocational Education and Training (SOVET) for Certificate in Cosmetology, Certificate in Jewellery Designing and Post Graduate Diploma in Fire Safety & Disaster Management programmes.
- The Academic Programme Committee noted the action taken reports and A.P.C. 39.1.3 confirmed the minutes of the 38th APC meeting with changes mentioned above by the member.

- A.P.C. 39.2 To consider the Phase-4 (Programme Launch Approval Form) of B. **Tech** in Aircraft Technology & Maintenance.
- A.P.C. 39.2.1 Dr. B.S. Sudhindra, programme coordinator briefed the members about B.Tech. in Aircraft Technology & Maintenance. He informed that the programme will be launched at Bangalore with limited number of seats on full time basis in face to face mode. Programme coordinator also circulated printed programme details in the meeting and submitted details about the readiness of course material for the 1st year of the programme.
- A.P.C. 39.2.2 On the query whether the teachers appointed for this full time programme has the approval of respective School Board, to which programme coordinator informed that the same is yet to be sought from the respective authorities.
- A.P.C. 39.2.3 The Committee **after going** through the complete details deliberated over the programme and suggested that the process of **appointing** teachers may he routed through the School Board of SOET. Further, an advisory committee to review the readiness of the **B.Tech**. programme was constituted as follows:

- A.P.C. 39.3.1 Dr. M.V. Lakshmi Reddy, programme coordinator informed that the Post Graduate Certificate and Master of Art in Adult Education (Item No 39.4) will be launched by the school in the ycar July. 2011. He briefed about the readiness of the programmes, the status of study material preparedness for the 1st and 2nd year of the programmes to be offered in English language initially and later on in other languages.

A.P.C. 39.5.2	The Committee took note of the launch and approved the Phase-4 form of (i) Post Graduate Diploma in Extension and Development Studies and (iij M.A. in Extension and Development Studies.
A.P.C. 39.6	To consider the Phase-4 (Programme Launch Approval Form) of Post Graduate Diploma in Food Technology.
A.P.C. 39.6.1	Prof. M.K. Salooja, on behalf of Dr. K.S.D. Nair, programme coordinator informed that the Post Graduate Diploma in Food Technology has already been launched by the School in Face to Face mode in January, 2010 in collaboration with MACFAST in English language.
A.P.C. 39.6.2	The Committee deliberated over the launch and suggested to launch the programme in distance learning mode with the requisite self learning material to be prepared in consultation with respective experts and School Board at the earliest.
A.P.C. 39.6.3	The Committee took note of the launch and above deliberations approved Phase-4 form of Post Graduate Diploma in Food Technology.
A.P.C. 39.7	To consider the Phase-4 (Programme Launch Approval Form) of M.A. (Gandhi and Peace Studies).
A.P.C. 39.7.1	Prof. D. Gopal, programme coordinator informed that the M.A. (Gandhi and Peace Studies) was developed in collaboration with International Centre for Gandhian and Peace Research. These will be offered only in English language and subsequently in Hindi. The modular programme courses have been developed in collaboration with NCRI (National Council of Rural Institutes) and presently a good response has been received from a number of Universities located in different parts of the country. Further, NCRI scholarships are also being worked out and about 8-RTAs are already working in this area.

- A.P.C. **39.7.2** The Committee after going through the details suggested launching the programmes abroad also after due consultation with International Division. The Hindi translation of the programme may also be completed at the earliest.
- A.P.C. **39.7.3** The Committee after deliberations over the detailed information. collaboration, scholarship details as informed by the programme coordinator: suggested that a self contained note or brief about the programme may be submitted by the concerned School / programme coordinator in future **along** with Phase-4 forms for information **of the** APC.

- A.P.C. **35.8.1** Prof. **Subhasis** Maji, programme coordinator along with Shri Sandeep Bhatia of FDDI informed that all the above programmes have already been launched by the School in September, **2010.** The programmes are being offered in collaboration with FDDI (Ministry of Commerce & Industry) set up by the Ministry of Commerce, Government of India in the year **1986** with an objective to provide human resource and technical services to the industry. These programmes being offered in the area of cutting, closing, lasting & finishing footwear. As on date, FDDI campuses, where these programmes are on offer are equipped with modem facilities and latest technology and with an International Testing Centre established in collaboration with PFI Learning. Further, FDDI for all its programmes in the past has a record of **100%** placements of all its graduates.
- A.P.C. **36.8.2** The Committee **after** going through the details suggested to the programme coordinator to explore ways for launching these flagship programmes in distance mode, to which programme coordinator submitted that these are laboratory intensive programmes and it would not be possible to launch these in distance learning mode.
- A.P.C. **39.83** The Committee took note of the launch and approved the Phase-4 (Programme Launch Approval Form) of

A.P.C. 39.9 To consider the Phase-4 (Programme Launch Approval Form) of Diploma in Lifelong Learning.

- A.P.C. 39.9.1 Dr. M.C. Nair, programme coordinator explained the readiness of the programme and July 2011 as its launch date.
- A.P.C. 39.9.2 The Committee **after** going through the details, raised its concerns over the delay in launch of the programme as there is a **gap** of about three years since the approval of Phase–I, II and III forms.
- A.P.C. 39.9.3 -The Chairman after detailed deliberations over the delay expressed his concerns on the delay in launch of the programme. He while raising questions about financial viability of academic programmes suggested that cost benefit analysis may be done for programmes with low enrolment of the University by the concerned programme coordinator in consultation with respective school and divisions. This cost benefit analysis may consist of expenditure spent on administrative, human resources etc. and income generated by the respective programme.
- A.P.C. **39.9.4** The Committee took note of the readiness and above deliberations approved the Phase-4 Form of Diploma in Lifelong Learning.

A.P.C. 39.10 To consider the Phase- 4 (Programme Launch Approval Form) of Certificate in Handmade Paper Items.

- A.P.C.39.10.1 Dr. M.C. Nair, programme coordinator explained the readiness of the programme which will be launched by the Centre in July, 2011. He informed that study material of the programme is ready and the study centers have been identified. The programme has been developed in coordination with EDNERU for the North East region of the country.
- A.P.C. **39.10.2** The Committee took note of the readiness and approved the Phase-4 Form of Certificate in Handmade Paper Items.

A.P.C. 39.11 To consider the Phase- 4 (Programme Launch Approval Form) of Certificate in Telecentre/Village Knowledge Centre Management.


- A.P.C. 39.11.1 Dr. M.C. Nair, programme coordinator explained that the programme has already been launched by the Centre in January, 2011 in collaboration with The International Development Research Centre (IDRC). He informed that about 150 enrolments have been registered in the programme. The study learning material is also being translated into Hindi, Malayalam and Bengali languages.
- A.P.C. 39.11.2 The Committee raised its concerns over the low enrolment; to which, the programme coordinator informed that in order to boost the enrolment; scholarships for students from rural area is being worked out with IDRC.

A.P.C. **39.11.3** The Committee took note of the launch and approved the Phase-4 Form of Certificate in **Telecentre/Village** Knowledge Centre Management.

A.P.C. **39.12** To consider the **Phase- 4** (Programme Launch Approval Form) of Post Graduate Diploma in **Social** Work among Tribals.

- A.P.C. **39.12.1** Dr. Rose Nembiakkin, programme coordinator explained that the programme will be launched by **the** School in July, 2011. The course materials are read) and these are being sent to the printing press. The programme will be offered in English language at existing MSW programme centres and with same counsellors. She informed that collaboration is also being worked with Ministry of Development of North Eastern Region (DONER) for the programme.
- A.P.C. **39.12.2** The committee **after** going through the details, suggested collaborating for launching this programme with Mahatma Gandhi Institute of Education and Development, IGNOU-NGA Complex at Chuchuyimlang village, Nagaland.
- A.P.C. **39.12.3** The Committee took note of the readiness and approved the Phase-4 Form of Post Graduate Diploma in Social Work among Tribals.
- A.P.C. **39.13** To consider the **Phase- 4** (Programme Launch Approval Form) of Post Graduate Diploma in Pre Primary Teacher Education.
- A.P.C. **39.13.1** Dr. Vandana Singh, programme coordinator explained that the programme was developed in collaboration with Regional Centre, Cochin and will be launched in July, 2011. The eligibility for the programme graduate (any stream) without any work experience has been prescribed as the admission criteria. The study materials are almost ready and format editing / language editing has already been completed. Separate study centres have also been worked out for the programme.
- A.P.C. **39.13.2** On the query raised by the members whether NCTE approval has been taken for the programme, the programme coordinator submitted that as on date NCTE does not have any norms for this type of programme. Further. NCTE representative was an expert member during the development of the programme. As on date, NCTE or its representative in the expert committee have not raised any concerns over the development and launch of the said programme.
 - A.P.C. **39.13.3** The Committee took note of the readiness and above deliberations approved the Phase-4 Form of Post Graduate Diploma in Pre Primary Teacher Education.

- A.P.C. **39.19** To consider the Phase-4 (Programme Launch Approval Form) of Post Doctoral Certificate id Dialysis Medicine.
- A.P.C. **39.19.1** Prof. T.K. Jena, Programme Coordinator explained the readiness of the programme and July 2011 as its launch date. The self learning materials are almost ready and about 15 study centres have **been** notified. He informed that the programme has been funded by Ministry of ilealth and Family Welfare.
- A.P.C. **39.19.2** The Committee took note of the readiness and approved the Phase-4 form of Post Doctoral Certificate in Dialysis Medicine.
- A.P.C. **39.20** To consider **the** Phase-4 (Programme Launch Approval Form) of Post Graduate Diploma in **HIV** Medicine.
