Dr. Sunil Kumar and Dr. Pankaj Khanna were present to provide the academic support.

At the outset, the Member Secretary welcomed the Chairperson, Member(s), and Special Invitee(s) to the 51<sup>st</sup> meeting of the Planning Board (PB) and requested the Chair for opening remarks.

The Vice Chancellor and Chairperson of the Planning Board Prof. Uma Kanjilal welcomed and introduced Prof. Rajendra Prasad Das, Prof. Venkata Ramana, Prof. Saroj Sharma, Sh. Biswa Ketan Das, Prof. Jeetendra Pande, Prof. Neera Kapoor, Prof. Parmod Kumar, Prof. Nehal A. Farooquee and Dr. Amit Chaturvedi as new members of the Planning Board and felicitated the new external members. The Chairperson also placed on records the valuable contribution by outgoing members Dr. Sujata K. Dass, Prof. V. Venkaiah, Dr. D. Subrahmanyam, Prof. Kailash Sodani, Prof. Rama Shanker Dubey, Prof. Nita Mathur, Prof. S.R. Jha, Prof. Nawal Kishor and Dr. U.C. Pandey.

She also placed on records the valuable contribution of Prof. Nageswara Rao as the Vice Chancellor and Chairperson of the Planning Board. The initiatives under his tenure has taken the university to new heights and some of the major achievements during his tenure are highlighted below:

- NAAC A++ accreditation to the University in 2021;
- Exemption from the UGC regulations for ODL and online programmes;
- Signing of around 125 MoUs including the MoUs/MoAs with international institutions and some renewals;
- 22 modules of SAMARTH made active;
- Online registrations opened from January 2020;
- Over 200 new ODL programmes launched;







- The tally of online programmes increased from 3 in 2020 to 44 in 2024 and IGNOU
  has been one of the major contributor in the category of the online programmes;
- MOOCS on SWAYAM platform increased from 11 to 291;
- The fresh registration increased from 6,53,056 in 2017-18 to 7,53,181 in 2023-24;
- During Covid pandemic the tally of SWAYAM courses increased to over 300 courses and around 126 institutions like IIM's, IIT's and other Central Universities adopted IGNOU's SWAYAM courses;
- ABC started wherein the internal as well as external students can register providing them the flexibility of credit transfer;
- Channel Based Counselling in regional languages started and around 7000 counselling sessions have already been recorded;
- Around 2,50,25,625 license fee recovered from 2 Open Universities for using IGNOU's study material;
- Enrolment of International students increased from over 400 to around 4900;
- Online programmes started for 21 African countries and Afghanistan under e-Vidyabharti and e-Arogyabharti (e-VBAB) a project of Ministry of External Affairs, GOI:
- Three month online basic Hindi Awareness programme for Foreign nationals was started in 9 countries in collaboration with ICCR and CHD;
- MoAs with 14 countries to act as facilitators for promoting online programmes of the University in their region;
- Automation in examination system introduced which includes online question paper delivery system;
- Innovation and Research activities fostered during his tenure;
- 5 distinct MBAs duly approved by AICTE were launched;
- Mobile app was started for the students and till date around 25 lakh downloads have taken place;
- GOAL Guyana collaboration for offer of ODL and online programmes under Government of Guyana Scholarship Schemes.

Prof. Nageshwar Rao took significant step towards translating programmes in regional languages, as a move to make higher education more accessible in Indian languages and mother tongue. IGNOU has collaborated with AICTE to translate MBA courses in12 Indian languages. The Chairperson informed the house that the translation work in Hindi and Odiya has been completed. She also informed that during his tenure IGNOU in alignment with the National Education Policy, 2020, not only promoted Indian languages, arts, and culture but also provided stand-alone courses in Kashmiri, Nepali, and Meitei Lon (Manipuri).

The University offers a diverse range of undergraduate courses in various Indian languages. IGNOU has introduced live online classes in 13 Indian languages through Six SWAYAM PRABHA TV Channels, catering to learners in their mother tongue. The students were given option to go for digital material. As of now more than 23% Students have adopted the university's e-course material with 15% discount in the programme fee since 2019. During his tenure 23 undergraduate programmes were offered under the FYUP framework in the Multi-disciplinary, Major categories which will further contribute to the GER in Higher Education.

The University has forged partnerships with prominent organizations like NSDC and NCVET to offer skill-based certificates and degrees. Additionally, collaborative efforts with DTNBWED and the Ministry of Skill Development aim to enhance skill development and vocational education during his tenure. His contribution towards providing access, quality, equity and affordabilty and fostering incusivity is highly acknowledged.


The Chairperson placed on records the recent developments in the University which are as follows:

- The University has enrolled 5.33 lakh new learners in the July 2024 admission cycle, which is about 4.5% higher than the enrolment in July 2023. In addition, 4.16 lakh learners of UG/PG Programmes have re-registered in their next semester/year in the July 2024 session, taking the total student load in July 2024 to 9.49 lakh.
- Around 9600 learners have enrolled in the 44 Online Programmes offered.
- As many as 161 learners have availed the Lateral Entry facility to enroll directly in the second year of the PG Programmes in the July 2024 session.
- In fresh admission, female participation has reached 54.07%, the highest so far.
- The participation of SC and ST is 18.5 %. The participation of all the disadvantaged groups put together (SC, ST, OBC, EWS) is as high as 62.49%.
- Rural participation has reached 56.48%.
- About 25% of the learners enrolled in July 2024 have opted for digital study material in place of printed material. Earlier this figure was around 20%.
- In July 2024, the contribution of UG and PG Programmes is 83.1%. Diploma and Certificate programmes have contributed the remaining 16.9% (PG Diploma+Diploma – 13.35%, Certificate – 3.55%)
- The University has launched 5 specially designed skill-based Bachelor Degree
  Programmes for the Agniveers of the Defense Forces. In July 2024, 2788 Agniveers
  from the Indian Air Force have enrolled in these programmes. From January 2025,
  the Agniveers of the Indian Navy shall also be enrolling in these Programmes.
- The University is offering a specially designed Certificate Programme to the teachers of Navodaya Vidyalaya Samiti (NVS) for building their competencies, since July 2022 admission cycle. In July 2024, 1022 teachers of NVS have enrolled in the Programme.
- The University is actively participating in the E-Vidyabharati Scheme of the Ministry of External Affairs, Government of India under which it is enrolling learners from 21 African countries and Afghanistan. In July 2024 382 learners from Afghanistan have been enrolled. The total number of learners enrolled under the Scheme is 4080.









- The University has launched 43 new programmes (including FYUP programmes) in January and July 2024.
- The January 2025 admission and re-registration cycle has commenced from 12th December 2024. The admission portal of the University has been connected with UGC through an API for implementing the DEB ID in the admission process. In the last 5 days, more than 23000 prospective learners have registered on the admission portal and more than 2000 have submitted their application along with their DEB ID.
- The average percentage of marks of the learners (July 2024) in the qualifying examination was 64.68%. More than 14500 learners have scored 90% and above in the qualifying examination.
- The convention centre and EMPC has been upgraded with the help of HEFA loan received from MOE, GOI and the Smart Classrooms has been set up in the Head quarters along with upgradation of the meeting rooms in the VCO and Radha Krishna Block
- The 11<sup>th</sup> Overseas Coordinators Consortium Meet of Indira Gandhi National Open University took place on September 23-24, at IGNOU Headquartes for strengthenining partnership with Oveseas study centres and exchange of ideas.
- The 3<sup>rd</sup> batch of three months Basic Awareness course in Hindi for foreign national was conducted in collaboration wit Indian council for Cultural Relations (ICSSR), and Central Hindi Directorate (CHD) during 21<sup>st</sup> August, 2024 to 06<sup>th</sup> November, 2024 with registration from 42 countries.
- The University has entered into a strategic partnership with Kenya Open University.
- The University has been approved to set up the UGC-Malaviya Mission Teacher Training Centre (MMTTC).

The Chairperson apprised the board that the University has been awarded first rank in NIRF ranking under the category of Open and Distance Learning.

The Chairperson then welcomed the external members for their comments. All the members appreciated the efforts made by the University. The Chairperson then invited the Member Secretary to start the proceedings.

The Member Secretary informed that the last Planning Board meeting was conducted on 08<sup>th</sup> September 2022. Since then, seven meetings of Academic Programme Committee (APC) a Standing Committee of the Planning Board were convened. She also breifed the new initiatives taken by the university on the recommendations of the Planning Board.

NCIDE has also nurtured hundreds of IGNOU students and alumni in their journey from idea to startup who are at various Technology Readiness Levels through various student empowerment programmes. Many students of IGNOU are in the process of setting up their Startups and require IGNOU to provide them incubation facilities. The NCIDE has also put in place the policy for I&E. It has also set up a Patent Facilitation Unit for IPR Protection. IGNOU has conducted 542 activities and programmes in the field of Innovation, Entrepreneurship and IPR. More than 250 ideas have been generated by the students and faculty, and more than 75 innovations/prototypes have been developed by the students and faculty. During the period April to November 2024, MMTTC IGNOU has completed 16 programmes and certified 1281 participants from various HIEs.
