Prof. Surabhi Banerjee, Former Vice-Chancellor, NSOU, Kolkata attended the meeting as a Special Invitee. Prof. C.B.Sharma attended the meeting on behalf of Prof. M.L.Koul, Director, School of Education.

Prof. Basir Ahmad Khan, Pro-Vice Chancellor, Dr. Latha Pillai, Pro-Vice Chancellor, Prof. Shafiqa Parveen, Prof. V.M.Shah, Prof. Anjila Gupta, and Prof. S.K.Panda, could not attend the meeting. Sh. K.D.Sharma, Assistant Registrar, Academic Coordination Division was present to assist the Member-Secretary.

At the outset, the Chairman welcomed the members to the meeting. He apprised the Research Council that Prof. Surabhi Banerjee has taken over the charge as Vice-Chancellor, Gour Banga University, West Bengal. The Research Council congratulated Prof. Banejee for taking over the new assignment. Consequent upon her demitting the office of the Vice-Chancellor, NSOU, she ceases to be the member of the Research Council. The Research Council taken on record the contributions made by Prof. Surabhi Banerjee, outgoing member in the deliberations of the Council.

The Chairman then requested the Member-Secretary to present the items on agenda of the meeting.

The following items were taken up:

# ITEM NO. 1 To confirm the Minutes of the Eleventh Meeting of the Research Council held on 9<sup>th</sup> April, 2008 and note the action taken thereon.

- RC.12.1.1 It was presented that the Minutes of the 11<sup>th</sup> Meeting of the Research Council held on April 9, 2008 were circulated to the members and no comments were received. The action taken report on the Minutes was also annexed to the agenda.
- RC.12.1.2 The Research Council confirmed the Minutes of its 11<sup>th</sup> Meeting held on April 9, 2008 (**Annexure-1 without appendices**) and noted the action taken thereon.
- To consider and approve the Minutes of the Fourth Meeting of the Research Council's Standing Committee held on 9<sup>th</sup> April, 2008 and note the action taken thereon.
- RC.12.2.1 The Minutes of the 4<sup>th</sup> Meeting of the RCSC held on April 9, 2008 were circulated to the members along with the Minutes of the 11<sup>th</sup> Meeting of the Research Council. No comments have been received. A copy of the Minutes along with the action taken report was annexed to agenda.
- RC.12.2.2 The Research Council confirmed the Minutes of its 4<sup>th</sup> Meeting held on April 9, 2008 (**Annexure-2 without appendices**) and noted the action taken thereon.
- Item No.3 To consider and approve the matter relating to the award of Ph.D Degree to Ms. Nisha Peshin (Enrol. No. 024957627) in Education.
- RC. 12.3.1 It was presented that Ms. Nisha Peshin (Enrolment No. 024957627) has completed her Ph.D in Education and submitted her thesis entitled "A Comparative Study of Formal and Distance Mode of Teacher Education Programme (B.Ed) on the Development of Professional Efficiency among Secondary School Teachers". The same was examined by the Board of Examiners and recommended for the award of Ph.D in Education. The provisional certificate and notification to this effect have already been issued by the Registrar, SRED. The Degree will be conferred on her at the forthcoming Convocation of the University.
- RC. 12.3.2 The Research Council considered and approved the matter relating to the award of Ph.D Degree to Ms. Nisha Peshin (Enrol. No. 024957627) in Education.

- Item No. 4 To consider and approve the Minutes of the Committee constituted by the Vice-Chancellor for finalizing the procedure for enrolment of students in the Ph.D Programme and their follow up once after enrolment in consonance with the Ordinance of Research Degree Programme.
- RC. 12.4.1 It was presented that the Vice-Chancellor had constituted a four members Committee with Prof. Parvin Sinclair, Pro-Vice-Chancellor as Chairperson to re-look into the guidelines and procedures relating to Research Degree Programmes, and suggest the procedure for enrolment of students in the Ph.D and M.Phil Programmes and their follow up after enrolment in consonance with the Ordinance of Research Degree Programme. The Committee prepared the draft guidelines for M.Phil and Ph.D programmes separately, and circulated among the Schools/Divisions/Centres for their comments. The comments received from the Schools were considered and discussed at its meetings held on 11<sup>th</sup> and 19<sup>th</sup> June, 2008.

The guidelines for Ph.D and M.Phil programmes prepared by the committee and approved by the Vice-Chancellor were annexed to the agenda

- RC. 12.4.2 The Research Council discussed the guidelines in detail and suggested the following two modifications:
  - 1) Point no. 5 of Ph.D guidelines and point no. 3 of M.Phil guidelines, to be modified to enable the candidates to undergo the course work and dissertation work simultaneously.
  - 2) Each student shall give atleast two seminars during the whole duration of the programme before the Doctoral Committee, instead of atleast one seminar every year, as stated under point 8 of Ph.D. guidelines.
- RC. 12.4.3 The Research Council considered and approved the guidelines for M.Phil and Ph.D programmes with the above two modifications. The modified guidelines are placed at **Anneuxre-3**.
