- RC 4.2 To place the synopsis of the research proposals of the nine candidates selected for Ph.D. programme in the School of Social Sciences.
- RC.4.2.1 The Research Council at its 4<sup>th</sup> meeting held on 15.2.2003 decided that synopsis of the research proposals submitted by each candidate along with a statement of objectives and expected outcomes of the research of candidate already admitted to the Ph.D. programme in the School of Social Sciences and Education may be obtained and appended with the minutes of the meeting for perusal of the members. - Prof. Ravindra Kumar, Coordinator, Ph.D. programme in History apprised the Council of the structure of the programme. This was followed by a detailed discussion. The members observed that the structure of the programme should be in conformity with the decision taken in the 4<sup>th</sup> meeting of the Research Council and detailed syllabi of discipline based courses (16-26 credits) be worked out for approval by the Research Council. The Council observed that since the University is offering these programmes for the first time, it would be desirable that for uniformity and quality, the proposals be examined in detail by a Sub-Committee to be chaired by the PVC. The Chairman was authorized to nominate other members.

### RC 4.4 To report Integrated Research Degree Programme structure in Mathematics and Physics.

Prof. Parvin Sinclair, Coordinator, Integrated Research Degree Programme in Mathematics apprised the Council that IGNOU proposes to offer an integrated research degree programme in Mathematics and Physics in collaboration with Harishchandra Research Institute (HRI). Allahabad, which is a premier research institution in the country in mathematics and theoretical physics. The programme provides for entry and exits at Post Graduate level in keeping with the common objectives and priorities of both institutions. The programmes are being developed with the objectives of identifying talented graduates in mathematics and physics who are interested in pursuing research, nurturing their creative abilities and training them as outstanding mathematicians and physicists in selected areas. The duration of the programmes would be 5 to 8 years and students would be expected to put in work equivalent to 160 credits. Out of this, 64 to 72 credits of course work would make them eligible for the award of a Masters degree. The entry into the programme shall be through entrance test followed by a face-to-face interview to ascertain their ability to undertake high quality research.

The Programme Design and Detailed Programme Reports of the Integrated Doctoral Programme in Mathematics (IDPM) and Integrated Doctoral Programme in Physics (IDPP) were approved by the School Board of School of Sciences and later by the Academic Council of the University. The Academic Council recommended that the proposal may also be placed before the Research Council of the University.

Prof. Jain also apprised the Council that somewhat similar Ph.D. programmes for in-service professionals have already been launched in UK. Australia and New Zealand also are in the process of starting such programmes. However, in our country, this is the first initiative and we need to move quickly to establish our lead position in this part of the World. He apprised the Council of the salient features of the programme its structure, objectives, methodology to be followed etc.
